SUPPLEMENTAL APPROPRIATION – FUND INTERNSHIP IN THE CITY ATTORNEY'S OFFICE

Consideration on first reading of an ordinance enacting a supplemental budget and appropriation to the 2012 City of Loveland budget to fund an internship in the City Attorney's Office

This item is a legislative action to consider an ordinance on first reading vacating a portion of sight distance easement on Lots 1 and 2, Block 17 of the Alford Lakes First

Subdivision. The subject property is generally located east of N. Taft Avenue on the southeast corner of Brandywine Drive and Coral Burst Circle. The vacation is being requested because two existing single family homes slightly encroach into the easement.

CONSTRUCTION CONTRACT AWARD

Consideration of a motion to award a construction contract for the 29th Street Waterline Replacement and Concrete Repairs project to Coulson Excavating Company, Inc.
