Instructions for Arbor Day Planting Wednesday, April 18, 2:00 pm Recreational Trail on the East side of Hwy 287

<u>Parking:</u> Fairgrounds Park will be the closest. So, parking options are at Fairgrounds Park, near the ball fields off of Old Fairgrounds Drive (behind Sonic, Metric Motors). The closer option is in the office park on SE 8th St. The Trail runs along the E. side of the office park, so if volunteers enter along there, driving south, they can park at the south end where the Trail runs on the E. side of the junkyard/"auto salvage operation."

<u>Please bring:</u> gloves, heavy footwear (NO SANDALS!!!) water, and a round shovel.

Note: There is no close restroom, unfortunately.
