CALL TO ORDER

Chair Elliott called the meeting to order at 6:10 pm.

APPROVAL OF JUNE 28TH MEETING MINUTES

Commissioner Paulson made a motion to approve the August 23rd meeting minutes. Vice Chair Greene seconded the motion, which passed unanimously.

CITY COUNCIL LIAISON UPDATE

Councilor Trenary stated that the City Council is going through the Annual Budget Process and working on the renewal of the Capital Expansion Fee Program. They are researching oil and gas regulations for items that have been presented to them. They have a vacant council seat that will be filled in the upcoming election in November.

Vice Chair Greene asked about a possible increase in grant funds since it has been so long since there has been one. Councilor Trenary encouraged the commissioners to talk to the two City Councilors in their ward and the mayor. It was decided that a sub-committee would get together and work on the next steps. The sub-committee members will be Commissioners Street and Bettenhausen, Vice Chair Greene, and Chair Elliott.

COMMUNITY PARTNERSHIP OFFICE LIAISON UPDATE

Staff Liaison Hade informed the commission of changes happening in local agencies:

Homeward 2020's Executive Director, Bryce Hach, will be leaving his position at the end of this year. Neighbor to Neighbor's newly appointed Executive Director has left after only a few months in the position.

SAVA's director has stepped down.

The Loveland Homeless Connect event is November 2nd at Truscott Elementary School, volunteers are needed. Volunteers will be navigators for homeless and those at risk of homelessness in filling out the intake form and maneuvering through all the Loveland services that are available. Staff handed out volunteer forms.

FINAL REPORT SUMMARY - ADDITIONAL INFORMATION REGARDING AGENCY OUTCOMES

Staff Liaison Hade went over a spreadsheet with percentages for the outcomes to show how agencies performed and several agencies showed very significant under performance for what they said they would be able to do with the grant funds. The commissioners discussed and determined that staff should follow-up with the agencies that under delivered to find out why and report back to the commission.

SITE VISIT ASSIGNMENTS AND REPORT FORM

Staff handed out the site visit sheet with agencies that need to be visited this year. Commissioners picked the agencies they wanted to visit (attached). Commissioners discussed if there should be a standardized site visit report form or not. It was decided that each commissioner could do their report however they preferred, just include at the top basic information about the name of the agency, who was interviewed, who is doing the report and the date of the report.

FINALIZE CHANGES TO THE 2013 GRANT GUIDE

Staff handed out changes agreed on at the August meeting and the commissioners discussed the scoring questions weighting. Changes were made to the weights (attached), Vice Chair Greene made a motion to accept the changes which was seconded by Commissioner Street and passed unanimously.
