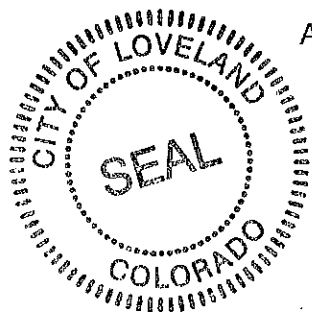
4. OLD BUSINESS/NEW BUSINESS

The next regularly scheduled Local Licensing Authority Meeting will be **February 21, 2013 at 8:30 AM** in the City Council Chambers.


Having no further business to come before the Authority, the meeting was adjourned at 8:27 A.M.
