Gary White appeared to address the Authority and answer questions. There were no concerns from the City or the Police Department. The Authority approved the license renewal. The application will be mailed to the Department of Revenue for issuance of the license.

The Licensee was not present when the renewals were addressed; However, Richard Lucio appeared at the end of the meeting and came forward to address the Authority and answer questions. There were no concerns from the City or the Police Department. Mr. Lucio asked the Authority about the process for obtaining stricter consequences upon the violating employee for a liquor offense. Mr. Lucio was directed to contact the State legislature. The Authority approved the license renewal. The application will be mailed to the Department of Revenue for issuance of the license.

SPECIAL EVENTS PERMITS

a. Project Self Sufficiency
 Chapungu Sculpture Park at Centerra (6105 Sky Pond Drive)

The applicant applied for the "Strides for Strength 5K and Fun Run" on April 27, 2013 from 8 a.m. to 1 p.m. Kathy Miner and Ingrid Bush appeared to address the Authority and answer questions. The Authority informed the applicants that the monitors at the event should not be consuming alcohol while working. There were no concerns from the City or the Police Department. The Authority approved the Special Event Permit.

b. Food Bank for Larimer County 2600 North Lincoln Avenue

The applicant applied for the "1st Annual Front Range Rally" on May 18, 2013 from 3 p.m to 7 p.m. Amy Pezzani and Russell Fruits appeared to address the Authority and answer questions. The Authority informed the applicants that the monitors at the event should not be consuming alcohol while working. The applicant was instructed to notify Sgt. Mines when a

security company is hired for the event. There were no concerns from the City or the Police Department. The Authority approved the Special Event Permit.

MODIFICATION OF PREMISES

a. Generations Bar LLC d/b/a Generations Wine & Martini Bar 127 West 4th Street

The applicant has submitted a modification of premises application to change the patio area of the licensed premises. The premises was posted with a sign advertising the public meeting on the application. The Authority read the procedures for the hearing. Erin Borsdorf appeared to address the Authority and answer questions. There were no other parties in interest appearing. Ms. Borsdorf explained that the patio area on the north side of the building was removed and the patio area decreased to allow for a permanent patio. A security camera, two windows and the servers will monitor the alcohol service on the patio. There were no concerns from the City or the Police Department. The modification of the premises was approved by the Authority and the application will be sent to the Department of Revenue for State approval.

4. SHOW CAUSE HEARING

The purpose of this hearing is to consider the suspension or revocation of said license for alleged violations by the Licensee; or by any of the agents, servants, or employees of said Licensee, of the provisions of the Colorado Liquor Code, or of any of the rules or regulations adopted pursuant thereto.

 b. Office Lounge Inc d/b/a Office Lounge Bar & Grill 1710 W Eisenhower Blvd

Caroline Gill appeared to address the Authority and answer questions. The Authority read the procedures for the hearing. Ms. Ablao read the proposed stipulation whereby the Licensee would admit the violation of serving a visibly intoxicated person and a 15 day suspension of the Tavern License would be imposed. The recommended penalty is for 5 days of the suspension to be served as an active suspension and 10 days held in abeyance for one year from the date of approval by the Authority, provided that during said one year period there are no violations of the terms and provided that there are no further violations of the Colorado Liguor Code or the Colorado Code of Regulations by the Licensee at the licensed premises. The Licensee is eligible for a fine in lieu of suspension. The Authority accepted the Licensee's admission of the violation and waiver of the right to counsel and a hearing. Ms. Ablao reviewed the establishment's records to determine a fine of \$1016 in lieu of serving the 5 days of active suspension. Ms. Gill requested the Authority's consideration of reducing the days held in abeyance due to the establishment's good rapport and cooperation with the Police Department and termination of the offending employee. Ms. Ablao stated that there were no aggravated circumstances surrounding the violation; however, the recommended penalty is being requested by the City as the standard of fair treatment across the City for violating establishments. The Authority commended the establishment's firing of the employee and reduced the days in abeyance to 8 days. The fine must be paid by cash or cashier's check at the City Clerk's Office no later than 5 p.m. on May 3, 2013. Copies of the Order will be mailed to the Licensee. An appearance at the next renewal of the license will be required by the Licensee.

The Authority related information on SB 59-2013 in the legislature regarding amending persons prohibited from holding a liquor license. SB 43-2013 cleans up language in the statute for removal of alcohol from the premises and addresses common consumption areas and the effect on Hotel and Restaurant licensees.
