Kimberly Akley-Charron appeared to address the Authority and answer questions. There were no questions from the City and no other parties in interest appearing. The Authority noted that the monitors of the event should not consume alcohol beverages while working. The Special Event Permit was approved.

TRANSFER OF OWNERSHIP

a. AJO, Inc. d/b/a Casa Real Mexican Grill & Cantina 243 East 29th Street

An application for transfer of ownership was filed by AJO, Inc. from Casa Grande of Loveland d/b/a Padres Mexican Restaurant. A temporary transfer permit was granted on January 6, 2014. This matter was continued from the February meeting. Alfonso Barajas appeared to address the Authority and answer questions. Mr. Barajas has been working with the Building Department on a permit to remodel the restaurant and the new diagram was submitted. Ms. Ablao questioned Mr. Barajas about final approval of the permit by the City and criminal history disclosure by Jesse Adame. Mr. Adame came forward to explain the incident and subsequent dismissal of the charge. There were no other concerns by the City. The Authority approved the Transfer of Ownership.

6. OLD BUSINESS/NEW BUSINESS

The Authority reconvened the discussion from last month of fees for Special Event Permits. Ms. Ablao recommended that the \$100 permit fee be charged per event, stating that if there is more than one event listed on an application, \$100 would be collected for each event. The Authority clarified that if the days on the application are not consecutive, then there would be multiple events incurring \$100 per event. The Authority requested that all previous Special Event Permitees be informed of the clarification of the \$100 permit fee charged per event.

Ms. Ablao announced the upcoming Colorado Municipal League meeting on June 19, 2014. To accommodate the attendance by all the City Attorney's staff she requested and the Authority changed the June meeting date to June 26, 2014, one week later than normal.

Ms. Ablao introduced Lt. Kurt Willson from Loveland Fire Rescue Authority. Lt. Willson will be doing inspections of liquor establishments. The Liquor Enforcement Officers are attending the Metro Area Liquor Inspection (MALI) class on Enforcement today. Ms. Ablao reported that the information they received from a previous class was excellent and they are hoping MALI will continue providing these training opportunities.

The next regularly scheduled Local Licensing Authority Meeting will be **April 17, 2014 at 8:30 AM** in the City Council Chambers.

Having no further business to come before the Authority, the meeting was adjourned at 10:46 A.M.
