**1. REGULAR AGENDA - (Appearance required)**

Municipal Judge, William E. Starks called the Special Meeting of the Local Licensing Authority to order at 3:00 PM on the above date. Also present were: Assistant City Attorney, Tree Ablao; and Secretary, Jeannie Weaver.

**a. MODIFICATION OF PREMISES**

Ovations Food Services LP d/b/a  
Ovations Hot Dog Cart  
5290 Arena Circle

Phil Hossler appeared to address the Authority and answer questions. The Authority scheduled this matter for a public meeting and a public hearing is not required. The Authority related that the request was necessary due to the State's decision to withdraw the permanent optional premises use of the parking lot areas at The Ranch. The request seeks to allow events on June 6, 2014 to September 6, 2014. The Authority advised the Licensee to keep the premises posted during the entire time period to inform the public and to keep the law from inadvertently being broken if someone brings alcohol onto the premises. Ms. Ablao stated that the City and the Police Department had no concerns. There were no parties in interest appearing. The Authority found the request in order and the temporary modification of the premises was granted.

**b. MANAGER REGISTRATION**

Heather Sutherland appeared to address the Authority and answer questions. The Authority expressed concern with the written explanation provided by Ms. Sutherland and asked for further clarification for the record. Ms. Sutherland explained the incident that resulted in her incarceration. At the time she thought the sentence was deferred and completed the application based on that understanding. Ms. Ablao was satisfied with the explanation and had no other concerns about the manager registration. The Authority approved the application and advised Ms. Sutherland to contact the reporting court for her records.

**2. SHOW CAUSE HEARINGS – posting and publication not required**

The purpose of this hearing is to consider the suspension or revocation of said license for alleged violations by the Licensee; or by any of the agents, servants, or employees of


said Licensee, of the provisions of the Colorado Liquor Code, or any of the rules or regulations adopted pursuant thereto.

- a. Cyclone Enterprises Corp. d/b/a Scotty O'Brian's  
237 East 4<sup>th</sup> Street

Brian Miller appeared to address the Authority and answer questions. The Authority reviewed the proposed stipulation accepted at the meeting on May 15, 2014. After Ms. Ablao has had a chance to review the records for Scotty O'Brian's and determined the fine amount of \$504. Mr. Miller admitted the violation and waived the right to a hearing. The Authority accepted the admission, finding it is voluntary and not the result of any undue coercion. The penalty was imposed as written in the stipulation. The Authority set the due date for payment of the fine in cash, cashier's check or certified funds by 5 p.m. on May 30, 2014 at the City Clerk's Office. Mr. Miller will send several employees to the upcoming alcohol server training class on June 2, 2014. The Licensee will be required to appear at the meeting for the next renewal of the license.


