
Newspaper Takeover

Remodel of the Fire & Administration Building to Create Development Center

SUMMARY:

This informational presentation summarizes efforts on the conceptual design for the remodel of the Fire & Administration Building to create a Development Center.

BACKGROUND:

Completion of the Service Center Expansion project in late 2014 allowed for the Public Works employees previously located at the Fire & Administration Building (FAB) to join the now more centralized Public Works Department. Not only did moving the Public Works staff from the FAB free up space, it also coincided with renewal needs for the FAB. Thus, an opportunity now exists to maximize the remodel so that it not only improves the working environment of the long-term building occupants, but better meets the needs of the City's Development Services customers.

The potential to create a Development Center at the FAB allowing customers to interact with development review staff at one location, was included in the Facilities Master Planning process completed in 2014. City Council prioritized this project at its Council Workshop in early 2014.

City staff from each department formed project committees in 2014 to research and develop recommendations for the creation of a Development Center. These committees considered other development centers, staffing and operational needs, and facility space needs for the center. Surveys were distributed and focus groups were created with local development and building consultants. Programming for space needs was completed in October 2014. Following the programming efforts, the project team selected Belford Watkins Group (BWG) to develop a conceptual design for the remodel.

BWG explored multiple options and worked with City staff to evaluate, define, and estimate the cost impacts and space requirements. Options were developed to meet the needs for the

Development Center along with the Loveland Fire and Rescue Authority staff currently located in the facility. Other options were developed to accommodate growth for longer-term needs.

Although the FAB remodel is not included in the current 10-year capital plan, it is a priority for the City because it will create a Development Center at one City facility, house public meetings such as neighborhood meetings and small commission meetings, and create a vibrant, welcoming environment for customers and staff. The project team desires to move forward with final design and bid the construction for the remodel project in 2015. Construction and occupancy is anticipated to be completed in early 2016.

The FAB was originally constructed in 1966 providing multiple services to the community. The Fire and Police Departments remained at the facility in 1988 when City Hall relocated to the refurbished school house. The FAB underwent renovation in 2003 after the Police Department relocated to the Police & Courts Building in 2002. The project budget for the 2003 renewal and small expansion was \$1.5 million. The currently proposed, relatively inexpensive, re-purposing of the facility not only extends its useful life, but also better positions the City to meet customer service needs now and into the foreseeable future.







SUMMARY:

This is an administrative action. Since July of 2014, the City of Loveland, Town of Windsor and Larimer County have been developing an application to the State of Colorado Economic Development Commission for the award of a Regional Tourism Act Grant. This session will update the public on the status of the application and potential projects. The application is due February 17, 2015.

BACKGROUND:

In July of 2014, the City of Loveland, Town of Windsor and Larimer County began an effort to compete for a State of Colorado Regional Tourism Act (RTA) award. The Loveland City Council has discussed a Go NoCo Regional Tourism Application in two previous study sessions and held an executive session on January 13, 2015.

The purpose of the Regional Tourism Act Program of the State of Colorado Economic Development Commission is to assist with the development of destination tourism attractions to bring new out-of-state visitors to the State of Colorado. The program offers the use of net new state sales tax generated in a regional tourism zone to the development of the projects. On October 13, 2014, Go NoCo submitted a required regional tourism zone (RTZ) designation preapplication. This submission was used by the State to determine a base line natural growth rate of 4.5% which would occur in the RTZ even in the absence of any destination tourism projects.

The submission of an application does not guarantee an award. The State Economic Development Commission is not obligated to award any grants not is it obligated to award two, which is the number of remaining possible awards per State Statute. The State of Colorado has extended two deadlines to assist communities with their project submissions. Local Governments may add area to the regional tourism zone and submit missing information before March 11, 2015.

Applicants may reduce the size of the RTZ, add a new project element, subtract project elements from the existing application and change programming within an existing project before August 28, 2015.

The Town of Estes Park will consider support for a Regional Tourism Zone expansion and the possible addition of a destination project at a January 27, 2015 work session. An Estes Park project cannot be submitted to the State without the formal approval from the Town Board. This action may take place on February 10, 2015.
