Mr. Hamblin explained that the restaurant has been running smoothly without violations for three years with the same staff whose capabilities are to act as Assistant Managers and make decisions unless an owner is needed. He stated that Marlene wanted to remain on the license as part owner and is available to make decisions anytime and handle the accounting duties.
