Ms. Pacheco stated they have cured the issues at the store by requiring all new hires to attend the City's alcohol server training and incorporated the required training as an in-store policy. There were no other concerns from the City or the Police Department. The Authority was satisfied and commended the manager for instituting the policy and approved the renewal.

SPECIAL EVENT PERMITS

a. Loveland Museum/Gallery 503 N. Lincoln Avenue

APPROVED

The application contains six events to be held at the Museum on April 10, 2015 from 6-9 p.m.; July 10, 2015 from 5-9 p.m.; August 14, 2015 from 6-9 p.m.; September 11, 2015 from 6-9 p.m.; September 24, 2015 from 6-10 p.m.; and October 24, 2015 from 5-10 p.m. The proper posting was completed on March 12, 2015 and no protests were filed. All other requirements were met and the Authority approved the Special Event Permits.

4. SHOW CAUSE HEARINGS

The purpose of this hearing is to consider the suspension or revocation of said license for alleged violations by the Licensee: or by any of the agents, servants, or employees of said Licensee, of the provisions of the Colorado Liquor Code, or any of the rules or regulations adopted pursuant thereto.

a. Consignment Barn 66 dba Fifth Street Bar Loveland 111 East 5th Street

Ms. Ablao came forward to address the Authority and ask for vacation of the show cause hearing due to the surrender of the Liquor License by the owner and approval of the State Liquor Authority. The Authority approved the dismissal of the show cause hearing.

 Dondel-Pigg Properties Inc. dba Corkscrew Wine and Liquor 247-251 West 64th Street
 Retail Store License Renewal and Show Cause April 19, 2015 to April 19, 2016

Scott Pigg appeared to address the Authority and answer questions. Ms. Ablao came forward to request a continuance of the renewal and show cause hearing for time to negotiate with the Licensee. Mr. Pigg agreed with the request and the Authority continued the matter to the meeting on April 16, 2015.

c. Walnut Brewery Inc. dba Rock Bottom Restaurant & Brewery 6025 Sky Pond Drive

Attorney Loren Brown appeared with General Manager Todd Jones to address the Authority and answer questions. Ms. Ablao came forward to present a stipulation whereby the Licensee would admit the violation and serve a 10 day suspension. Five days of the suspension would be held in abeyance for one year conditioned on no other violations occurring on the licensed premises and no other violations of the Colorado Liquor Code or Colorado Code of Regulations and employee training attendance. The remaining five days would be served by payment of a fine in lieu of the suspension in the amount of \$3,290. Ms. Ablao stated that usually a first offense penalty is a 15 day suspension but in this case, the Licensee's response was exemplary and warranted a lesser penalty. The Licensee admitted the violation and waived

the right to a hearing. The Authority reviewed and approved the stipulation finding it a fair and voluntary admission by the Licensee and not the result of any undue coercion. A cashier's check for payment of the \$3,290 fine was submitted to the Secretary; therefore, the dates for the five day suspension did not need to be completed on the Order. The class registration form will be mailed to the Licensee.

5. PUBLIC HEARINGS

NEW LICENSE

a. Miray Corporation dba Bai Tong Thai Cuisine
 1120 North Lincoln Avenue

The application was filed for a new Hotel and Restaurant license. The premises was posted with a sign advertising the Public Hearing and a notice was published in the Reporter Herald as the law requires. Ekawat Sunti appeared to address the Authority and answer questions. The Authority read the procedures into the record for the Public Hearing. The Secretary's file was admitted into the record. There were no other parties in interest appearing. Mr. Sunti was sworn in to testify. Mr. Junglas questioned the applicant about the Fire Code violations and occupancy issues related to the building. Mr. Sunti explained that he is working on completing the Fire Code issues and stated that the occupancy set by the health department was 99. Mr. Junglas recommended that the applicant provide proof of curing the deficiencies from the Fire Department and contact the Building Division to review the occupancy of the building for the Liquor Code requirement to not pose a safety risk to the neighborhood. The Authority questioned Mr. Sunti as to the desires of the adult inhabitants of the neighborhood and the petitions that were submitted, which appeared to have the same handwriting on several pages. Mr. Sunti testified that he obtained the signatures himself and could not explain the appearance of the same handwriting on the pages but was unable to submit them by the deadline. There were no other parties in interest appearing. The Authority closed the Public Hearing and made the following findings: The application is in order, the background investigation is complete and the notice requirements were met. Concerns of the Authority remaining were the appearance of the petition signatures being the same and the Fire and Building Division inspection issues raised by the City. There were no other concerns from the City or Police Department. The Authority approved the application conditionally upon: 1) Receiving a new set of petitions containing at least 100 individually signed and verified signatures; 2) Satisfying all of the issues with the Fire Department; 3) Satisfying the Building Division and City with respect to the occupancy issue; and 4) passing the Police Department's final premises inspection. The Authority continued the Public Hearing to the April 16, 2015 meeting unless the applicant completes all of the conditions and submits proof to the Authority prior to that date.
