
# Conserve electricity, earn cash

For a limited time, Loveland Water and Power is making it even more cost-effective to renovate your commercial or industrial space with energy efficient projects.

Through Platte River Power Authority, Loveland commercial and industrial customers have benefited from incentives for efficient lighting, air conditioning, motors, drive systems and process equipment. Participants not only receive rebates on projects, but the installation of efficient equipment saves them money on energy bills well into the future.

Loveland Water and Power is upping the ante. We are adding an additional \$150 per kilowatt to PRPA's \$350, giving participants \$500 back on every kilowatt of average demand reduction, as measured

or estimated for the summer peak period from 3-7 p.m., June through August. Incentive caps may apply.

# What's ahead for 2006

#### Parks & Recreation

The new Loveland Sports Park will open to the public this summer. The 55-acres of this new park will offer two in-line skate rinks, a skate park, playground, picnic shelters, basketball court, sand volleyball, a championship synthetic turf field, and seven multi-purpose athletic fields.

More ball fields are planned at Barnes Park Softball Complex with construction commencing fall 2006 - Winter 2007. In addition, staff will continue to work with City Council on funding and the project scope for redevelopment of the old fairgrounds property.

After the pool closes at the end of the summer, the Winona Pool Bath House will be renovated and updated to provide improved locker rooms. The renovation will also address environmental issues associated with the pool's chemical storage.

City staff will continue to work with City Council on funding and the project scope for expansion of the Chilson Recreation Center and/or development of a new recreation center for Loveland

#### Commercial Customers

In 2006, the Water and Power
Department will be finalizing a program
to support mid-market commercial
customers throughout the City. The
program will be built around needs
identified through in-person interviews
with a random selection of commercial
customers throughout the City. The
main focus will be on water-and-powerrelated issues, in coordination with other
City departments to facilitate projects
as needed.

#### Stormwater

In order to eliminate existing flooding problems in the area, construction of the Wernimont Regional Detention Pond will begin this spring. The project goal is to construct a 60 acre-foot regional detention pond immediately southwest of Valency Drive.

Final engineering design begins in 2006 to solve flooding problems in the East 29th Street & Monroe Avenue area. This stormwater improvement project includes construction of a new storm sewer system from the existing Devers Detention Pond near 29th and Monroe to the existing Eagleview Park detention pond. The project is scheduled for construction in 2008.

Final engineering design of new inlets and storm sewer improvements are currently being finalized to more efficiently move stormwater from Dotsero Avenue into the Loch Lon Park detention pond. This summer, a new storm sewer system will be constructed from the detention pond, north in

Dotsero Avenue, to the existing Carlisle Drive storm sewer system.

This winter, a stormwater detention pond will be completed at the Police and Courts Building. This work will support the existing facility, as well as any future buildings on the campus.

#### Airport

More than \$4 million from federal grants will be spent in 2006 for improvements to the Fort Collins/Loveland Airport. Work will begin for reconstruction of the commercial ramp area used by airliners and large charter aircraft, and a taxiway will be reconstructed including its lighting system. Revenue generated from passenger fees will pay for replacement of the airfield's lighting control system plus runway fog sealing and repainting of runway markings.

Leasing of airport ground for the construction of additional private aircraft hangars is likely. The new hangars will help meet demand by businesses and aircraft owners while providing additional revenue to the airport.

#### **Current Planning**

Current Planning and members of the Development Review Team will continue to evaluate and make improvements to the development review process. This effort will include monthly evaluations plus surveying internal and external customers regarding experiences with the review process and the newly created Development Review Center.

Architectural standards for commercial and industrial building have been adopted and are being implemented. An evaluation of these standards by Current Planning will take place late in 2006, after the standards have been in use for a year. Current Planning also anticipates working with the Water/Wastewater divisions on the use of low-water landscape plants and defining what steps can be taken to encourage the use of these plants to help conserve water.

#### Library

The library is placing an expanded emphasis on services for teens and is recruiting members for a teen advisory board that will help plan programs and services.

#### **Open Space**

During 2006, the City will actively pursue acquisition of additional open space. The 2006 open space budget includes \$1.5 million, which is the City's share of the ongoing .25 cent Larimer County open space sales tax. Open space is acquired using a "willing seller-willing buyer" philosophy.

#### Water

The City's Water Treatment Plant will receive \$2.3 million in improvements to meet service demand and comply with EPA/State mandated water quality and treatment regulations. The 2006 efforts are part of a total \$4.3 million in improvements planned during the upcoming five years.

Funding has been approved and construction will begin for a 2 million gallon elevated water storage tank and transmission lines. The tank will be located about one mile east of the intersection of I-25 and Crossroads Boulevard along the south side of Crossroads Boulevard and will support the development demands of the east side of Loveland.

#### Wastewater

\$1.3 million in improvements and expansion of the Wastewater Treatment Plant are planned for 2006, part of a total of \$11.2 million during the next five years. The improvements will help keep pace with anticipated growth as well as EPA and State of Colorado mandated regulations. Funding has also been approved for continued odor control projects.

New, rehabilitated and replacement water and wastewater pipes and other infrastructure construction will occur at various locations around Loveland during 2006. The work is required due to the age and condition of existing infrastructure in some parts of the city's water and wastewater service territories.

#### **Electric**

A new underground distribution feeder circuit will be constructed between two eastside electric substations. The circuit will transfer power loads between the two substations and provide a contingency electrical source if a problem occurs at either substation. A similar project will



begin in 2006 between two westside substations. This project is expected to be completed in 2007.

An underground distribution circuit will be installed along Rocky Mountain Avenue. This circuit will provide an alternative electric source for the Medical Center of the Rockies now under construction.

In order to save money during electrical load peaks, a new generator will be installed at the Water Treatment Plant and a second generator installed at the Wastewater Treatment Plant .

Smaller electric projects are planned for 2006. These include installing additional roadway lights, relocating some facilities while some Public Works projects are under construction and replacing some older electrical switchgear.

#### **New Streets**

This year, the City will spend more than \$7 million on new road construction, design and traffic control. The two largest projects involve right-of-way acquisition for Centerra Parkway and improvements to the intersection at Hwy. 287 and 57th Street. Funding for these and similar projects comes primarily from fees paid by developers of the adjacent projects.

The intersections of 287/19th SE and Madison/1st will get new traffic signals and/or turn lanes. In 2006, engineering design for improvements to 37th Street and Madison Avenue are also planned. Another significant project involves the extension of N. Boise Avenue to Larimer County Road 11C.

#### **Existing Streets**

In addition to the \$7 million budgeted for new streets, another \$2.8 million will be spent on keeping our existing roadways in good condition. The Street Rehabilitation Program will repair and resurface about 30 miles of Loveland's streets ranging from arterials to residential.

#### **Police**

The employee section of the now 5-year-old police building parking lot will be enlarged this year. Use by additional employees, volunteers and personnel from other enforcement agencies during multi-jurisdictional operations has brought about the \$35,000 expansion need.

#### **Cultural Services**

Loveland's Visual Arts Commission has commissioned large, outdoor sculptures by three widely known local artists.

Linda Prokop will create "The Gathering," made up of five abstract figures to be

# New bus routes to begin March 1

Loveland's buses will begin new routes March 1, aimed at providing easier and faster service throughout the City. The routing has been revised to better serve riders, particularly to provide more efficient transportation to popular destinations for employees and customers alike.

The current Jitterbus and Tango looping routes will be transformed into a cross-shaped "express" route and square-shaped "collector" route with four transfer points instead of the current single transfer point. For many riders, the changes will significantly reduce time between origin and destination. The new routes will be called simply Blue and Green.

The preliminary route plans have been fine tuned since they were originally proposed last fall. The changes were made in response to patrons' suggestions and survey results.

For the most part, the Blue express route will run on only two streets; in both directions on Hwy. 34 between Taft and the new Promenade Shops, and in both directions on Hwy. 287 between 8th Street and the Orchards Center. The Green route will run clockwise connecting Boise, 14th SW, Wilson and 29th. Passengers may transfer between buses at any of the four locations where the routes intersect.

The Foxtrot bus will continue to connect Loveland and Fort Collins, with the pickup/dropoff point relocated to the

Orchards Center for the convenience of riders and to keep the bus running on schedule.


The new routing is the first overhaul of the fixed route system since it began in 1999. The redesign will make the service more efficient for the riders and serve new high-demand areas such as Centerra. It will offer more stops in areas requested by patrons and eliminate some stops with very low ridership.

Major employment areas will be served including HP, Agilent, WaterPik, McKee, Wal-Mart, Lowes, the new Skyline medical center, grocery store shopping centers and the malls. Service will continue to all four high schools, where students make up 44 percent of the system's total ridership. The Medical Center of the Rockies will be added to the route when it opens.

On average, bus stops will be located about a quarter-mile apart along each route. The Monday-Friday service will continue from 6:38 a.m. to 6:38 p.m. Saturday service will change to 10 a.m. to 10 p.m.

Several changes in fares, both for the fixed route and Paratransit services, will also become effective March 1.
