CALL TO ORDER

Chair McCrory called the meeting to order at 5:20 pm.

PUBLIC COMMENT

APPROVAL OF MINUTES

Commissioner Rice made a motion to approve minutes from 3-12-2015, 4-7-2015, 4-22-2015, and the sales tax statement from 5-11-15. Commissioner Martz-Mayfield seconded the motion. Passed unanimously.

2016 CDBG GRANT PROCESS

2015-2020 CONSOLIDATED PLAN GOALS

Review of community outreach survey results. Review of consolidated plan work so far in IDIS system.

Commissioner Rice made a motion and Commissioner Berg seconded the following as goals in the 2015-2020 Consolidated Plan:

- 1. Homeowner housing. Increase supply of affordable homeownership by 75.
- 2. Rental units constructed. Increase supply of affordable rental housing by 300.
- 3. Housing for homeless. Supportive housing for 30 homeless individuals.
- 4. Homeowner housing rehabilitated. Rehabilitate affordable housing to HQS safe & sanitary standards of 600 homes.
- 5. Rental housing rehabilitated. Rehabilitate affordable rental housing of 200 homes.
- 6. Public facility. Purchase or rehabilitate 2 public facilities for agencies serving low/moderate income individuals or families.
