The Licensee shall serve a suspension of 5 days of its 3.2% Off-Premises Retail Beer License; The 5 days shall be served as a fine of \$200 in lieu of suspension. There were no further concerns and the renewal was approved.

The application was filed for a new 3.2% On/Off-Premises Retail Beer license from the currently held 3.2% Off-Premises Retail Beer license.
