4. SHOW CAUSE HEARINGS

The Licensee appeared to address the Authority and answer questions. The Authority accepted the Stipulations for each Licensee and signed an Order for each below:

The purpose of this hearing is to consider the suspension or revocation of said license for alleged violations by the Licensee; or by any of the agents, servants, or employees of said Licensee, of the provisions of the Colorado Liquor Code, or any of the rules or regulations adopted pursuant thereto.

- a. Kylee Foods Inc. dba Nordy's Bar-B-Que & Grill
4360 St. Cloud Drive
The Licensee shall serve a suspension of 25 days of its Hotel and Restaurant License; 10 days of suspension shall be held in abeyance for one year. The remaining 15 days shall be served as a fine of \$4,800 in lieu of suspension and required alcohol server training for untrained employees.
- b. Zen Restaurant LLC dba Café De Bangkok II

1360 East Eisenhower Blvd.

The Licensee shall serve a suspension of 10 days of its Hotel and Restaurant License; 5 days of suspension shall be held in abeyance for one year. The remaining 5 days shall be served as a fine of \$200 in lieu of suspension and required alcohol server training for untrained employees.

The Licensee shall serve a suspension of 10 days of its Hotel and Restaurant License; 4 days of suspension shall be held in abeyance for one year. 
