## TRANSFER OF OWNERSHIP

## 4. SHOW CAUSE HEARINGS

The purpose of this hearing is to consider the suspension or revocation of said license for alleged violations by the Licensee; or by any of the agents, servants, or employees of said Licensee, of the provisions of the Colorado Liquor Code, or any of the rules or regulations adopted pursuant thereto.

The Licensee shall serve a suspension of 20 days of its Hotel and Restaurant License; 13 days of suspension shall be held in abeyance for one year. The remaining 7 days shall be served as a fine of \$1,075.00 in lieu of suspension and alcohol server training is required for untrained employees.
