The meeting was called to order by Chairperson Pat Kistler at 5:37 PM. A motion was made and seconded by Ed Gassman and Dennis Soucek to approve the minutes as is. Motion carried. All approved.

CHIEF TICER

- ❖ Received a lot of great feedback from the community on the Trump visit, Pence visit and Bill Clinton visit. Great participation with all agencies. Chief explained the roles of SWAT, site security to Greeley and Budweiser Event Center. We received an amount of great respect from the secret service on how these events were handled.
- ❖ Chief **THANKED** Councilor McKean for his support of the police pension plan. It was a unanimous vote by City Council to accept the proposed plan. Chief **THANKED** PCAB member John Tindall as well who is on the pension board.
- ❖ LPD is continuing to find outstanding people to come and work here at the police department.
- ❖ Chief explained that Front Range Community College will be starting up an academy in the fall of 2017.
- ❖ LPD will be sending two new recruits to the Adams County Academy beginning January 9th.
- ❖ There were 15 candidates for the sergeant process. This will be a very competitive process. We have two vacancies and will retain the list for 18 months.
- ❖ Working on a new mission statement with staff for the Loveland Police Department. Chief Ticer asked someone from PCAB to be on the committee.
- ❖ We are moving forward on the police training facility. Have met with firearms and driving instructors and will present to the City Council Study Session on January 17th possible locations. Chief Ticer is continuing to work with Chief Hutto of Fort Collins Police Services on this project as well.
- ❖ Loveland Police Department is lucky to hold a lot of trainings throughout the year and we have become known as the training department in the state.

COUNCILOR HUGH McKEAN

- ✚ Appreciated all the efforts that the Pension Board committee did on getting the police pension changed. All councilors thought it was a great proposal. Board member Tindall suggested that Chairperson Kistler write a letter to City Council thanking them for their unanimous support.
