MUNICIPAL COURT MUNICIPAL COURT 2016 YEAR END REPORT

FISCAL ADVISOR DOWNTOWN PARKING STRUCTURE FOR FOUNDRY

Alan Krcmarik, Executive Fiscal Advisor, presented this item to Council. The week after the City Council approved the Development and Redevelopment Agreement for the Foundry Project to be constructed through a public-private partnership between the City and Brinkman Partners, the City received an unsolicited lease-financing proposal from BBVA Compass Bank. The interest rate offered in the proposal was

substantially lower than the City expected. City staff reviewed the terms of the proposal with the Project Negotiation Team and determined that the proposed transaction would be advantageous to the City. To ensure competition on the interest rate, City staff contacted other banks that presented financing proposals for the City's recent request for proposal process for the Wastewater Treatment Plant Improvements. The proposed Ordinance authorizes the City to obtain lease-financing proceeds to use to construct the parking structure at the northwest corner of the intersection of Lincoln Avenue and 2nd Street and other eligible improvements. The financing proposal from BBVA offered up to \$17.1 million of financing. Due to more favorable market conditions, the amount needed for the project decreased to \$15.9 million. Of the total \$15.9 million. \$14.5 million would be used for the construction of the facility and eligible improvements. The remaining \$1.4 million will be capitalized interest for the first thirty months of the payment term. The payment schedule will be based on a 30-year payback period with a reset of interest rates at the end of the 15th year. The rate for the first fifteen years will be 3.39%. During the construction phase, the City will use existing assets as collateral for the lease. Upon completion of the parking facility, the parking structure will serve as collateral for the lease. The ordinance was adopted by City Council on first reading on January 17, 2017 by a 7-1 vote.

LOVELAND POLICE DEPARTMENT PROPOSED LOVELAND REGIONAL POLICE TRAINING CENTER WITH POSSIBLE EXECUTIVE SESSION

Bob Ticer, Loveland Police Chief and Michael Hogan, Facilities Operations Manager, provided the City Council with background on the proposed Police Regional Training Center in partnership with the City of Fort Collins, including an update on possible locations with the possibility for City Council to provide direction to the Police Department regarding the project. This item provides information to support City Council decision making regarding funding of this project. The City of Loveland budgeted \$810,000 in the 2017 Capital budget for design. The 2018 budget has a conceptual construction budget amount of \$8,315,000. Additionally, a conceptual 2018 budget of \$350,000 was developed for two (2) FTE's and an initial operational impact, which is currently being evaluated by Chief Ticer. If this project is supported and a 50/50 capital partnership is agreed upon with the City of Fort Collins the total cost for build would be approximately \$18,250,000. A split (4-4) Loveland City Council vote in December of 2015, in effect, put the project on hold.
