## 2.1 HUMAN RESOURCES MUNICIPAL JUDGE PERFORMANCE REVIEW WITH POSSIBLE EXECUTIVE SESSION

Julia Holland, Human Resources Director, presented this item to Council for the purpose of conducting the Municipal Judge's quarterly performance review, which included discussion in an executive session and direction was given to staff, as the Municipal Judge's two-year appointment term will expire on April 21, 2017.

### 2.2 BROADBAND PROJECT TEAM BROADBAND FEASIBILITY REPORT WITH POSSIBLE EXECUTIVE SESSION

Brieana Reed-Harmel, Broadband Project Manager and John Honker, President and CEO with Magellan Advisors, presented the information on the Broadband Feasibility Report intended to update City Council on Loveland's broadband initiative. The Executive Session that was recommended in order to share proprietary financial modeling information did not take place. The update included:

- An update on the broadband environment in Loveland based on public outreach
- Review of the most feasible business models
- Preliminary financial feasibility analysis for most feasible business models
- Network designs and pro forma for each business model
- Overview of City's next steps prior to construction

Once City Council recommends a business model option for Loveland's Broadband Initiative, there are future costs associated with the implementation of each business model, depending on the option chosen. The Broadband Task Force Members were invited to comment: Mindy McCloughan, Richard Toftness and Fernando Pedroza spoke in support of the Broadband Initiative. Dave Kavanagh expressed concerns regarding revenue and expenses. Mayor Pro Tem Fogle asked for Public Comment: Bruce Croissant, 1629 Jackson Ave, spoke in support; Gene Duran, 550 N Lincoln Ave, spoke in support; Larry Sarner, resident in Ward 2, spoke in opposition. Council invited John Lehman with Comcast to address Council. He spoke regarding the services that Comcast provides. Council asked staff to provide the survey questions and comments.
