4.2 ECONOMIC DEVELOPMENT, PUBLIC WORKS, FINANCE PUBLIC COMMENT SUPPLEMENTAL APPROPRIATION FOR THE FOUNDRY ROW TRAFFIC CALMING

Mike Scholl, Economic Development Manager, presented this item to Council. This supplemental appropriation request is for street infrastructure improvements related to the proposed Cleveland "Traffic Calming" and improvements to 1st Street that would improve traffic flow as required for the project. Staff is seeking \$1,343,000 for the Cleveland Avenue and Lincoln Avenue street improvements between 1st and 3rd; dovetail design of traffic calming on Cleveland Avenue between 1st and 7th; and, design and improvements to the intersection at 1st Street and Lincoln Avenue. These actions are recommended at this time because of the opportunity to realize cost savings if the work is combined with the Foundry Project. Specifically, the City will save an estimated \$100,000 on the Cleveland Road improvements based on the current work underway for utility relocations and the Brinkman Partners have agreed to contribute \$100,000 to the improvements to the intersection at 1st Street. This expense is eligible for funding through the TABOR Excess Fund. If the request is approved, the TABOR Excess Fund balance will be \$20.035.733.

Public Comment: Jackie Marsh, spoke in support of slowing traffic down. Justin Erion, spoke in support of slowing down traffic. Kim Rack, spoke in support of slowing traffic by moving down to two lanes. Clay Caldwell, spoke in opposition to narrowing the street.
