The premises was posted with a sign advertising the Public Hearing on April 20, 2017 and publication was made in the Reporter Herald as the law requires. The matter was continued to May 18, 2017, in order to provide more information for the Authority on identification for those patrons consuming alcohol.

**5. STAFF REPORT**


Officer Castellanos spoke about the Liquor Enforcement Unit and the need for 5-6 officers to be fully staffed.
