PCAB Chairperson Pat Kistler called the meeting to order at 5:40 PM. A motion was made and seconded by Dennis Soucek and Ed Gassman respectively to approve the minutes as is. Motion carried. Approved

Chief Ticer introduced Mark Gaisford, Communications Manager, and Erin Berry, Communications Specialist, who presented the program for this meeting.

COMMUNICATIONS PRESENTATION

Mark introduced Communications Specialist Erin Berry who recently won Telecommunicator of the Year award for 2016. Erin received this prestigious award for two urgent calls that came through the Communications Center. The first 9-1-1 call was where a high school student (Zach) collapsed on the football field. Erin gave compression instructions to another student while Officer Bruce Boroski retrieved the AED along with the student's coach who administered the AED just as paramedics arrived. Erin received the award in New Orleans at the Navigator's Conference. Zach and his parents attended this conference as well. Zach has recovered 100% thanks to Erin's extensive training as well as everyone else who was on scene. Erin stated she was very humbled by receiving this award. Another 9-1-1 call ... Erin was able to help a couple on their way to the hospital deliver a baby. Mom and baby were just fine when they reached the hospital.

Erin also explained briefly the trainings that all communications specialists need to complete before they can begin solo on the computers.

Mark Gaisford gave some brief information on the Communications Center.

- ❖ There are usually 3 dispatchers in the COMM Center between the hours of 11:00 AM to 1:00 AM. There are no less than 2 dispatchers in the center per shift.
- ❖ Received the 4th reaccreditation for Communications.
- ❖ Fifty-eight (58) lives saved since 1990.
- ❖ Communications (667-2151) has deployed a new call tree, aka auto attendant. This has served the department well and has reduced generic calls that have come into dispatch by re-routing them to the correct extension.
- ❖ Mark explained that if there is a massive power outage or another extreme catastrophe in Loveland and it affects the COMM center, all calls are then handled through the Larimer County Sheriff's Office. LCSO is on the same CAD system as Loveland and staff can be interchangeable if necessary.
- ❖ Mark stated that only about 2% of the population are able to handle the job of dispatcher.
- ❖ Mark stated that Loveland, Fort Collins, LCSO and Estes Park will all be with TriTech in the near future which will make it more convenient for all these agencies when it comes to communicating.
- ❖ Officers will soon be receiving new software called "Inform Me" which gives officers the ability to get out of their cars and walk around. This new software will update the

officers' status, run queries, run mappings, records checks and criminal history. This new software will be a great asset to the police department.

CHIEF'S UPDATE

- **THANKED** Bev and Kathy for attending the K-9 graduation. CSO Tebbe and K-9 Jojo and Officer McAuley and K-9 Pako.
- Met with Fort Collins Interim Police Chief Jones who is very supportive of the Regional Training Center and the FOP. Chief Jones is on board for as long as it takes to hire a permanent chief in Fort Collins.
- Crime Stats – Chief passed out the April crime stats which indicated some of the following:
 - Traffic Crashes down 5%
 - DUS/DUR/DUD Traffic Citations up 42%
 - Careless driving citations up 9%
 - Calls for service are down 16% thanks to a new phone tree that the police department has implemented.
 - Part I crimes down 15%
 - Crimes against persons (assaults) up 30%
 - DUI/DUID Arrests up 50%
- Community Night Out – June 21
- **THANKS** to Becky Kamoske twenty (20) AEDs will be placed in patrol cars.
- **DDACT** signs have been placed along Highway 34 corridor indicating that there is high traffic enforcement along this stretch.
- Assistant City Attorney Vince Junglas is working on an agreement with surrounding agencies and CSP for back up officers on traffic enforcement.

COMMENTS

- ✚ PCAB member Gassman stated that he has received traffic complaints from citizens along Monroe Avenue between 37th and 50th. Chief stated that he has assigned this project to Sgt. Halloran, the Traffic Unit Sergeant.
- ✚ PCAB member Tindall asked that a picture of PCAB members in attendance be taken and put on Facebook.

A motion was made and seconded by Dick Hunsaker and Ed Gassman respectively to adjourn the meeting. Motion carried. Approved. Meeting adjourned at 7:10 PM.
