Present: Chairperson Pat Kistler; PCAB members: Bev Cardarelli, Erin Frisch, Dick Hunsaker, Kathy Mitchell, Dennis Soucek and John Tindall. Absent PCAB member: Ed Gassman. Councilor Don Overcash; Chief Bob Ticer; Commander Tim Brown; Lieutenants Arnold, Hurr and Newbanks and Asst. City Attorney Vince Junglas and Elizabeth Markham

PCAB Chairperson Pat Kistler called the meeting to order at 5:30 PM. A motion was made and seconded by Kathy Mitchell and John Tindall respectively to approve the minutes as is. Motion carried. Approved

Chief Ticer started out by telling PCAB members that a new direction has come from City Council and the City Manager to present to Boards and Commissions policies or changes that are to be presented to City Council for their upcoming meetings. Two items were on the agenda for the meeting:

- a) DDACTS 1: Foot patrol and bike patrol in the downtown area.
DDACTS 2: Traffic enforcement on Hwy 34 corridor from Madison east to Co Rd 3 by Centerra AND the downtown area (Hwy. 287) from 5th Street north to 43rd Street.
- b) Evaluate asset money from Drug Task Force seizures, which is a shared fund

LTS. HURR and NEWBANKS

▪ **DDACTS Zones:**

- Lts. Hurr and Newbanks presented some information on DDACTS (Data Driven Approach to Crime and Traffic Safety) During the month of June there were approximately 900 traffic stops in these zones. In July the numbers had subsided. The vision for the downtown area is our need for additional staffing. With the Foundry coming on board it may call that the police department initiate another district for that area. Councilor Overcash indicated that he has received a lot of great comments from downtown businesses and patrons regarding our foot patrol. Councilor Overcash questioned if we could start a foot patrol at Centerra during the holiday season. Lt. Hurr indicate that was in the plan and we were going to give every effort to do that. Since this topic is going to be discussed at the next City Council meeting Councilor Overcash asked the lieutenants to put some crime numbers with the presents and Chief indicated he would. PCAB member Pat Kistler stated that this was a great movement for the police department. *After some discussion a motion was made by Chairperson Pat Kistler that the Board accept this policy and seconded by board member Cardarelli. Motion carried. Approved.*

▪ **Lt. Arnold and ACA Vince Junglas**

- Lt. Arnold presented to the Board that he and ACA Junglas are working on the follow-up to City Council's request for staff to evaluate the issue of equitable shared funds from the Drug Task Force. ACA Junglas explained that state seizures and cost of prosecution fees are handled by the 89th Judicial district. Various options were given to the Board as to where the Drug Task Force money

should be spent. Board member Frisch asked if we can re-evaluate the IGA and Lt. Arnold stated that we are looking into that now. *After some discussion a motion was made by board member Tindall to support the idea of continuing the utilization of the funds as we are currently doing, which is overtime for SIU and the remainder for downtown foot patrol. Motion seconded by board member Mitchell. Motion carried. Approved.*

CHIEF'S UPDATE

- ✚ Chief updated the Board on our two new commanders
 - Commander Eric Stewart – 32 years in law enforcement with the Aurora Police Department. Started in July.
 - Commander Ray Butler - coming from the Department of Public Safety in Arizona. Will start late fall of 2017.

There being no other business to discuss a motion was made and seconded respectively by Kathy Mitchell and John Tindall to adjourn the meeting. Motion carried. Approved.
