

**Loveland Senior Advisory Council****January 6, 2010****MINUTES****Gertrude B. Scott Room @ Library**

**BOARD MEMBERS PRESENT:** Earl Stevens, Sybil Arns, Larry Roos, Phoebe Hawley, Daryle Klassen, Mary Louise Kreiger, Anne Brown, Diane Stobnicke, Diane Traylor (DAC), Betty Herder, Doris Helwig, Lynn Hayden Ugarte and Bobby Sutton. Kim Ferro has been excused.

**OPENING COMMENTS:** Earl Stevens; **Senior Day** at the **Capitol** will be Feb. 24<sup>th</sup> Please sign up today- (on the sheet being handed around)-the plan is to leave 7:30 AM return around 3:15 PM.

Discussion of Senior Advisory Board Membership, city council reduced one liaison membership as Golden K withdrew. An ordinance amending the Loveland Municipal Code at Section 2.60.240 was handed out for membership review. Nine members shall be appointed by the city council to serve terms of 3 years. Six members shall be nominated by the SAB and approved by the city council to serve terms of 2 years. The six members shall consist of one at- large member and one member from each of the following organizations: Chilson Senior Advisory, Volunteers of America, McKee Senior Services, the Poudre Valley Hospital Aspen Club and McKee Medical Center Seasons Club. **REQUEST** is to increase the overall board membership from 14 to 15 members by adding one at-large position to be nominated by the Board, and approved by Loveland City Council, to serve a term of 2 years.

**Motion:** Recommendation to City Council for approval of changes to Municipal Code (2.60.240) to increase membership to an additional at-large member. Motion accepted by Sybil Arns, seconded by Anne Brown.

**APPOVAL of DECEMBER 2, 2009 MINUTES: accepted as presented**

**LOVELAND SENIOR SINGLES** motion was made to withdraw recommendation to change their name to Loveland Seniors by sending a letter to the Loveland Senior Singles, leaving out the word "Single." Amendments to the SS by Laws dated 10/13/09 was handed into the SAB file.

**Motion:** Was so moved by Sybil Arns, seconded by Doris Helwig. One negative motion.

**ANNOUNCEMENTS:** Paratransit Input sought. Earl Stevens asked if members received the forwarded email as requested by City Council member Klassen from Transit Manager Marcy Abreo. Seeking input for comments on proposed service options as part of the Comprehensive Paratransit REVIEW Project. Discussion followed, no recommendation or formal action will be taken at this time.

**SPEAKER:** Member Larry Roos introduces the "VITA" Income Tax Program

Volunteer Income Tax Assistance is a Nationwide Non Profit. Grants from the IRS- provide laptops to help people with their tax returns, clients are people with disabilities, low income or seniors. Many very highly qualified and trained volunteers do taxes (on the spot) on a 1<sup>st</sup> come 1<sup>st</sup> served basis. This service is offered out of the 1<sup>st</sup> Methodist Church 533 N. Grant Ave. corner of 6<sup>th</sup> Street and Grant St. their # is 970-667-0876. Last year over 3,000 tax returns were completed.

Hours are Monday thru Thursday 9-Noon and 1 till 4 PM. VITA has 30 volunteers. Fridays they travel to the Berthoud community to offer help there. The average time to complete taxes takes 1.5 hours, some 1099 could take longer. VITA volunteers can also help small businesses. For info -visit the IRS website to the VITA page for list of what to bring to complete your taxes. No age limit. **City Update:** Jan 15 and 16 will be Council's Retreat. Colorado's economic forecast will remain tied around creation of new jobs. Loveland remains optimistic, with the 34 million Revitalization Plan and Lodging Tax estimated to generate \$350 to \$400,000 in revenue. Applications going out to residents interested in applying for a position on a new 7 member Commission to help Loveland with marketing and Art promotion. The city has 4.7 million in American Reinvestment & Recovery Act Stimulus funds. \$3.3 million will go toward street safety projects, 1.4 million will be used to purchase 2 NEW BUSES and fund energy projects within the city.
