Mr. Junglas was satisfied that the applicant was a qualified to hold the Liquor License. The Authority's concerns were also satisfied and the Transfer of Ownership was approved.

This matter was continued from October 19, 2017, for a transfer of ownership of the Hotel and Restaurant License from Fuasian Soho Bowl Inc. dba Asian Café and Grill. A temporary transfer permit was issued on September 5, 2017.

SHOW CAUSE HEARING

The purpose of this hearing is to consider the suspension or revocation of said license for alleged violations by the Licensee; or by any of the agents, servants, or employees of said Licensee, of the provisions of the Colorado Liquor Code, or any of the rules or regulations adopted pursuant thereto.

a. Mazuma Restaurants LLC dba Pourhouse Bar and Grill 124 East 4th Street

ACTION TAKEN: Attorney Adam Stapen and Chris Kline appeared to address the Authority and answer questions. A stipulation was approved whereby the Licensee will serve a suspension of three (3) days of the Hotel and Restaurant License; the three days will be served as a fine in lieu of active suspension. The Licensee shall pay a fine totaling \$1,075 in lieu of the suspension and the fine will be paid on or before December 1, 2017.

The application was filed for a new Hotel and Restaurant License to dispense malt, vinous and spirituous beverages by the drink for consumption on the premises. The neighborhood boundaries were designated as: North – West 1st Street; South – 28th St. S.W./Cty. Rd. 16; East – Garfield Avenue; and West – S. Wilson Avenue/Cty. Rd. 19. The premises was posted with a sign advertising the Public Hearing and a notice was published in the Reporter Herald as the law requires.
