NON-ACTION/INFORMATION ITEMS

Golf Division Funding

Steve Southard discussed the process to building a clubhouse including funding. Steve related that he had talked to other owners of similar facilities regarding their F&B areas and all said, if they were building a new facility today, they would not build the full-serve restaurant model. Staff is investigating ways to combine uses of areas in a new clubhouse design. For example, is there a way to use a large patio area during season and a different way to use the same space during winter, (e.g. indoor hitting areas)?

No Action Taken: Golf Board comments included names and sites of indoor hitting areas and discussion around success of indoor hitting areas. Councilor Overcash felt that Council would favor a business model/building design that incorporated ways to improve revenues during the winter months.

Golf Operations Report

The RFP documents are out for the F&B Concession at Mariana Butte. The City of Loveland Municipal Code requires that a competitive process be undertaken periodically to select a firm to run the restaurant and concessions at Mariana Butte Golf Course. The previous agreement conditions stated a term of 5 years (expiring 2017), so the City is now undertaking this process again. The City is interested in a longer term (up to 10 years) contract with a qualified firm.

- Rex Lamoreaux complimented Steve on the speed at which he was able to get the fairways mowed differently at Cattail Creek (Rex saw Steve on the mower the next morning after the last Board meeting.)
