## **CALL TO ORDER**

Chair Warner called the meeting to order at 6:04 pm MT.

## **Approval of Minutes**

December 7, 2017: Commissioner Soreide made a motion to approve. Commissioner Taylor seconded the motion. 6 ayes, 1 abstain. Motion passes.

## **The Edge Funding**

Andy Bickers from Loveland Housing Authority. The Edge houses formerly homeless veterans. The City of Loveland gave \$10,000 in 2017 to support case management of the program with an assumption of an additional \$20,000 from 2018-2019. This is the first project of its kind for Loveland Housing Authority and while additional funding is coming the additional financial support has helped to ensure supportive housing services are consistent.

Commissioner Selders made a motion to support the \$20,000 allocation from the Housing Development Fund to go to The Edge case management services during 2018-2019 (\$10,000 each year). Commissioner Shaddock-McNally seconded the motion. Passed unanimously.

## **COUNCIL UPDATE**

- Councilor Jersvig requested feedback from the Commission regarding important priorities to communicate to City Council. Recommendation made to schedule a joint commission meeting with the Human Service Commission and Affordable Housing Commission to determine priorities.
- Community Housing Development Fund- Clarification is needed around the perpetual nature of the 400,000 annually and the 1.25% sales tax.

## **COMMUNITY PARTNERSHIP OFFICE UPDATE:**

- Community Resource Connection group first quarter of 2018 presentations planned.
- Larimer County Health Summit is January 24<sup>th</sup>.
- Agency meetings for upcoming grant cycle are next week.

## **Community Request Process**

- All requests to City of Loveland outside of typical processes would be processed in a predictable manner through Community Requests
- Process includes two application steps, departmental reviews, Boards and Commissions endorsement, and formal presentations to City Council.
