4.2 FINANCE

DRAFT 2019-2028 CAPITAL IMPROVEMENT PROGRAM (CIP) & FINANCIAL MASTER PLAN

Brent Worthington, Finance Director; Theresa Wilson, Budget Manager; Matthew Elliott, Senior Budget Analyst; Brett Magellin, Budget Analyst presented this item to review the Draft 2019-2028 CIP and Draft 2019 Financial Master Plan with City Council, answer questions, and receive feedback and direction for finalizing the 2019-2028 CIP.

Objective was to finalize the 2019-2028 CIP, year one (2019) of which will be included in the Draft 2019 Budget.

The effort will result in a robust, thoughtful, and well-planned 2019-2028 CIP for the City of Loveland.

Council Follow-up: The final 2019-2028 CIP will be brought back to City Council during the Draft 2019 Budget Study Session scheduled for September 11, 2018. First Reading and Public Hearing of the 2019 Budget is planned for the regular City Council meeting scheduled for October 2, 2018. Second Reading, Public Hearing, and anticipated adoption of the 2019 Budget is planned for the regular City Council meeting scheduled for October 16, 2018. The first year of the 2019-2028 CIP will be adopted as part of the 2019 Budget. The 2020-2028 out-years will be approved by City Council in concept only.

Sales tax revenue is not meeting a 3% threshold, staff will research with other municipalities to see what they are experiencing. Staff will work encumbered and spent amounts to show a clearer explanation of the difference between the two.

REQUIRED RESERVE POLICY PRESENTATION

Brent Worthington, Finance Director, presented the current Required Reserve Policy, adopted October 4, 2011, which has a number of inconsistencies. The presentation highlighted these issues with a request for direction from City Council for revisions to the policy, and introduce enhancements that could be incorporated into a future policy revision. Council directed staff to revise the policy and present a draft to Council.

BUDGET RESILIENCY PLAN PRESENTATION

Brent Worthington, Finance Director, presented this item. At the January 24, 2018 City Council Goal Setting Session, Council directed the Finance Department to prepare and present an in-depth recession plan. During the development process, Staff expanded the presentation to include other events that could have negative fiscal consequences and will be able to develop an expanded plan sufficient to prepare for and address a wider range of harmful circumstances by prioritizing and providing a continuum of options.
