## 2.1 HUMAN RESOURCES MUNICIPAL JUDGE QUARTERLY PERFORMANCE MEETING WITH POSSIBLE EXECUTIVE SESSION

Municipal Judge, Geri Joneson, presented a quarterly report to update City Council on trends in the Court regarding both the type and volume of cases filed in Municipal Court, as well as informed City Council of any major changes in Court procedures, legislation, or other items that may affect Municipal Court.

Pursuant to the report, Council discussed options for providing the report either two or three times per year with the option for an evaluation continuing on a quarterly basis. Council asked about holding the Municipal Judge evaluation twice a year. City Attorney Garcia stated that the Council approved a Resolution stating the evaluations for their three direct reports would be held on a quarterly basis; any change from that would require Council action.

Councilor Ball requested a Rule of 4 to discuss changing the evaluation dates for the municipal judge; Councilor Fogle, Councilor Jersvig and Mayor Marsh concurred.

City Council and Judge Joneson decided there was not a need for an executive session.
