#### **CALL TO ORDER**

Ursula Albers, Norm Reichardt of Northstar Homes and Vernon Smith presented information for The Meadows-Simple Living Community. Commission discussed and would like more information after the project has gone through the planning process.

- Enchantment Ridge Subdivision Update. We are complete with the affordable housing portion (20%) of the subdivision.

# **LOVELAND FIRE RESCUE FEES**

Commissioner Rice motion that we recommend to City of Loveland Council that the Loveland
Fire Rescue Fees are backfilled from the Community Housing Development Fund for affordable
housing designations back dated to January 1, 2018 and future projects as approved.
Commissioner Gresham seconded. Passed unanimously. Payback to LFRA will include Mirasol
Phase III, Greenhouse Homes, and Habitat for Humanity. The estimated amount is roughly
\$45,000.00

# ASSET CAP

• The Commissioners discussed placing an asset cap for the City of Loveland's Affordable Housing program. The commissioners decided to table this discussion until a future date.

# **APPRECIATION CAP**

• The Commissioners discussed placing an appreciation cap for the City of Loveland's Affordable Housing program. The commissioners determined more time and research needed before a vote should take place. This topic will come up for Grace Gardens and The Meadows- Simple Living Community. This item will be on the November agenda.

# **CDBG GRANT GUIDE REVIEW**

At this time, the Commissioners determined no changes are needed to the grant guide.
 Commissioner Daley motioned that we leave the Grant Guide as is, Commissioner Irelan seconded. Passed unanimously.
