CALL TO ORDER

Commissioner Thorp called the meeting to order at 6:00 pm MT.

APPROVAL OF MINUTES

Commissioner Warner motioned to approve the minutes of September 6, 2018. Commissioner Taylor seconded the motion. Passed unanimously.

PRESENTAITON

Jessi Colehour updated the commission about One Community One Family and the City of Loveland Housing First grant. Jessi informed the commission that she received funding from Foundations Church, which will get her started with rent assistance. She shared a success story of a family housed through OCOF and she has started working with the first rapid re-housing client.

COUNCIL UPDATE

- Councilor Jersvig talked about the September 25, 2018 council meeting that addressed issues and solutions to opioid addiction, suicide and homelessness that a task force identified as the "top problems facing Loveland."
- Councilor Jersvig supports the change to the code around youth members.

COMMUNITY PARTNERSHIP OFFICE UPDATE

- InterSector Partners will begin on September 24, 2018 reviewing agency policies and practices (ADA, Title VI, and grievance) of four agencies: Voices Carry Child Advocacy Center, ChildSafe, House of Neighborly Service and Alternatives to Violence. They will also conduct an all agency (and future agency applicants) meeting later this year and will meet with the Human Services Commission to review the grant guide and provide technical assistance.
- Burnes Institute at DU contract is in process. The Community Partnership Office has a call planned for 10-09-2018.
- Loveland Connect is right around the corner, October 12, 2018 at Truscott Elementary.
- The Community Partnership Office was presented of an idea of a sober living home. This home would have an onsite manager. This home would serve six individuals at a time, both female and male. Currently they are working on funding and have submitted their business plan to our office.

The commission made a motion to revise the question to: "Provide a meaningful example of specific collaboration with another non-profit or non-profits." Commissioner Warner motioned.
