COMMUNITY PARTNERSHIP OFFICE UPDATE

- InterSector Partners began their work on September 24, 2018 reviewing agency policies and practices (ADA, Title VI, and grievance) of four agencies: Voices Carry Child Advocacy Center, ChildSafe, House of Neighborly Service and Alternatives to Violence. They will also conduct an all agency (and future agency applicants) meeting later this year and will meet with the Human Services Commission to review the grant guide and provide technical assistance.
- Burnes Institute at DU contract is moving forward. We have had a kick off meeting that included taking a tour of a few nonprofits. We are setting up agency meetings. There will be a study session on November 27th.
- Loveland Connect served 274 individuals.
