APPROVAL OF MINUTES

ACTION TAKEN: The Minutes were approved as submitted.

3. CONTINUED FROM JUNE AGENDA

MODIFICATION OF PREMISES

A. Desk Chair LLC dba Five Tables Cafe 201 East 4th Street

This application was continued from the June 20, 2019 meeting; with the request of owner (liquor license holder) to be present to answer questions.

ACTION TAKEN: Owners Doug and Justin Erion appeared to answer questions. Loveland's Fire and Building departments' representivies were present for questioning. The Public Hearing was held and the Authority was satisfied that the applicant is qualified to control the modified premises. No parties in interest were present, and the permanent modification was approved.

TRANSFER LICENSE AND TASTING PERMIT

A. JB & BB LLC dba Bentley's Liquor 1775 Rocky Mountain Avenue

An application was filed for a transfer of ownership of the Retail Liquor Store license from B & E LLC. A temporary transfer permit was issued on May 28, 2019 and a Retail Liquor Store Tasting Permit has also been applied for.

ACTION TAKEN: Owners Jessica and Brian Boggard, and attorney Anda Stephenson appeared to answer questions. The Authority was satisfied that the applicant is qualified to hold the Liquor License. The Authority approves the Tasting Permit and Transfer of Ownership.

SPECIAL EVENT PERMIT

B. Colorado Kids Create Inc.920 West 29th Street

An application was filed on June 4, 2019 for 'Loveland Fine Art Invitational' to be held this year on August 9 from 11 a.m. to 8:30 p.m.; August 10 and 11 from 11 a.m. to 5:30 p.m. The premises was posted with a public notice as the law requires.

ACTION TAKEN: Board member and Event Manager William Myers, appeared to answer questions. The Authority was satisfied the applicant is qualified to hold the liquor permit and the application was approved.

TRANSFER LICENSE

C. Fache LLC dba CJ's Patio Grill 1331 Eagle Drive

An application was filed for a transfer of ownership of the Hotel and Restaurant license from CJ's Patio Grill Inc. A temporary transfer permit was issued on June 7, 2019.

ACTION TAKEN: Owners Fadil Astafaj and Christopher Aloi appeared to answer questions. The Authority was satisfied that the applicant is qualified to hold the Liquor License. The Authority approves the Transfer of Ownership.

The application was filed for a new Lodging and Entertainment License. The Authority was satisfied that the applicant is qualified to hold a liquor license. The application is conditionally approved upon completion of inspections from the Building Department, the Fire Marshal and the final Police Department inspection.

B. Loveland Wing Company LLC dba Loveland Wingstop 3033 N Garfield Ave.

The application was filed for a new Beer and Wine License. The neighborhood boundaries were designated as: North – 45th St.; South – E 16th St.; East – Madison Ave.; and West –

N Taft Ave. The premises was posted with a sign advertising the Public Hearing and a notice was published in the Reporter Herald as the law requires.

ACTION TAKEN: Owner Aaron Zipp and Carol Johnson from Esquire Petition Services appeared to answer questions. There were no parties in interest present and this public hearing was closed. The Authority was satisfied that the applicant is qualified to hold a liquor license. The application is conditionally approved upon completion of inspections from the Building Department, the Fire Marshal and the final Police Department inspection and background check from fingerprints is completed.
