ORDINANCE VACATING A TWENTY FOOT ALLEY WITHIN THE WESTMOUNT ACRES ADDITION, CITY OF LOVELAND, COUNTY OF LARIMER, STATE OF COLORADO

The owner of 2004 W. Eisenhower Blvd. intends to redevelop the currently 0.75-vacant property for retail and restaurant uses. There exists a 20 foot public alley at the southern end of the property that is not regularly used. Vacation of this alley would provide additional depth to the property that would better facilitate its redevelopment, and the proposed site plan is contingent upon acquiring the additional 20 feet of property. Adjacent owners have agreed to this vacation, and access easements as well as utility easements would be maintained. The applicant understands that upon vacation of the easement, 10 feet of the alley would revert to the owner of 2004 W. Eisenhower, with the other 10 feet reverting to property owners to the south. This southernmost part of the alley would need to be purchased or otherwise obtained from those southern property owners prior to redevelopment.

ORDINANCE VACATING CERTAIN RIGHT-OF-WAY WITHIN THE MYERS GROUP PARTNERSHIP #949 THIRD SUBDIVISION, CITY OF LOVELAND, COUNTY OF LARIMER, STATE OF COLORADO

This application proposes to vacate a 2.33-acre portion of unimproved (unpaved) right-of-way at the south end of the Centerra Motorplex. The right-of-way to be vacated is situated south of the paved portions of Test Circle and Byrd Drive, and had been intended to connect the two streets with a curved (half-circle) road segment.

The dedication of additional east-west Precision Drive right-of-way, extending it to Test Drive from its current terminus at Byrd Drive, is being arranged in conjunction with the vacation through the submittal of a concurrent plat application. With the concurrent extension of Precision Drive, the unpaved half-circle right-of-way connecting Test Drive and Byrd Drive, just south of Precision Drive, is unneeded.

ORDINANCE ENACTING A SUPPLEMENTAL BUDGET AND APPROPRIATION TO THE 2019 CITY OF LOVELAND BUDGET FOR A SURVEY OF HISTORICAL PROPERTIES WITHIN THE CITY OF LOVELAND, COLORADO

This project will allow the City of Loveland to conduct an intensive level survey of 20 to 25 properties related to the sugar beet industry and/or Germans from Russia immigrant population in Loveland, Colorado. Under the agreement as a Certified Local Government (CLG) with the state historical office and as outlined in the Loveland Historic Preservation Plan adopted in 2002, the City of Loveland regularly updates and maintains an inventory of properties eligible for historic designation.

These grant funds will cover an intensive survey which will allow the City of Loveland to enhance its historic inventory as well as maintain its CLG status with the State of Colorado, allowing for its continued ability to apply for state historical fund grants. Loveland has benefited with approximately 2.5 million dollars in grant funding since it became a CLG.

The first reading of this ordinance was heard at the July 16, 2019 City Council meeting where it passed on the consent agenda with a 9-0 vote.

Appropriation of \$145,285.68 of surety funds being held in escrow account 120-00-000-0000-35200 for Warranty repairs not completed by the Developer. With approval these funds will be transferred to account 211-23-232-1701-49360, EN1901 for the work being contracted with Don Kehn Construction for repairs to Boyd Lake Ave.

City Council heard this item on first reading on July 16, 2019, where it passed with a 9-0 vote on the consent agenda.

Per the Larimer County Urban Area Standards a surety is required to be kept in escrow during the 2-Year Warranty period. When a developer fails to complete warranty repairs the City may use these surety funds to complete the required repairs. This ordinance is for the appropriation of \$145,285.68 of surety funds being held in escrow for warranty repairs not completed by the developer. With approval these funds will be transferred to account 211-23-232-1701-49360, EN1901 for the work being contracted with Don Kehn Construction for repairs to Boyd Lake Ave.

Public Works has competitively bid the necessary repairs and is contracted with the low bidder, as seen in Attachment 1. Additionally this work has been approved by the Bankruptcy Court.

ORDINANCE ENACTING A SUPPLEMENTAL BUDGET AND APPROPRIATION TO THE 2019 CITY OF LOVELAND BUDGET FOR ONE FULL TIME EMPLOYEE POLICE OFFICER TO STAFF THE NEW VISION CHARTER SCHOOL (NVCS) SCHOOL RESOURCE OFFICER (SRO) POSITION

The proposed ordinance will provide funding for one full time employee (FTE) police officer position. Funding one FTE police officer position will allow the department to assign one police officer to the School Resource Officer (SRO) program. The expansion of the SRO program by providing SRO services to New Vision Charter School will positively impact school safety in Loveland. Positive impacts include: (a) the SRO program's efficiency and effectiveness, and (b) school safety. Additionally, funding one FTE police officer position will allow the Department to assign one additional police officer to the SRO program without adversely affecting patrol staffing levels and the delivery of police services to the community.

City Council heard the first reading of this ordinance at the July 16, 2019 City Council meeting where it passed on the regular agenda with a 9-0 vote.

ORDINANCE ENACTING A SUPPLEMENTAL BUDGET AND APPROPRIATION TO THE 2019 CITY OF LOVELAND BUDGET FOR TWO FULL TIME EMPLOYEE POLICE OFFICERS TO STAFF THE NORTHERN COLORADO TRAFFIC SAFETY TASK FORCE (NCTSTF)

The proposed ordinance will provide funding for two full time employee (FTE) police officer positions. Funding the two FTEs will allow the Department to assign one sergeant and one police officer to the Northern Colorado Traffic Safety Task Force (NCTSTF). Assigning a sergeant and police officer to the NCTSTF, which will include personnel from the Larimer County Sheriff's Office and the Windsor Police Department, will focus on reducing impaired driving and positively impact traffic safety in Loveland and Northern Colorado. This will provide a positive impact concerning traffic safety in Loveland and Northern Colorado. Additionally, funding two FTE police officer positions will allow the Department to assign one sergeant and one police officer to the NCTSTF without adversely affecting patrol supervision and staffing levels and the delivery of police services to the community.

The first reading of this ordinance was heard at the July 16, 2019 City Council meeting where it passed on the regular agenda with a 9-0 vote.

ORDINANCE AUTHORIZING THE SALE OF RIGHT-OF-WAY TO LARIMER COUNTY FOR THE LARIMER COUNTY ROAD 17 ROAD WIDENING PROJECT PURSUANT TO SECTION 4-7 OF THE CITY OF LOVELAND MUNICIPAL CHARTER

The purpose of this item is to assist Larimer County with widening County Road 17 between U.S. Highway 287 and County Road 16 and to authorize the sale of 7,322 square feet (0.168 acres) of City property to Larimer County for the County Road 17 Widening Project. The City Property to be sold includes the east 20 feet of the water tank parcel located on the west side of County Road 17 (Taft Ave/Berthoud Parkway) and just south of County Road 14 (42nd Street Southwest). The City will receive \$8,150 as compensation, and the County will have adequate right-of-way to make the necessary improvements to County Road 17.

ORDINANCES TO ADOPT THE CITY OF LOVELAND WIRELESS COMMUNICATIONS CODE AS TITLE 14 AND AMENDING PORTIONS OF THE UNIFIED DEVELOPMENT CODE AND SECTION 13.12.200

The purpose of this item is to consolidate provisions of the Loveland Municipal Code from Titles 13 and 18 into a new Title 14 - Wireless Communications Code. This requires amendments to Title 13 and Title 18 (the Unified Development Code), along with adoption of a new Title 14 which adds provisions to address state law and federal regulations, particularly regarding the deployment of small cell wireless facilities in the public right-of-way. Approval of the proposed Title 14 and associated amendments will allow the City to regulate the deployment of wireless communications facilities in the public right-of-way by requiring providers to sign a master license agreement and follow the City's wireless design standards. Existing code provisions regarding pole attachments and wireless communications facilities on private property will remain intact with limited revisions.

The new code provisions will protect the City's interests in the public right-of-way to the greatest extent possible. The consolidated code will provide easier guidance to the City and cellular providers regarding wireless communications facilities.

ORDINANCE ENACTING A SUPPLEMENTAL BUDGET AND APPROPRIATION TO THE 2019 CITY OF LOVELAND BUDGET FOR THE REDWOOD/US 34 CDOT REIMBURSEMENT FOR EMERGENCY SIGNAL REPAIRS

During a snow storm on March 13, 2019, the traffic signal at US 34 & Redwood sustained significant damage when a 7200 Volt power line swung into the signal pole. The traffic signal is owned by Colorado Department of Transportation (CDOT) and maintained and operated by the City under contract. Due to the extent of damage sustained, CDOT agreed to reimburse the City for the cost of repairs.

Each year, the Community Partnership Office submits the Annual Action Plan to the U.S. Department of Housing and Urban Development (HUD) to identify the housing and public service projects that will be funded with CDBG funds during the next grant year. This action is necessary to submit the plan to HUD.

City Council appropriated 2019-2020 CDBG funding on second reading on May 21, 2018 and approved grant recommendations on June 4, 2019. A copy of the Annual Action Plan is attached.

This award request is a result of a competitive public bid process for which there were four responsive and qualified bidders. DeFalco Construction was the lowest bidder.

3. NO-ACTION ITEMS

3.1 PUBLIC WORKS FOUNDRY PLAZA OPERATIONS

This informational item provided background to Council as it related to the operations and maintenance of the Foundry Plaza. Discussed will be Metro District history, current status, budgets, cost sharing, and operational opportunities.

Michael Hogan introduced Jay Hardy from Brinkman who presented a brief history of the Foundry plaza.

Mr. Hogan noted the responsibilities and maintenance, which has led staff to question if it would be better if one entity to maintain it all. Staff noted that the city looks at operations in regards to maintaining it forever, and the private sector will approach with a year-to-year mindset. No matter who controls the maintenance it needs to be a cohesive effort, with all areas of the district being cohesive.

Brinkman is requesting that the City of Loveland share in the shortfall of the Metro District, with a \$150k from City of Loveland and \$130k from the Downtown development authority.

Brinkman & city staff agreed on scope of work, quality & expectations, and both recommend one entity would be the best option. The Metro District is willing to take the responsibility.

Council discussed the two options – if the city maintains it and it happens to not be up to city standards can they respond to concerns as needed. Council does have the authority to bring this issue back if the maintenance is not up to city standards.

Mr. Hogan recommended bringing back this item with dollar amounts so City Council can make a decision, as well as bringing the service agreement. Council recommended the city be in for 50% of the agreement and cost, and staff will bring the service plan at a later date.

3.2 ECONOMIC DEVELOPMENT INFORMATION ITEM REGARDING THE REDEVELOPMENT OF 205 E. 6TH STREET

The purpose of this item is to update the Loveland Urban Renewal Authority (LURA) Board on the status of 205 E. 6th Street and to seek direction on next steps for managing and marketing the property for redevelopment.

Kelly Jones, Economic Development Director and Mike Scholl, Economic Development Manager, presented the information to Council with the changes from the previous information meeting given to Council.

Staff was able to work with Longbow and the earnest money has been returned back to Longbow in exchange for all their due dalliance documents. Appraiser Zachary Smith also attended in order to answer questions from Council.

Ms. Jones introduced Zachary Smith, who gave a brief background of his history as an appraiser and the appraisal of market value of the building. Mr. Smith did go into depth as to the wide variety of instances that can happen with the building and how market value is defined in the report.

Mr. Smith addressed questions regarding the cost to put in a sprinkler system. His opinion would be that the city could get away from putting in a fire suppression system but believes that purchasers will want it so it can be turnkey ready.

Council directed staff to move forward to find a buyer for the building.

7.1. CITY MANAGER

ORDINANCE CONCERNING RECREATIONAL AND MEDICAL MARIJUANA AND SUBMITTING TO THE REGISTERED ELECTORS OF THE CITY OF LOVELAND AT THE CITY'S REGULAR ELECTION TO BE HELD ON NOVEMBER 5, 2019, A BALLOT

ISSUE PERMITTING RETAIL AND MEDICAL MARIJUANA DISPENSARIES, CULTIVATION, MANUFACTURING, AND TESTING AND RESEARCH FACILITIES IN THE CITY AND IMPOSING AN EXCISE TAX OF UP TO 15% WHEN UNPROCESSED RETAIL MARIJUANA IS FIRST SOLD OR TRANSFERRED BY A RETAIL MARIJUANA CULTIVATION FACILITY AND BY IMPOSING AN ADDITIONAL SALES TAX OF UP TO 15% ON THE SALE OF RETAIL MARIJUANA AND RETAIL MARIJUANA PRODUCTS BEGINNING JANUARY 1, 2021

The purpose of the ballot measure is to authorize the cultivation, manufacturing, research and testing, and sale of medical and retail marijuana in Loveland and approve an excise tax on the first sale of unprocessed retail marijuana and an increased sales tax on retail marijuana. The objective is to allow Loveland voters to determine if there is support to authorize and apply a special sales and excise tax on retail marijuana at rates not to exceed 15.0% in Loveland. If the ballot measure is successful, the City of Loveland will authorize medical and retail marijuana in Loveland and to collect tax revenue on retail marijuana in addition to the City's existing 3.0% sales tax rate.

Alan Krcmarik presented this item and briefly went over a history of the Council requested Rule of 4, and compared various communities surrounding the City of Loveland regarding selling and manufacturing of retail and medical marijuana.

Mr. Krcmarik also presented the ballot question language for Council to review. Staff wanted to note that even if the ballot question went to the election this year, Council would have 18 months to create an ordinance with how much tax Council would want to apply, how many dispensaries etc. that Council would want to allow.

Council discussed splitting it into two questions; one for retail and another for sales tax, and if the tax portion would get passed by the voters how Council would choose to tax sales. Staff clarified that if the question passed as is, Council would have the option to tax up to, not exceeding, 15% and would have the option to raise or lower the taxes, not to exceed 15%, without returning to the voters.

Sally Tasker from Butler Snow informed Council that the form of the ballot question is wording and phrasing that is required by the Colorado Constitution. The tax amount is not an expectation of the amount the City would receive in taxes, it is informing the public the maximum amount the City would be allowed to keep without refunding it to the voters or asking the voters if the City can keep the excess.

Mayor Marsh opened Public Comment.

Tom Olzinski questioned if 15% excise tax comes back to city.

A Motion To Amend The Motion To Turn The Ballot Question Into Two Questions

Councilor Jersvig motioned, Fogle seconded

Tom Olsinski stated that if taxes are raised the public may go elsewhere.

4.13. ORDINANCE ENACTING A SUPPLEMENTAL BUDGET AND APPROPRIATION TO THE 2019 CITY OF LOVELAND BUDGET FOR THE ACQUISITION OF LAND FOR FUTURE RECREATION FACILITY DEVELOPMENT

Removed from Consent Agenda by Councilor Olson.

The purpose of this item is to secure 18.095 acres of land over a three-year period for the future development of recreation facilities. This appropriation is for purchase of the first 6.095 acres valued at \$223,300 (\$34,771 per acre) plus annexation, surveying and closing costs. On July 15, 2014, City Council Adopted the Parks and Recreation Master Plan, which identified the need for specialized recreation facilities to keep up with projected community growth. The Parks and Recreation Master Plan guideline for recreation centers is 1 per 60,000 population and 1 per 50,000 for outdoor aquatic facilities. In 2019, with an estimated population of 79,000 and a projected population of almost 95,000 by 2023, the time is now to purchase the land so expanded facilities can be built to meet the needs identified in the Master Plan. With projected residential growth, we will not be able to meet and maintain this service level without the acquisition of additional land for future development. Capital Expansion Fees (CEF) are collected for recreation development to meet community growth. The funding ordinance would appropriate \$300,000 from the Recreation CEF Fund for the acquisition of land suitable for community recreation facilities within the Growth Management Area.

LeAnn Williams, Recreation Manager, presented this item and noted that staff has been working on this deal for over five years and clarified with Council that this is solely to purchase the land.

Mayor Marsh open Public Comment, of which there was none.

8. NO-ACTION ITEMS

8.1. FINANCE

INVESTMENT REPORT JUNE 2019

Half-way through 2019, the market value (including accrued interest) of the City's investment portfolio is estimated to be \$229,167,687. This is about \$1.5 million more than the prior month. The budget revenue projection for the full year of 2019 was set at \$3,319,680. So far this year, actual interest received is now \$564,003 ahead of projections. Using the portfolio's beginning year balance, the rate needed to reach the annual interest earning target is 1.43%. The annualized interest rate at the end of June remained at 1.91%. For the month, accounting staff posted \$287,745 to various fund accounts. The year to June month-end total is \$1,941,554. U.S. short-term (under five years) Treasury interest rates were inverted (short term rates higher than longer term rates) in June. At the time this summary was written the rate on the 10 year U.S. Treasury Note was 2.079%, the rate on the 2-Year Note was 1.865%, and the rate on the 3-month Treasury was 2.108%.

The Federal Open Market Committee increased the federal funds rate in December, the fourth increase of 2018. Due to softening growth rates in Europe, Japan, and China, The Fed decided not to raise rates in June and indicated that they are looking closely at market conditions. The consensus among economists and financial advisors is a 25 basis point (0.25%) increase at the July meeting.

Alan Krcmarik reviewed presentation noting sales tax, etc. Council inquired about the downtown and if the increase in sales tax was due to retail or restaurants, to which staff will check into.

JUNE 2019 FINANCIAL REPORT

The Snapshot Report is submitted for City Council review and includes the reporting of the City's revenue and expenditures, including detailed reports on tax revenue and health claims, as of June 30, 2019. Citywide Revenue of \$164.3 million is 34.7% of total annual budget. Sales Tax collections June YTD are 4.1% above June 2018 YTD, and 48.8% of the total annual budget. Building Material Use Tax collections for June are 30.1% below June 2018 YTD, and 32.5% of the total annual budget. Sales and Use Tax collections combined are 48.0% of total annual budget. Citywide total expenditures of \$131.2 million are 44.6% of the total annual budget.
