Derek clarified that if Council planned to put an item like this up to vote, Roger would first like it presented to CFAC. The group agreed and a motion was made and moved to adopt a resolution stating said presentation be given to CFAC prior to any tax rate or policy changes being put to vote. Motion passed 7-0.
