The purpose of this item is to consider an ordinance directing: (1) all mixed loads of construction and demolition discards (C&D debris), AND (2) all mixed loads of single-stream recyclables, to future County-owned sorting facilities, once those facilities are built. At the March 19 Council meeting, Council directed staff to bring back for its consideration, the two flow control proposals referenced above.

PUBLIC COMMENT

ORDINANCE ENACTING A SUPPLEMENTAL BUDGET AND APPROPRIATION TO THE 2019 CITY OF LOVELAND BUDGET FOR TWO TRANSIT BUSES

This ordinance will allow City of Loveland Transit (COLT) to proceed with placing an order for two Gillig 29-foot, low floor transit buses, and authorize the use of an awarded grant funding through the Federal Transit Administration. COLT will be using an option from the contract of the Commonwealth of Virginia to place the order.

The grant revenue equals \$726,000 and the transfer from the Fleet Replacement fund of \$197,000 for a total of \$923,000 will be used to purchase the two buses.

ORDINANCE ENACTING A SUPPLEMENTAL BUDGET AND APPROPRIATION TO THE 2019 CITY OF LOVELAND BUDGET FOR PULLIAM BUILDING PHASE II RENOVATIONS

This item will authorize the expenditure of Pulliam Community Foundation funds, in the amount of \$250,000, via appropriation to the 2019 City budget and enact the ordinance authorizing the supplemental budget and appropriations to the 2019 City budget, thereby funding a change order to the Construction contract for Phase II renovations. City of Loveland will be able to amend the construction contract and will bring before Council a resolution to approve a Change Order to Fransen Pittman for construction work associated with Phase II with second reading of the ordinance.

Phase II renovations of the Pulliam Building Project begins the phase of \$1 for \$1 matching of City funds to Pulliam Community Foundation donations. This ordinance seeks to appropriate the first \$250,000 donated by the Foundation for Phase II renovations. Facilities is planning to leverage existing 2019 appropriation to temporarily cover the City's \$250,000 match in order to fully cover the \$500,000 contract amendment for this project in 2019. The City's \$250,000 match is included in the 2020 Budget (along with an additional \$500,000 match for an additional \$500,000 to be received from the Foundation in 2020).

The City Attorney's Office presently has a contract with outside legal council to assist in the review of oil and gas applications and other oil and gas matters. The city has an application process administered by the Development Services Department with associated fees to cover staff review costs but does not have an additional charge to cover external service contracts. The \$5,500 fee amount proposed would be added as line item under the Executive & Legal Department section of the City fee resolution document to cover legal and other external service contracts.

The first reading of this resolution was heard at the October 1, 2019 City Council meeting where it passed on the consent agenda with a 7-0 vote.

7. REGULAR AGENDA PROCEDURAL INFORMATION

7.1. DEVELOPMENT SERVICES

RESOLUTION ADOPTING THE HIGHWAY 402 CORRIDOR PLAN

The Highway 402 Corridor Plan is the result of a planning process that began in the summer of 2018. Highway 402 is the southern gateway into Loveland, and as such, should give travelers on the corridor a good first impression of Loveland through well planned, thoughtful development. Additionally, improvements to the interchange of I-25 at Highway 402 will likely make this area more attractive to developers. Without a corridor specific policy document developed in collaboration with the community and local government partners, Highway 402 runs the risk of haphazard development patterns that are inappropriate to the area, unattractive and do not function well. This plan was developed with extensive input from community stakeholders, including residents, businesses, large property owners and oil and gas industry representatives, as well as city, county and state government partners.

This plan should be viewed as a comprehensive plan specific to Highway 402 that provides guidance on preferred development types and patterns for the corridor as well as recommendations for implementation of plan objectives and policies.

Jennifer Hewett-Apperson presented this item and reviewed the power point. Ms. Hewett-Apperson noted the six sections of the plan with appendices, guiding principles, information regarding the floodplain and oil and gas impact in the study area. Ms. Hewett-Apperson reviewed the community survey conducted and stakeholder visioning done in October 2018.

Through the community charrette process which was done over three (3) days staff was able to refine the vision of this plan, the plan implementation and long term corridor enhancements with the input of a wide variety of residents..

Council inquired about the Parks and Recreation river corridor plans, to which staff responded that there is a plan out to I-25, and noted that this plan was done in 2014 and it may be time to update. The goal is to go from 287 to the I-25 Corridor.

Council questioned the water and utilities needed for this plan. Staff stated that there are grants aimed at water quality or supply generally, and staff will have to explore grants for this corridor.

Mayor Marsh open public comment

Brian Peterson – Loveland resident– endorsed the plan.

Mayor Marsh closed public comment.

Council expressed concerns that the plan may be short sighted in what the corridor can be in the future, and that the proposed plan does not capitalize on the Big Thompson.

RESOLUTION ADOPTING THE 2020 SCHEDULE OF RATES, CHARGES AND FEES FOR SERVICES PROVIDED BY THE CITY OF LOVELAND, THE STORMWATER ENTERPRISE AND THE WATER AND POWER DEPARTMENT AND SUPERSEDING ALL PRIOR RESOLUTIONS ESTABLISHING SUCH RATES, CHARGES AND FEES, AND ORDINANCES ADOPTING THE 2019 MILL LEVY AND THE 2020 BUDGET FOR THE CITY OF LOVELAND COLORADO

To establish rates, charges, and fees associated with the 2020 City of Loveland budget, to establish the City's 2019 mill levy for property taxes due and payable in 2020 (which remains unchanged over 2018), and to enact the 2020 City of Loveland Budget. The recommended 2020 total appropriations amount for City of Loveland Budget is \$366,352,325, which includes \$37,876,248 in interfund transfers. The Total City Budget is decreasing by \$19.37 million or 5.0%. The General Fund Budget is increasing by \$1.52 million or 1.5%. These recommended appropriations provide for the continuation of services levels with reasonable growth in critical service areas along with the rebuilding of General Fund's 15% Fiscal Contingency Reserve.

Alan Krcmarik, Chief Financial Officer thanked the Citizens Finance Advisory Commission for their work on this budget year. Theresa Wilson, Budget Manager stated that there had been no changes since the study session the 2020 Draft Budget had been presented at.

7.3. NORTHERN COLORADO REGIONAL AIRPORT PUBLIC COMMENT

ORDINANCE ADOPTING THE 2020 BUDGET FOR THE NORTHERN COLORADO REGIONAL AIRPORT; RESOLUTION ADOPTING THE 2020 SCHEDULE OF RATES, CHARGES, AND FEES FOR THE NORTHERN COLORADO REGIONAL AIRPORT AND SUPERSEDING ALL PRIOR RESOLUTIONS ESTABLISHING SUCH RATES, CHARGES AND FEES, EFFECTIVE JANUARY 1, 2020

The Cities of Loveland and Fort Collins jointly own and operate the Northern Colorado Regional Airport. The City of Loveland provides administrative support to the airport through an Intergovernmental Agreement (IGA) with the City of Fort Collins. The airport is within the City of Loveland boundaries thereby receiving a direct financial benefit. As a part of this function City Council approves and appropriates 50% share of the total airport budget, which includes the City's contribution to the 2020 Airport Budget. On August 15, 2019, the Northern Colorado Regional Airport Commission reviewed and recommended for approval, the 2020 Airport Budget to the Loveland and the Fort Collins City Councils.

The recommended 2020 appropriation of \$2,773,890 is \$26,975 or 1.0% higher than the 2019 Adopted Budget. This appropriation level will promote continuation of existing services at the Airport. Self-generated revenues are projected to offset the need for city provided support in 2020 as a result of land lease payments by both cities associated with the construction of the Northern Colorado Law Enforcement Training Center.

Theresa Wilson, Budget Manger, noted the key driver of the increase is Operations & Maintenance.

This is an administrative action. The resolution provides for City Council approval of the Loveland Fire Rescue Authority (LFRA) 2020 Fee Schedule and 2020 Budget.

The resolution provides approval of the LFRA 2020 Fee Schedule as well as the 2020 Budget. Based upon the annual contribution formula set forth in the IGA, the City of Loveland's contribution is \$13,892,025. This amount also is included in the City's 2020 Budget. This contribution amount is a 12.6% increase over the contribution amount provided by the City to the LFRA in 2019.

Staff stated that the increase in the budget is due to 15 new positions added mid-year.

DEVELOPMENT AUTHORITY (DDA)

This ordinance will approve the fiscal year 2020 budget for the Downtown Development Board (DDA). The 2020 budget recommended to Council by the DDA Board is \$87,115. On November 7, 2017, the ballot issue submitted to the voters authorizing the City to incur

debt was approved. State statute requires approval of a budget each fiscal year by the DDA Board and City Council.

The recommended 2020 appropriation of \$87,115 is \$87,115 higher than the \$0 budget adopted for 2019. The DDA receives applicable sales and property tax revenues and is beginning to build a fund balance. In 2018, the DDA received \$57,397 in property taxes and \$63,603 in sales taxes. In 2019, it is estimated that the DDA will receive \$59,344 in property taxes and \$58,746 in sales taxes. In 2020, it is estimated that the DDA will receive \$60,000 in property taxes and \$59,000 in sales taxes. The \$87,115 expenditure in 2020 is programmed for the DDA's contribution to the 4th and Garfield Project. Any additional funding needs will be brought forward via supplemental budget ordinances for City Council consideration at a future point in time.

The 2019 gross mill levy for property taxes paid in 2020 will remain 2.684. No mill levy credit is needed to comply with the State's 5.5% Statutory Property Tax Revenue Limitation per 29-1-301, C.R.S. that applies to the District for 2019 (affecting property taxes paid in 2020).

This item is to change the annual allocation of General Fund monies to the Community Housing Development Fund from 1.25% of the City's net sales tax collected to a fixed amount of \$450,000 in order to improve the Financial Master Plan (General Fund) trajectory for the 2020 Budget and 2021-2029 Forecast, while still meeting the important needs around Community Housing Development.

The result of this change will be reducing the allocation of General Fund monies to the Community Housing Development Fund from 1.25% of the City's net sales tax to a fixed \$450,000, which equates to a reduction of \$175,112 for 2020. An allocation of \$450,000 ensures that currently known projects will be supported through 2022.

This item was presented at the September 10, 2019 Study Session where Council provided direction to reduce the Community Housing Development Allocation from 1.25% of sales tax to a flat \$450,000 annually.

Mayor Marsh opened public comment, to which there was none. Mayor Marsh closed public comment.

This measure will result in an estimated additional amount of \$500,000 in General Fund sales tax revenue.
