APPROVAL OF MINUTES

**ACTION TAKEN: The Minutes were approved as submitted.**

**2. REGULAR AGENDA (Appearance Required)**

SHOW CAUSE HEARING

- A. Miray Corporation dba Bai Tong Thai Cuisine  
Hotel and Restaurant License  
1120 North Lincoln Avenue

This hearing has been continued from the September 19, 2019 meeting, requested by owner Mr. Sunti. The purpose of this hearing is to consider the suspension or revocation of said license for alleged violations by the Licensee; or by any of the agents, servants, or employees of said Licensee, of the provisions of the Colorado Liquor Code, or any of the rules or regulations adopted pursuant thereto

**ACTION TAKEN: Owner Ekawat Sunti appeared before the Authority. A stipulation was approved whereby the Licensee shall serve a suspension of 10 days of its Hotel and Restaurant License. Five days of the suspension shall be held in abeyance for one year under the conditions the licensee does not violate the Colorado Liquor code or Regulations. The remaining five days shall be served as a fine in lieu of active suspension in the amount of \$200.**

REPORT OF CHANGES AND LIQUOR RENEWAL

- B. Barneveldt Inc. dba McGraff's Restaurant  
Hotel and Restaurant License  
1602 East Eisenhower Boulevard

The following applications have been filed: Report of Changes for corporation change in financial interest from Sherry Mehan (50%) and Michael McCarty (50%) to Sherry Mehan (51%) and Chad Miller (49%) and the liquor license renewal.

**ACTION TAKEN:** Co-owners Chad Miller and Sherry Mehan appeared before the Authority. Assistant City Attorney, Emilie Loomis asked Mr. Miller questions relating to his Individual History Record (IHR), specifically question ten about his criminal history. The City has concerns that the application was not completed timely, as well as, the veracity of the application (IHR). The Authority granted the 'Report of Changes' on the condition Mr. Miller amend his IHR with accurate information.

#### SPECIAL EVENT PERMIT

- C. House of Neighborly Services  
1511 East 11<sup>th</sup> Street

An application was filed on August 19, 2019 for 'Fall into Jewels' fundraising event to be held on November 15, 2019 from 5:30 p.m. to 8:30 p.m. The premises was posted with a public notice as required by law.

**ACTION TAKEN:** Event Coordinators Cherri Houle and Cheryl Wong appeared before the Authority. The applicant stated this is the twelfth year for this event and the first ten years had been at hotels; however, the last two years have been at the Life Center without an alcohol permit. The applicants stated they were unaware they needed an alcohol permit and will comply with future events. The Authority was satisfied that the applicant is qualified to hold a liquor permit and the application was approved.

- D. Knights of Columbus Big Thompson Council 3434  
1730 West 12<sup>th</sup> Street

An application was filed on August 29, 2019 for a fundraising event to be held October 19, 2019 from 5:00 p.m. to 10:00 p.m. The premises was posted with a public notice as required by law.

**ACTION TAKEN:** Deputy Grand Knight, Kevin Stinner, appeared before the Authority. No questions from the Assistant City Attorney, and after a few questions from the Authority regarding the service and control of alcohol, the Authority is satisfied the applicant is qualified to hold a liquor permit and the application was approved.

### 3. PUBLIC HEARING – (Posting and Publication required)

#### NEW LICENSE

- A. Mo'Betta Gumbo dba Betta Gumbo  
277 North Lincoln Avenue  
Hotel and Restaurant

An application for a new Hotel and Restaurant license was filed on September 9, 2019 to dispense malt, vinous and, spirituous liquors by the drink for consumption on the premises. The premises was posted with a sign advertising the Public Hearing and notice was published in the Reporter-Herald as the law requires.

**ACTION TAKEN:** Owner H. Clay Caldwell appeared before the Authority. No parties in Interest were present and the application was continued to the November agenda for the applicant to obtain more signatures within the designated boundary for the 'needs and desires' requirement.
