A. Special Event Permit – Northern Colorado Mustang Car Club

- i. A fundraiser to be held at Loveland Sports Park on July 9th, 2022 from 9am to 3pm, the **All-American Car Show** will benefit the Loveland Parks and Rec Foundation, Hearts and Horses, and American Legion Post 2000 Veterans assistance funds.

B. Special Event Permit – Northern Colorado United for Youth

- i. A fundraiser to be held at Discovery Air, 5017 Lindbergh Drive on August 19, 2022 from 6pm to 11:30pm, the annual **Suitcase Party** will benefit CASA of Larimer County, Youth for Christ, and Center for Family Outreach.

C. Modification of Premises – Circle K #2740698

An Application was filed for a Modification of Premises located at 1040 S. Lincoln Ave. The scope of work is complete demolition and rebuild of the store from the ground up. CST Metro LLC filed a complete application on April 21st, 2022 detailing the proposed modification, with construction expected to begin in January 2023. Building Permits and associated inspections are anticipated after approval of the modification to this liquor license.

D. New License – White Groves Barber and Taproom

An Application was filed for a new **Tavern License** by White Groves Barber LLC, d/b/a White Groves Barber and Taproom at 341 E 4th St. in Loveland, 80537. White Groves Barber and Taproom currently holds a Beer and Wine license at the same location. The neighborhood boundaries were designated as: (**NORTH – Eisenhower Blvd. SOUTH – 14th St. SW; EAST – Boise Ave.; and WEST – N. Duffield.**) The premise was posted with a sign advertising the Public Hearing and a notice was published in the Reporter Herald as the law requires.

E. Show Cause Matter – Northern Asian Café Inc. d/b/a Asian Café and Grill

Pursuant to the provisions of Colorado Liquor Regulation 47-302(A), the Local Licensing Authority of the City of Loveland will consider the suspension or revocation of said license for alleged violation by the licensee or by any of the agents, servants, or employees of said licensee of the provisions of the Colorado Liquor Code, or of any of the rules or regulations adopted pursuant thereto.

Evidence concerning the following allegation, together with such other evidence as may be presented concerning other allegations, shall form the basis of any denial of renewal, suspension or revocation of the license:

- i. A significant change to the licensed premise was noted on March 17, 2022 without prior approval by the local or state licensing authorities. The licensee is believed to be in violation of the Colorado Liquor Rules, Regulation 47-302(A): After issuance of a license, the licensee shall make no physical change, alteration, or modification of the licensed premises that materially or substantially alters the licensed premises or the usage of the licensed premises from the latest approved plans and specifications on file with the state and local licensing authorities without application to, and the approval of, the respective licensing authorities.
