# Affordability/Housing

All new housing developments must include low income options. Integrate us!!

Creating more affordable housing (not just apartments and townhomes) for younger generations and creating less 55+ communities.

Life is getting expensive here-we have been here 47 years, first retired and inflation is really hard on set income.

Rental rates in Loveland are too high/almost unaffordable for a single individual.

We retired here, but we may not be able to stay if we are taxed out of our home, which keeps going up in value. That would be good if we were going to sell, but if we want to stay in our home, crazily increased value only raises our taxes and insurance.

Loveland is becoming very unaffordable for the young.

There are very little opportunities for AFFORDABLE home ownership in Loveland.

this city is hard to live in for households with two working parents. there are very few affordable childcare options and even less that offer services for infants. Most young child classes, events and activities are in the middle of the day on weekdays. Then when our kids are school age, the majority of schools in our district are not ranked well, do not get enough funding and are not a priority for the city and it shows. Young families are moving to Loveland, the city needs to start taking note and taking action to support this growing community.

Too expensive to live here and schools not teaching true history anymore. It's getting too "woke."

Wages in Loveland are not keeping up with the cost of housing. I cannot sustain myself in my own home. I have to share housing with a non-family member

We need more \*affordable\* housing for baby boomers \*based\* on their income\*.

I'm facing going homeless because I can't work from a back injury .. there's a lot of us out there...

I think we need affordable housing for even folks w/average way & retirees -> need patio! Homes

Being age 85, disabled with poor vision-1 living in a senior apartment facility, I am excluded from outside contact or concerns. I am dependent on my facility for food apartment maintenances outside senior care expense.

More higher paying jobs to support higher cost of living.

There should be a way to address issues with Hoa that don't enforce what they say they will.

Less HOAs would also be great.

Addressing hunger where kids are involved.

Creating Metro Districts was a big mistake. The City does not have any oversight and the money is not being used for purposes they are supposed to be used for. Property taxes are too high due to Metro Districts. Would rather pay some other way.

I believe there should be a focus on metro districts. It seems unfair that there is no sundown clause on the extra taxation to the metro districts once the basic infrastructure is paid for. They should not pay almost double taxes.

There is too much approval of Metro Districts!

# **City Government**

Increase the human services budget for the city.

Generally, public buildings & infrastructure need substantial, regular maintenance (not just superficial, piecemeal patchwork) to maintain their functional integrity & the value of the original capital investment. It constitutes fiscal mismanagement by the City to initiate new projects or major remodels without budgeting for the corresponding cost of those projects' maintenance for the projected life of those assets. How many times has the City resorted to requesting tax increases or bond initiatives to address the "unanticipated" costs of building/infrastructure maintenance that were, in fact, deferred or inadequate or misrepresented from the start? Realistic costs for proper maintenance of City assets' should be built into the City's budget.

I trust our mayor and some members of city council. I believe others are on a power trip, are rude, and do not have the best interest of the Loveland Community in mind.

I am sick of the city's refusal to deal with the homeless issue, allowing crime, drugs, thefts out of fear of litigation. Your job is to protect the citizens of Loveland and you have failed.

I am concerned that the more programs we have for homeless residents, the more residents from other areas will come to use those programs and the less safe, natural areas we will have. (I watched the homeless situation spiral in Denver, with increasing resources added, resulting in increased homeless population, drug use and crime - no end in sight.)

I do not feel safe at the Parks and downtown with all the homeless

I don't want to take my kids to the parks when there are homeless sleeping on the grass. I don't want to take them downtown because of the homeless. I hate seeing the huge homeless camp on 287 and hwy 14 by river. They should be kicked out by the police please!

I just think that homeless people who live in their car while working a job should be able to park in non busy areas at night or during the day (even behind or next to businesses) as long as they aren't drawing attention to themselves or making the area look bad. These people need a break and shouldn't be told to move when they aren't causing any problems. As long as they park for no more than a night or day as to inconvenience a particular business. But to give them a place to rest when they have nowhere else to go. This includes churches of all places. My son was living in his car during covid and was not allowed to park in the back of a church parking lot during the week. In fact he would sit and read his Bible until he finally fell asleep. Police and businesses and city need to respect that this could be any one of as at any time.

I work as a volunteer for salvation army, the homeless situation is overwhelming.

I would like to know reasons of why there are so many homeless and most businesses are short handed or hiring.

Lots of jobs- out there - but you have to apply - to get one. I have had them tell me - they don't want food if you hand them some they want money- how do you know?

Homelessness is unfortunately a serious problem that has made it likely that we will move. It often feels unsafe as a woman to use many of the paths in town (which are otherwise beautiful and well maintained) because of homeless people camping/ harassment. Similarly, I love all the plangrounds and think they are well maintained and updated, but I have had to leave a couple of times because of homeless people causing them to feel unsafe (most Fairgrounds park). I would love to be able to bike places instead of driving, because the infrastructure is there, but it doesn't feel safe. Also you'll shouldn't just kick homeless outta encampments w/strong other options (shelter/housing/jobs) for them first.

Not wise to enforce no camp ordinances if there is no place the homeless can go.

Our homeless makes our city bad!

Please stop assuming all homeless people in Loveland are residents of northern colorado who no longer have a home to live in. If you talk to them, the VAST majority have shown up here from other states where they were already homeless and came here based on word of mouth information that there is minimal police enforcement of drug use, minimal interference of homeless camps, and a sympathetic city administration + sympathetic population. Please consider this carefully going forward. This is really a problem in Loveland. I have lived here since the mid 1980's and I have never felt uncomfortable/unsafe downtown or anywhere in loveland until the past few years with the growing homeless drifters setting up camp here.

Remove homeless camps along river by our trails - very unsafe.

Residents need to feel safe on trails + neighborhoods. Right now that's not happening!

We'll probably move from downtown in the next couple years just to get away from them. They are ruining this town while we just treat them better and better. A good start for dealing with this would be to ban camping out. As other towns do that it causes more of them to migrate here. No matter how many you "adopt" there will always be more showing up for a handout.

The camping ban is a good first step, but it's important to continue enforcing it after an initial sweep-up. In Boulder, this is exactly what happened: clean up the camps, stop enforcement, and the camps are back up within a month.

Turn the Sidewalks into safe bike lanes and safe from cars.

We need decent sidewalks. It is nearly impossible to get from where we live on far north Loveland to any place along the main thoroughfares such as Garfield down to 34 without meandering all over the place. The sidewalks on Taft by Lake Loveland are especially bad.

The bike lanes in the older parts of town are either nonexistent or so narrow as to be scary when riding in traffic. I would love to ride my bike more for transportation but it is very difficult here as opposed to Fort Collins. The older parts of town on the north end have streets that just dead end into neighborhoods of trailer parks without any indication that they stop before you are at the end. A more cohesive plan for the older (not downtown area) neighborhoods is much needed.

I wanted to sweep downtown sidewalks last winter; my first winter living downtown. The autumn leaves were never completely cleared off the sidewalks on 4th Street downtown.

# Affordability/Housing

Address the rental apartment situation for handicapped and seniors. Some of these rentals are over priced and are dumps.

Affordable accessible housing is essential.

Affordable grocery stores and more diverse grocery stores would be nice too.

Affordable healthcare does not exist in Loveland.

Affordable housing means more density. Quit building low density single family housing.

Affordable housing not new businesses we don't have employees to fill positions

affordable housing to all, older adults, young families and single adults as well as trying to help the homeless find permanent shelter

Also, more small houses that are actual houses beyond down town where it is very expensive. Not everyone needs a 3 bed 2 bath house for 500k.

Giving tax brakes to new businesses and then raising cost to the average citizen, like the Utility bill. I'm a senior citizen but in Loveland the city gives no discount on the Utility bill only a cost increase. I've been to council meetings and spoke, it only went in one ear and out the other. Loveland has 40,000 homes that Utilities tax each month with an average of over \$150 each home, that means thy take in over \$6,000,000. each month just from the home owners, then they tax the business also. So why do they need more money, can't they live on a budget like I have too?

Groceries are insanely expensive and almost impossible to afford. Gas is so expensive I can't even put a full tank because it's well over \$120. Loveland has become such a disappointment, I was born here and I'm really starting to hate it. I need a new car but the car market is insanely expensive and over priced.

higher quality jobs and affordable housing are the strongest needs for Loveland

Houses are so packed together it's disgusting, trying to find affordable house is impossible.

I am 70+,, still working 40+ hours @\$17/hr and rent a room - I can't even afford the "affordable Senior Housing" apartments.....would love to live in a safe/ small house/apt co-opt community in Loveland!! Also, it's really hard to find another job in Loveland - Age And Diversity barriers do exist.

I have informational articles about Metro Districts that I give to people who are looking into moving here and so far they have all decided to move to other communities where such districts are not so readily endorsed. I have also noted that there are new developments in surrounding communities which are now advertising that they will not be having Metro Districts as a major marketing tool.

I love Loveland and living here. I have been here for almost 50 years. I think it would be great to have more affordable living options for seniors, the cost of living is so out of control.

I want to stay in Loveland, but I'm not sure how much longer I can afford to.

I've lived here my entire life and now I can barely afford to make ends meet. I'm a single parent and have no access to help because "I make too much" but after I pay rent I can barely buy groceries and pay the rest of my bills. I don't understand why we're coddling Californians and Texans and changing things to be what they were in the state they left. This is not the Loveland I grew up in.

In would like to see fair housing for everyone. I recently looked for housing for seniors w/mobility issues. I wanted a place that had washer/dryer capability and a kitchen. I'm not in low income range. They have that for low income, which is fantastic, but I could not find this. Can't the same be provided for those who can pay? Sure seems like that's the way it should be.

It is incredible how many people have been displaced since COVID and how extremely expensive it is to have a roof over your head. As a single, DISABLED, parent household who received assistance for rent during this time only to be given 11 days to move into the only apt available (2 bdrm apt from a 4 bdrm house) and to pay well over 2100 a month and I only clear 2600 after taxes and insurance, and not including my other bills, THIS IS INSANELY RIDICULOUS! I am house poor, I don't get child support, I work for the State and still don't make enough. My children and I are crammed into this tiny shithole out of desperation AND I DON'T GET FOOD ASSISTANCE SO GUESS WHAT THIS MEANS??? What are the City officials doing but allowing Property owners to screw us over, rape us financially, displace us, rape us of application fees, etc., all while you sit on your high and mighty mountain because this gouging provides revenue for your precious pocket lining and city bs. HOW DARE YOU? It is a matter of months before my children and I cannot afford this place any longer as with many other people experiencing the same thing. OPEN YOUR FREAKING EYES, SPEAK TO YOUR COMMUNITY, YOUR RESIDENTS, YOUR BREAD AND BUTTER. MONEY ISN'T EVERYTHING, REPUTATION GOES A LONG WAY. PROTECT US FOR GOD'S SAKE!!!

It seems like it is taking the City of Loveland years and years to address the homeless population. There's been too much talking without enough action on housing. The new affordable housing for veterans is wonderful, as is Art Space, but housing is needed for the most vulnerable. Please explore tiny house options.

Loveland desperately needs affordable housing, not everyone wants apartments with all the special amenity's. young people cant afford to get a place to live in a simple apartment complex.

Loveland has always been a beautiful yet affordable place to live. This is no longer true. Even the places that were affordable have been affected by the jump in the economy. I can't afford to live here any longer. There are apartments and housing going up everywhere but how much is low income controlled. The same is true for everyone, the disabled, seniors and families. It's all the same. Very little affordable housing. It's depressing if you live on fixed income like I do because of health reasons.

Loveland needs better resources for seniors: condos with access to outdoors rather than apartment type warehouses AND services accessible by walking

Loveland needs to stop building and take care of the residents it has now. There is no affordable housing in this city anywhere. That is a joke. You are pricing out the natives to Loveland and Colorado.

More affordable housing for the disabled in this community

Mortgages and rent needs to come down. Period.

New Jobs are low paying service jobs, New homes are luxury homes out of reach of working class.

Property tax burden is relatively high especially in development zones.

Property taxes are too high, especially in metropolitan districts.

Senior Housing is Not Readily Addressed. There Non Seniors in Senior Housing. The Housing is handed in a FAIR WAY. There friends and family of some of these managers that get housing long before people who have been on the list for years. There are managers with conflict of interest that is NEVER addressed. Grandparents Raising Grandchildren SHOULD HAVE priority OVER pregnant women who don't know what birth control is. The grandparents are trying to help the children and struggle to find services. I was one of these grandparents. SENIORS, GRAND FAMILIES, HANDICAP AND HOMELESS NEEDS PRIORITY ATTENTION!!!!!

So many people in Loveland are getting pushed out. The cost of housing and inflation are skyrocketing while salaries are staying the same and people can't afford essentials anymore.

Something needs to be done about the excessive growth, traffic, and lack of affordable housing. I want to be able to enjoy living here again but it's hard when you have to work multiple jobs and still can't afford to go anywhere or do anything.

Stop metro districts.

The availability of affordable housing in this area is too low.

The City must also get a handle on the rising cost of housing- HOAs and metro districts must be regulated and held accountable. It's nearly impossible to find a new home in Loveland that is not governed by one of the two.

The city should not tax groceries, especially with the cost today.

The infrastructure is struggling to accommodate the high density population moving into our community.

The major problem I have with Loveland is allowing Metro districts on new homes. This is probably going to be a reason my wife and I when we downsize to either move from Loveland to another city in Colorado or even leave the state.

The metro tax is a joke. Eagle Brook meadows is a terrible representation of what the metro tax is trying to accomplish. We are paying all of this money for terrible craftsmanship and no one is willing to take accountability for their poor performance. Just another loop hole for the citizens to put money into everyone else's pockets but their own.

The push for high density apartments in place of single dwelling homes has greatly altered the tenor or the community even in the short 9 years that I have lived here.

The real estate market is overpriced and the job market is mediocre. We are becoming another California whether we like it or not.

Through my taxes I also pay for low-income housing for families and individuals. I think this is worthwhile, but it should not be abused.

utilities too expensive and no affordable housing considering Loveland jobs pay poorly

We don't necessarily need government affordable housing, as much as smaller houses/lots that are affordable for our young working class.

We need another affordable rec center. Downtown location is overcrowded.

We need more affordable housing for our seniors - one-story housing. Many find themselves leaving Loveland to care for aging relatives because they can't find affordable, appropriate (ranch style) housing here.

Work toward lowering cost of housing.

You also need to get real about development and stop being over dependent on single family housing style. The only way to address affordability is to promote greater density and to promote better transit.

You need to work on your zoning laws. You allowed a Dollar General to be built next to a trailer park (off Wilson). Why couldn't you just add more homes? You have some sort of mixed business building being built next to a trailer park (by the Walmart off 287 heading to FoCo). Do you have something against trailer parks? You may have a lot of NIMBYs, I don't know, but affordable multi-home housing will be needed.

# **City Government**

Need to get rid of "good ole boys" club with city council and look out for residents not the big developers

1) Survey longer than necessary; might depress response rate. 2) No questions directly related to corruption of elected officials - their relations with developers. Survey steered clear of this essential matter - does not inspire my trust.

7 out of the 9 on the City Council are rude, controlling and clearly not listening to the residents of Loveland.

It is extremely concerning that after many citizens stood before the council or submitted concerns via email, and asked for assistance and review, that both of the Ward Four City Councilmen (Overcast and Mallo) voted AGAINST a review of fracking concerns in the Boyd Lake and Centerra areas of Loveland. The other councilmen agreed to NOT review the community's fracking concerns. I have yet to talk with one neighbor, voter/constituent who supports fracking in their neighborhood; so who did the rest of the council represent in that vote? Mayor Marsh and Councilwoman Andrea Samson requested greater panel review by experts, both pro and con, regarding fracking but were outvoted by both councilmen in ward four, along with the remainder of city council. How can you support the fracking plans without study and without update to our city COGCC regulations? Regardless of on which side of the issue we sit, questions remain about fracking regarding the health and safety of current and future generations of Loveland residents. Please educate, rethink and vote for a moratorium on fracking.

We have air pollution problems, potential future water problems, horrendous traffic problems, downtown parking problems, yet this city council has never saw a housing or business development project they can say no to or not throw taxpayer dollars at or tax reductions to the builders. They give way to much authority to some of the commissions (planning, housing and development, to make decisions to spend taxpayer money or waive rules for traffic lights etc.) that should be made by our elected officials and not bureaucrats. Our current city council needs courses in human relations and courtesy. All should be recalled an banned from ever running for any office in the county or city again!

We moved out of town proper last year. I could not be happier. However, as property owners within city limits, these issues do resonate. Surrounding communities don't have the very public problems Loveland does. Why is that? Looking at you, Steve Adams and your gang of bullies on city council.

# **City Services**

2nd Tier is public library, parks and rec, public transportation, bike paths, and natural areas.

3rd tier is everything else, and whether it is provided or continued needs to be considered carefully.

It would be great if recycling could be picked up each week rather than every other week.

On a different topic: I would really like the option of curbside composting--Longmont offers this and we should, too, for a reasonable fee. Loveland's Recycling Center is fantastic; the layout and service is great! stellar recycling programs and staff

We also really need to work on our recycling program. Education would be nice. That and finding more spots to drop off glass, driving out to Kroh Park is not ideal at all. Will the one by Dollar Tree return??

Also, the City needs to find more places for the glass recycling, All the yellow bins are too far from where we live and we live in town.

Appreciate Home Watch, Chilson Center, Library, Open Spaces.

As a tax paying residents I don't think we should have to pay for full admission to our art museum.

I enjoy that there is always something to do or somewhere to go in Loveland. My favorites are the natural areas, Big Thompson river trail, delicious restaurants, and free live music. I also really enjoyed the Sculpture Quests.

I know for a fact that the City's IT department has had major outages that have disrupted services on a recurring basis. I have heard that City IT is poorly managed and funded. Society runs on technology; the city can't move forward if it is hindered by repeated outages.

I think Loveland is a good place to live with good utilities service and arts and recreational opportunities. I love the trails and parks.

I was born and raised here. I love my city. I LOVE the new parks and the library and civic center. I love the nature trails and bike trails and access to natural beauty (though I'd love to see more, and see them connect more for safe bike travel). I love our community events.

In general, I expect the city to provide quality public safety (police, fire prevention/response, building inspection & planning), streets in good repair, reliable and quality utilities at a reasonable rate (water, electricity, waste management)

Loveland Open Lands, parks, rec center, fire department, city utilities, library are all huge positives for our community.

We love the library programs, recreation programs, family centric events, arts and community togetherness opportunities! Thank you so much for making Loveland a lovely place to live!

# **City Utilities/Sustainability**

I would love to see our city aggressively embrace changes that will have us ready for climate change, energy independence, and cheap and safe transportation. I want us to be a leader for surrounding cities, not a follower. That alone will drive people to move here, and improve our economic standing.

Also concerned that there is no incentive or encouragement to homeowners to replace lawns with drought tolerant, native plants or for developers to be mindful of reducing water use in their planning. For example, there is a lot of water-thirsty grass being planted in median strips along Boyd Lake Drive. We are in a major drought why isn't the city doing more to encourage water conservation. CO is in a major, ongoing drought! So what is the City of Loveland actually doing to address climate crisis?

Great neighborhood, but the city came in and destroyed the sidewalks and yards without the owners approval to put forth new infrastructure for cyber optics and disabled sidewalks....HUGE lack of communication and using 3rd parties that came in and left great paint messes on side walks that are still there and brought huge equipment onto our property...thus denting/lowering our front yard and destroying lawn sprinklers and other areas of our grass. No accountability for care or cleanup. I called the city to have them come clean one area of our sidewalk for the disability work...which they came and tried to clean up as best they could but then fiber optics came and spray painted other areas on our sidewalk that are now permanent. So sad to see the City and their lack of care or concern for this side of town. Please help us and care for us as you have been doing for the east side of Loveland

Housing prices are out of control as is my City of Loveland bill. I am paying \$200 a month for electricity for an apartment. This is the most expensive and over inflated place I have ever lived.

I am disappointed in how expensive the utilities have become in the last few years. I understand a gradual increase but this is ridiculous! People are struggling and I feel like the city is taking advantage.

I am very disappointed in the "lack of interest" the city has in supporting solar power for our homes. We are very behind all the communities surrounding Loveland. We need higher by backs for KWH and the ability to bank our KWH. Something isn't right, and I think the city needs to take a serious look at those who are dragging their feet. It almost makes one believe that there is something crooked going on in keeping solar out of Loveland.

I feel the city should implement more sustainable development requirements and recommendations in the areas of energy use, water use (both internal and landscaping), and low water/xeric landscaping requirements for developers.

I realize you need money to provide services but the cost of utilities is so high its hard to keep utilities on and still buy food or medicine. As a person getting ready to retire, I am looking at what I will have to stop doing in order to pay for my food and medicine.

I think the Water Meter Department does a great job in taking care of our needs in the Community. I have spoken with Collin Martin on several occasions and your fortunate to have him with the city.

I truly wish that developers would be required to install solar panels on every new home and to xeriscape.

I wish Pulse was available in our area. But maybe if we can buy another home that area would have access.

I would like to see more incentive for xeriscaping.

I would like to see the power lines buried (along with all the Pulse work). I don't want a 3rd 50-year plan

I'm tired of having to cut down all the old/big trees. The city mutilates hundreds of trees every year and then claims to be a Tree City.

It is essential we address climate change, even if on a very local level. Provide incentives for xeriscaping front yards, putting up solar panels, reducing water usage, etc.

It will be nice to have the Pulse in my neighborhood

Love Pulse

Loveland needs to protect/own water rights for residents. Loveland needs to protect natural resources, fresh water, clean air. Loveland must support renewable energy, not harmful fracking.

Loveland needs to recognize the danger that climate change poses to the community and structure its policy decisions around fairly and equitably mitigating that danger.

Many of my "don't know" answers are a reflection of being fairly new to the community and spending two years pretty isolated because of Covid. I choose Loveland for my retirement. I have not been disappointed. I do think with our dry conditions Loveland spends a lot of valuable water trying to get trees to grow in neighborhoods that have been prairie historically. My HOA has spent thousands of dollars replacing trees that just don't grow in the soil and water conditions here. Yet, the city requires this effort. Water usage needs to be more critically evacuated in this area. Thank you for all you do!

My tap water has such a strong chlorine taste I don't drink water from the tap, I filter it.

Namaqua Hills Area should be included in New city internet pulse as well as trash. Quite ridiculous that I voted for Pulse and yet it is unavailable on my area. Make zero sense the the city does not support trash services in Namaqua Hills Area.

Pulse is a bloated over budget under delivering "service of government that was never voted on. The city has done so much to betray voters confidence, dump this money pit and work with private industry. You created a poor solution to a problem that didn't exist.

Solar power should count for more

Still waiting on fiber internet

Stop approving developments with Kentucky blue grass. We cant keep watering lawns

Stop relying on the citizens of Loveland to keep bailing out the city by charging us to deal with the city's incompetence. The last example of this is the clean up after the flooding. The flood happened in 2013 and it is now 2022 and now you decide to fix up the area so it can't flood that way again and charge the residents with the bill. It should have happened years before now (when supplies where less expensive) and the city should have figured out a way to take care of the situation.

The city should do more to address environmental issues, such as air quality and water use. I am disappointed that there are few, if any, questions in this survey about environmental issues.

The pace of internet (Pulse) rollout is beyond unacceptably slow. I live in old town near Westside Park and it is still not available to me.

The rate of utilities is criminal.... The increase it completely unreasonable

The transparency for the new fiber optic infrastructure is abhorrent. The underground cables went in November of 2022 and still are not connected and City will give no information on when they will be in our neighborhood. It is an eye sore.

The way water billing is conducted isn't transparent and doesn't promote water conservation due to the rounding.

We need to encourage communities to reduce watering grass and replace areas w xeriscape plants.

What is the city doing to address the risks of climate change (fire, flood, heat) and air and water pollution to citizens? Are building codes changing to improve efficiency and reduce emissions? Are we gearing up to meet demand for EV recharging?

Why are the Pulse trucks branded (waste of money) and by the way, the Pulse communication is horrible. No one told us there were 7 inch holes being dug in our yards and then left open for weeks. We were told via lame door hanger that came off in the wind, that we all received emails about Pulse being in our neighborhood to dig-nope, never got the email. I'm even on the Pulse notification list- have never received any communication.

## **Code Enforcement and Compliance/Noise**

2) As part owner of a greenbelt behind my home (along with the owners of five other homes), it is disappointing that the city has failed to provide adequate maintenance for Dry Creek that runs through the greenbelt that abuts N Taft Ave between W 43rd St and W 45th St. Attention has been limited to mowing and a bit of weed control. That's the extent of the city's address of its responsibility to maintain Dry Creek and footage along its sides. There has been over the past five years during my residence no attention to the creek's banks that are literally falling in nor to the growth of vegetation that obstructs the water's flow. Other owners of longer standing say there have been promises, but never action to secure the banks and address other concerns.

Alley maintenance is very poor. Zero maintenance last year and so far, none this year.

Also, weed enforcement seems arbitrary and overzealous.

Businesses are not maintaining landscaping, making things look run down.

Cars being parked on roads more than 72 hours should be enforced and have stipulations that a cat should be moved more than 50 feet to be considered moved. So many neighborhood roads have cars that don't move for months making areas look trashy.

City of Loveland, department of safety must act and enforce the safety of sidewalks, let the homeowners know their responsibilities to make sure their trees and bushes does not block the side walks. Specially south Wilson Ave between 1st street and 14 sw (southbound)I called few times and made complain last year, but I haven't seen city enforce the safety of pedestrians by making homeowners to be responsible.

City/County/State/ Fed regulations need to be re-vamped re: land use and housing to focus on tiny homes, multi-unit and co-op communities, NOT single home mansions, there are enough of them. Tax upper income homeowners to benefit the less fortunate communities.

Homes in neighborhoods that don't have n HOA are trashy, allowed to let weeds grow in yards, making overall appearance of older neighborhoods undesirable & lowering overall quality of Loveland

I first lived here in the 70s, my family has lived here from the mid 60s to the mid-80s and it's sad to see people leaving their garbage containers in front of the garage ,beside their house or wherever it's convenient to park them.

I have owned a home before in west Loveland and felt harassed just for having an extra vehicle on my property in the driveway that was not registered, in a non HOA neighborhood. Seemed like Loveland will enforce codes on some but not all.

I live on city's edge. Please ban all unsanctioned fireworks for safety and animals' (humans too) sake.

I see no question about quality of life in Loveland. Noise and light pollution are out of control here. I constantly hear motorcycles and trucks with loud modified exhausts, sometimes a mile or more away and no enforcement of already existing laws. You can't see the stars from some areas in town and daylight LED lights everywhere. I do see some dark sky streetlights but not in some of the new residential areas. Why are they not required?

I would like to see a plan to address light pollution in Loveland

I would like to see an improvement in city code enforcement, street maintenance and cleanliness. Especially, in the neighborhood between Madison and Boise Ave. I feel this area is neglected by the city. This would include quarterly if not monthly street sweepings and timely snow removal.

I'm confused about zoning rules if there are any. I lived in a nice residential neighborhood until a huge Dollar General was allowed into the middle of it. Now there's increased traffic, floodlights on all night and my view of the mountains is gone. It seems the city cares more for commercialization than the quality of living for residents and their homes.

Improve how the entries in town look, many are very sad. Other towns do much better.

It's also upsetting to see people parking their RVs trailers, boats what have you in their driveway, beside their house and wherever that's convenient too. It would be nice if there were some codes drawn up regarding these issues and enforced, there used to be codes covering this in many areas, but they apparently fell by the wayside.

Loveland has become very filthy over the years. I have lived in Loveland for about 45 yrs. and it has gotten worse.

Maintenance of streets and roundabouts the weeds are out of control. We live in a beautiful city but our streets look very messy and unkept.

No noise ordinance enforcement. Frequently very loud motorcycles traveling well over the speed limit on SE 4th between St Louis and Madison. There is a senior building right next to the street! I

Parking of junk or unused vehicles on street or property.

Please ban fireworks and firework sales for public use! The shows the city puts on is great and fun for the community. It's the fireworks, people use at their homes that are a nuisance, dangerous and extremely hard on animals. I know some people will still buy illegal fireworks and use them. But the city of Fort Collins started a new program last year to help law enforcement pin point the use of illegal fireworks and I was only sad to hear Loveland wasn't apart of this. Ban all fireworks and the sale of fireworks and focus the appeal of the fun shows arranged/provided by the city.

Please consider rethinking zoning laws and development in the city to allow for more dense and livable areas and neighborhoods to reduce reliance on cars and to help promote greater sense of community.

The lack of enforcement on the noise ordinance issue alone (because it makes life here miserable for a solid month) has colored my view of the Loveland PD, which I used to hold in high regard. Please don't let use become another Fort Collins (though in Fort Collins they tend to enforce the fireworks laws). I chose Loveland because it's NOT Fort Collins.

The noise ordinances aren't enforced in all but the most expensive neighborhoods, and panhandling has kept me out of downtown for 2 years now. On and around the Fourth of July, my neighborhood and others sound and look like war zones for HOURS on end (nonstop), and nothing is ever done. Literally nothing---ever. If the laws have changed and M-80s and rockets shooting 200 feet in the air are now legal, please let us know.

There is an issue with weeding, and street cleanup.

We are very frustrated when we drive around Loveland and see businesses that are not keeping up their landscaping, weeds are taking over, or grass is completely dead. These businesses need to be fined and held accountable. This makes our city look trashy!!

We moved here almost 2yrs ago and love our west side neighborhood. However, it is the noisiest and brightest place I've ever lived! The conductors honk the train horns incessantly (very loud, long duration, and frequently). The noise ordinance sign entering town off Highway 287 at Taco Johns is irrelevant because of the excessive loud train noise that occurs any time of day or night and is not a very friendly wake up alarm. The LED lighting retrofit the city did recently in the 4th and 5th street historic district unfortunately has created unnecessarily brighter lights and light pollution into neighbor's yard, houses and through windows. Not all LED lights are created equal and there is research to show that brighter is not better, and some LED actually causes more sky glow and negatively impacts the quality of the dark night sky, wildlife, and human health. The Governor of Colorado just passed a resolution designating June as Dark Sky Month. https://www.darksky.org/5-reasonswhy-june-is-a-big-month-for-dark-skies-in-colorado/. It would be great if the city could reduce the light pollution in residential areas, and especially the 4th and 5th street historic districts. The light pollution negatively impacts the sense of place, look and feel of the historic setting. Some options to help do this include: 1) installing full cut-off shielding on the LED light fixtures, 2) installing sensors so the lights only come on when triggered by a car or people walking by, 3) retrofitting the LED with warmer amber lights that are 2,700k (right now the light are bright white - the type of artificial light that impacts human health and night skies the most), and 4) dimmable street lights. Below are some resources that could help the city improve the quality of life by reducing artificial light at night impacts on it's residents and wildlife. Weed control and maintenance of center medians and street sidewalks is awful. The way our streets look compared with other communities is not good. Given the sales taxes added to every service provided by the city more can be done.

What happened to weed enforcement on private/vacant land and making sure there is clear visibility at neighborhood intersections?

Zoning that incorporates city and county land together is a problem because enforcement issues are different. My county neighbors are out of control — noise levels, pollution, dogs barking, weeds.

Fireworks for Independence Day? All the police officers had to do was hang around Lake Loveland because the people north of Safeway and all over were lighting illegal ones in the air for over a week. There's lot of money for the city right there, I'll be curious to see how many firework fines the city wrote.

I feel that the police do nothing to enforce the noise ordinance. People are allowed to make as much noise as possible with their vehicles, particularly diesels and motorcycles, without any consequence. Concerns about noise pollution should have been part of this survey.

Please take action to address the noise from train horns (e.g., silent crossings, etc.)

#### Downtown

The downtown "renovation", by the way, is a great plus for Loveland and has helped make downtown more vibrant and welcoming. our parks, trails, and recreation areas are very, very good. and continue to grow. Thank you Loveland!

Better support of small businesses in downtown. It's too expensive for them to survive.

continued development of downtown efforts started by the original DDA

downtown is a nice place to visit

Downtown Loveland is a disgrace for its dirtiness and it can be just plain scary even in the daytime to visit Police no longer seem to patrol down there. It is not a great destination for shopping or activities. I wish it could be, it has potential. Downtown is the low spot of this community. Housing looks so nice as they develop but who would want to really move in there, especially when it is so unsafe. You would not dare go out for a walk down there at night, I have actually seen homeless people fighting and literally screaming profanities at each other. I would not choose to go downtown to dine or to a movie, especially at night.

Get rid of the parking barriers creating dinning space, we need parking not more dining 6 hr a week.

I encourage you to keep funding the downtown improvements, it is really making a difference. The Foundry has been a lot of fun. And, I don't care what the goofy wackadoodles say about Sprouts...that was a good deal on an otherwise dumpy corner.

I feel like downtown has been neglected in favor of the foundry and moving events to the fairgrounds and other locations.

I like the businesses that have been added to the downtown area within the past year! I really hope that Loveland provides more parking spaces so that 4th can be turned into a walking mall with outside sitting areas.

I like the outdoor dining in the summer and fall in the streets, but limit restaurants to only in front of their bldg.

I love the summer patio program that some of the restaurants do. It would be wonderful to close down 4th street to traffic and make it pedestrian friendly like Pearl St. in Boulder! There could be more of a variety of shops downtown. There are quite a lot of antique shops.

Keep investing in downtown! It's the best thing happening in the city.

Loveland has done a good job revitalizing downtown. It would be nice to see more revitalization of the east side of 4th street.

Number Two issue to address is bringing quality and diversity of retail to the old downtown area - food, goods and services.

One of our major concerns with the city of Loveland is the tired, dirty an unappealing look of the downtown area. With the addition of the concrete barriers for outdoor dining the look has only gotten worse. Although we use and appreciate the parking garage the loss of the parking spaces makes downtown even less of a destination for us. Adding a sculpture or two is not a way to really beautify the area. How about washing the sidewalks and streets at least once a week. The planters are helpful but who can see the concrete container that blends with the rest of the grey? Time for downtown to do a major face lift i.e.: paint on trim and doors. Get the planters planted earlier in brighter colors.

Please please work on downtown. It could be such a great place, but empty rundown store fronts hurt us all. We need new restaurants and shops, and more engagement opportunities.

There are those of us that feel the older area in down town is being neglected and left out and the focus has become the new areas in Loveland are the focus and being given priority. This includes repairs, internet and other improvements.

We are relatively new to Loveland, we've been here about 1.5 years from Austin, TX. Loveland is a lovely little town, I think we still need to keep revitalizing downtown, but for some reason Loveland has a not a great reputation among it's "peer" cities. I think more focusing on beautifying and revitalizing downtown. Especially like abandoned factories/warehouses, etc. They are an eyesore.

We've like to see some renovation of cleanup of the business area in downtown Loveland and would love to see more great restaurants and stores come to fill in the run down and empty business spots especially on 4th street.

What if two blocks were closed off (between Lincoln and Railroad) and made into a pedestrians only area, similar to Pearl Street Mall in Boulder? Pedestrians are not "welcome" in Loveland, esp. the downtown area. We are more like moving targets for jerks in SUVS and trucks.

While I feel somewhat safe downtown during the day, I feel unsafe at night.

# **Economic Development/Planning/Growth/Building**

2.Overall this is a good town to live in still, but when we moved here in 2010 it still had the "small town" feel we loved. Now it is growing too big and too rapidly to support all the growth. The support systems, ESPECIALLY the roads, can not keep up with the growth. The roads are way too congested, especially the main arteries (Eisenhower, Taft, etc.)! Roundabouts do not take care of the problem. We really need to relook at the "Grand Plan" that has been in place forever. We do support a healthy economy, but sometimes feel our city leaders are only concerned with building more and more housing communities, (not the ones being built for the poor) and not necessarily encouraging more businesses to move and work here and downtown.

3 households of my relatives recently moved (to Longmont/Berthoud) and all said NO WAY to Loveland because it looks dirty and dumpy. I agree with them. Wish improvements could be made to make it more appealing, especially hwy 34.

34 and it's empty businesses (old ford dealership, empty old 7-11, primarily from Boise to 287. Looks dilapidated and sad.

Allowing all the growth especially around Hwy34 and I25 without making the big developers upgrade the road system. The traffic in Loveland keeps getting worse because of all the apartments, condos, etc. being built in this area. Also the traffic on Hwy402 continues to get worse. It needs to be upgraded to 4 lanes. Shutting down 1st street for a year doesn't help.

Also having enough water is becoming an issue but city council just keeps approving more and more housing developments. It's time to take a step back and figure out how to fix the mess that has been made.

Also need 1-2 large employers to draw a larger tax base.

And stop allowing all of the building it is also out of control, traffic is horrible, there is severe water shortage, and the grocery stores are packed.

Build walkable mixed use neighborhoods. Just look at downtown, it's thriving because it's mixed use. Downtown is the best thing going for Loveland right now. Keep that going!

City planning must approve another grocery store in town.

City planning needs to keep up with the growth of Loveland while preserving a good quality of life for those who currently live here. Poor decisions on timing of road repair, recognizing zoning issues, water quality and air quality.

Could the City also contemplate re-developing the areas along the Hwy 34 corridor? Perhaps the city could buy the old Ford dealership, some of the seedy little businesses along 34, and the old vacant City Market store that has been empty for 20 years and get those areas properly developed? Restaurants would be so nice, and to have more shops to go to along there. It would be a great way to snag the tourists coming thru as well as they head up to the Park.

Curb city growth. Loveland doesn't have to keep growing and straining at the seems just for the sake of tax dollar increases. Traffic, crowding and pollution are at insane levels. Why it the city constantly focused on growth. We can't even manage what we already have built. Work on infrastructure and efficiency. If that means there isn't room for just anyone to move in them so be it.

Development - residential and commercial appears to be hap hazard, disconnected and poorly planned.

East Eisenhower from Lincoln west to Denver avenue is an absolute embarrassment. Makes Loveland look incredibly trashy. Start encouraging re-use of these abandoned areas with incentives versus giving tax money to developers to develop brand new areas further and further out. If the abandoned, rundown buildings are allowed to co to us to degrade, no one in their right mind will drive through town and think they should visit/work/live here. Looks like a crap hole. Policies need to be changed to force developers to put in dramatically improved road systems. It needs to be more expensive to develop in Loveland. If they want to make insane amounts of money off development, then they need to pay much more than they currently do to help alleviate traffic their development will cause.

Efforts need to be made to stop uncontrolled growth!! We can't financially maintain quality services for out of control growth. It decreases the quality of life for everyone except the out of town developers!!!

Encourage more sit-in family restaurants. Slow down condo building.

Enough apartment buildings already!

Give more help to "mom and pop" type businesses.

Growth is too much, downtown is getting scary,

Having grown up in and near Loveland, and now living in Loveland currently as an adult, I have seen how significant growth has impacted our community. While growth is inevitable and not always a negative, it does feel like Loveland is building up every square inch of open space, which saddens me.

Highway 34 is an eye sore from I-25 to the west thru town. Instead of spending so much money on DT, maybe give monetary incentives for businesses in this sector to remodel, update etc. their buildings and grounds.

I am also discouraged about the lack of caring from our city planning. When the dollar general was built across from my house, myself and many neighbors sent emails to many city staffers including the planning department and the mayor. Only to be ignored by EVERY ONE of them. My email alone had eight people on it. Heard back from zero.

I am dismayed that the current city government is content to be a bedroom community for Denver instead of being our own vibrant community. We need attractive jobs and vibrant businesses. I shop and eat in Loveland if at all possible but I see businesses closing and moving to Johnstown.

I am very concerned as I see growing pains occurring and some changes that worry me about the quality of life here as I don't want to see our quality of life go down. Many more people are moving here and growth is a good thing as long as it is managed properly. I am concerned about the crime rate as it seems to be increasing. I am concerned about the traffic as we seem to be packing more cars on our streets and the streets are only so large. Waiting through multiple lights multiple times on Eisenhower all the way from exiting I-25 until you get through the light at 287. We have a vacant building at Eisenhower and Madison that has never been addressed that is an eye sore for our community and now the Ford store has moved and that old building is vacant. I have often wondered why we couldn't get a Whole Foods to move into the vacant building at Eisenhower and Madison as it used to be a grocery store.

I get tired of hearing the old timers lecture about the "small town" feel of Loveland. Loveland isn't a small town, it hasn't been for forty years. We need to start acting like a real City.

I know that the city needs to give incentives to attract business. These incentives should be evaluated by the return on the investment of the taxpayers' money.

I miss the small town feel we used to have. Lived here since 1968

I think the growth needs to be managed and controlled in consideration for our natural resources - open space and wildlife. In particular the open land West of Wilson on the North end of town. Some of that space should be left as open space and not just built up as another neighborhood. Also consider re-zoning the open space West of the solar panels off 22nd. That space could be annexed into the Natural Area at Cascade and 22nd to maintain the nature landscape and wildlife habitat. Our beautiful scenery is one of the best things about Loveland!

I think there is a need for more grocery stores in the Loveland. With all the new housing and new residents in the area the stores cannot stay stocked.

I was born and raised in the town and have always loved it, however, the last 5 - 7 years, I can honestly say that I am not in love with this town anymore. The growth is out of control and we just simply do not have the road systems to handle the explosion of people who have moved here.

I would like to see more effort preserving Loveland's downtown charm. I want much less effort at building McWhinneyville and fracking and everything else that destroys what Loveland has been for over a century just to bring in big money when we already have the building blocks for a thriving economy of local businesses we can be proud of if we would invest more effort into it.

I would like to see the city work harder to preserve the historical architecture of the downtown area. I live in that area and am seeing a lot of ugly additions and the tearing down of old houses to make space for new construction. All this in an area that maintains high prices and desirability. I support economic growth but not at the cost of stripping away beautiful old architecture. There can be a balance. There are a lot of empty store fronts.

I've been a resident of the Loveland/Berthoud communities for 50 years. The more I travel the more I like where I live. Keep us on the right path, grow responsibly, grow your understanding of the needs of aging community members, disabled citizens, those of varying ethnic and religious backgrounds and assure our LGBTQ community members are valued for their contributions. I plan to stay here through my retirement and look forward to all the Loveland offers.

I've lived here 14 years and loved it until recently. The growth is out of control, stressing already stressed infrastructure and the environment. No longer a happy place to live.

Is there any way that when a business moves to a new location the abandoned buildings are maintained?

When I first moved here 15 years ago, Loveland was a lovely place. Things change, always, but Loveland is doing more than changing---it's deteriorating. Several houses down from me is an abandoned house that the owners haven't lived in or rented for at least as long as I've lived here. How is this allowed to go on? That house and the large number of poorly maintained rental houses in my neighborhood have contributed to an increase in noise, a huge increase in cut-through traffic, and more property crime (the old Broken Windows Theory).

Why do grocery stores keep getting built in locations where the need is not priority and in fact directly affects the viability of competition? First Sprouts put a local, family owned grocery store out of business (The Crunchy Grocer) when the Sprouts could have been built in the 25/34 center and now it's happening AGAIN with a Natural Grocer being built literally ACROSS THE STREET from an existing Safeway. Meanwhile, 25/34 remains a food desert where the only easy access is to restaurants and fast food. # **Fracking**

I go out of my way to be kind to everyone in person, on the phone and on the roads. I have never used alcohol or drugs. The rudeness and snobiness amazes me. If I pull out one of my old suits from my days of upper middle class and polish up my appearance, I am suddenly treated nicer. I have been forced through horrible circumstances to use the Food Bank. Every single person there are true gifts to humanity. That is the one place I feel like I am worthy to live another day. My 16 year old granddaughter who I am raising and is the sweetest, kindest young lady who works hard to be a "good person" is treated like a nobody at her school because she's not "from here" and not from the right family. This is from the teachers. Yet, we love Loveland. We love what Loveland could be and what it appears to be. I'm sure it is if your family has been here for generations unless you are Native American of course. If you've made it this far, I hope you understand what I'm saying. I hope these surveys are truly important to you.

With the exception of the main street in downtown Loveland, the city has a very "tired and worn" look - empty buildings, commercial buildings that haven't been kept up and look as if they were built in the 60's and 70's, horrible traffic and horrible traffic signal timing, unsightly medians with weeds and dirt rather than xeriscaped rock beds with native flowers, The last city I lived in, in a neighboring Western state and with the same size population and age of city, had a vibrant dining, shopping, arts, and recreation scene, was so much cleaner and prettier, much more welcoming and diverse, and had a sense of pride by residents.

## Homelessness

I use the bike path quite often and the homeless camping along the path make me very uncomfortable and feel unsafe. Actually, the homeless is a huge problem here and they make me feel unsafe everywhere.

In terms of homelessness, I'd like to see Loveland support in providing individuals a hand up, but limit the handouts. Homeless camps in our public spaces feels unsafe and we have seen crimes committed in our mostly quiet neighborhood by transients, making our neighborhood feel less safe.

What you have created with the homeless problem is a total disgrace, I am embarrassed when we have family from out of state come to visit, I used to be proud of how clean and safe Loveland was, not any more. The clean up of the homeless camps and our town should come from your salary and you should have to go clean up the feces, needles, trash, etc. I can't even go for bike rides with my kids on the our beautiful trails bc of the homeless and fear that we could be attacked. Same on all of you, I hope you are all replaced with people who actually care about Loveland not just pretend to get elected.

I live and ride my handicap bike around the Madison/Boise area, south of Eisenhower. There is a dip in the sidewalk on the east side of Boise Ave, across from Nickel Drive. I always feel like I am taking my life & dog's life in jeopardy as I cross over to the wide sidewalk on the east of Boise. Also, where the bike path crosses over 4th street; a flashing crosswalk sign is imperative there--people can't see you due to the bridge and undergrowth in that area. More enforcement for red light runners. People treat red lights like it means "go faster through the intersection". And, the CFI (continuous flow intersection) on Madison is a nightmare!!Because the city has been soft on homeless people, I as a disabled woman, can't fully enjoy the Park's and bike paths in certain parts of the city, i.e. Fairgrounds park area; the bike path going west between the fairgrounds to the lakes off of 1st street. It makes me angry that I can't enjoy what my taxes help pay for!!

1. Regarding the trust question: I trust my city council person, but the actions of Mr., Overcast and Mr. Fogel which I observed during the few council meeting I have watched on TV were often rude, disrespectful and condescending. 2. I look forward to again using ALL of the city recreational trail. Currently, as a single female bike rider, I am afraid to use the southern portion due to the homeless encampment. 3. Would be nice to have a designated walkway along west 1st St, , especially since the homeowners on Deer Meadow Court disallowed use of a small gate at the end of the street. Overall, I do appreciate living in Loveland, but am ready to "pull up the ladder" so it stops growing!

34 is a major vein from I-25 to RMNP. We are missing opportunities to draw people to stop, shop and recreate. So many stretches of 34 are run down and/or look abandoned. They are a huge eyesore and make me embarrassed when I have visitors in town. Others were built way too close to the road. Attract businesses that will draw people in and advertise their presence when built. Promote the benefits of choosing Loveland as a place to live over Ft. Collins and Johnstown. Instill a sense of Pride !!!! I would be willing to pay higher taxes to have better infrastructure. Require new businesses to keep their properties landscaped. Avelo leaving was a HUGE miss for revenue. For such a big Art culture, we need more of that visible. Murals, community art projects - More community spaces, such as gardens - which could help feed the homeless and soup kitchens. More public planting of trees and green spaces. There is no sense of community from my Area Representative. Loveland has so much potential - and no energy behind it.

#### Address homelessness

Addressing the homeless and addicts in the community is most important.

Also housing for homeless to lessen camping. I don't like feeling sketched out walking a trail when I see a tent or shopping cart near by.

Also, I keep reading on NextDoor about the homeless problem here. Will the city allow the homeless to overtake our TAXPAYER supported parks and open spaces?

And tighten up on homelessness. It's trashing our community.

Approximately in the last 6 years the city of Loveland, its services, it's people and the overall general environment has decayed. The rampant drug use and drug houses in the city is disgusting. Drug use should be eliminated, not encouraged or tolerated. The homeless shipped into Loveland from neighboring communities, towns, cities should not be allowed. Transience coming into the area to move off of our tax dollars is criminal. We have Loveland homeless people that need to receive their communities help. We can't afford to correct the problems from other parts of the country that wind up on our doorstep. Hard working, decent and respectable lovelanders should not have to be burdened with the cost of those that do not wish to contribute to the community in a positive manner. Everyone in life should earn their keep. Loveland as a whole was a much kinder, neighborly, affordable and safer place when I arrived 25 years ago.

Aside from infrastructure and economic health THE NUMBER ONE "big issue" to address that would improve the Loveland community for the next 5 years is the HOMELESS issue (not an easy one for city gov to address)

Better support for victims of domestic abuse should come above support for homeless

Camping bans don't ban homeless they ban homeless people.

Camping bans don't work in my opinion. Studies show the most effective and cheapest way to help unhoused people is providing them with permanent housing with no prerequisites

Camping restrictions should only be enforced if there is a viable alternative for the homeless in Loveland. Otherwise, what are they going to do?

Clean up the homeless problem. I have never felt unsafe until the last few years after living here for 50 years.

Homelessness has become a real problem. Some days I don't recognize the city I moved to 20 years ago. Our business has experienced vandalism. And the homeless camp nearby. It is essential that this issue is dealt with immediately.

Homelessness is a problem and it needs a solution now. My wife and I have six children ranging 10 yrs to 19 yrs and all of them including my wife and I have had negative impacting situations involving the homeless. Homelessness doesn't mean you can be inappropriate, disrespectful to the environment, violent, steal, participate in illegal drugs and other interactions that destroys the fabric of the Loveland community. Mental health is a problem for the homeless, but it is a few not the majority. Make Loveland safe for our kids, please! Homelessness is a serious problem.

Homelessness is an issue and my family no longer feels safe downtown

homelessness is high. other towns have created programs utilizing "tiny homes". I think this type of program should be investigated.

Homelessness is huge issue impacting safety of families at parks and recreation opportunities. We need to tackle it respectfully and 100% or it will get worse.

Homelessness must be addressed. It is not compassionate to let human beings struggling with drug addiction suffer out on their own. They are not "camping". These people have families and we are enabling them. The ban must be enforced immediately. We do not feel safe in public spaces with our children. If it's not resolved within the next year, we plan to move out of Loveland.

I also don't trust the House of Neighborly Service to help people experiencing homelessness or poverty! I don't think their philosophy is compatible with best practices.

I am a 3rd generation Loveland resident. I am proud of my city and the local events and activities. My biggest worries in Loveland are traffic, education and homelessness.

I am more concerned about supporting the families of the homeless. I am an only parent and I have to work overtime to provide for my 2 teenagers because their father decided to bail on them. I think he is homeless. I don't get support or any breaks so I feel that everyone can find their own way. I would like to see mental health assistance for the families of the homeless. I would like to see free trash pickup services for the families of the homeless. How about scholarships for college for families of homeless? If we can provide services to people who don't even try why not provide opportunities to those that are the victims of an adult choosing to be homeless. My focus is on the prevention of future generations to make sure they are supported and get opportunities to not follow in the footsteps of a homeless parent. Give support where support is appreciated.

I am very disappointed with Jackie Marsh and Andrea Samson and the infighting they have caused. The city leadership also tends to be reactive instead of proactive. It would be nice to see the arguing stop at council meetings, and a more solution oriented mindset used to deal with issues that effect us as residents, like eliminating our homeless camps and making policies that discourage homeless to flock to our city.

I appreciate the signs near busy roadways providing information on services for the homeless.

I believe our homeless population is increasing because we are allowing it along with giving our monetary resources...needed in other areas in our community...to the homeless. We need to be a welcoming community to those who are helping themselves and not just waiting for handouts from our city using our hard earned dollars. The citizens of Loveland work hard for their money and their property...a majority of the homeless could as well. Instead a majority of our homeless population are choosing to wait for, and receive, the free resources from our city using taxes that we work hard for to pay! This money needs to be used to help people who support this city by working and paying their taxes.

I can not believe that unauthorized camping means we Don't fix the roads so we can rent motel rooms for the unauthorized peoples. Between the state and local municipalities we spend over \$100,000 per homeless; and growing. You should have nipped this in the butt when you legalized Marijuana. So now you need more money out of my wallet.

I don't feel safe nor do I want to let my kids play outside because of transients and other things that are unsafe.

I feel a homeless person needs to feel empowered and assertive to help themselves, and not be enabled to remain homeless.

I feel the worst of the homeless aren't ones who are from around here. I recognize less than 1/4 of the population from when I was homeless. Offering them permanent housing may be a way of encouraging the ones who don't want to become a part of the community to move on. Also I would recommend offering one on one education on how to keep healthy and be more welcomed. Simple things like don't litter, and clean up after those around you. And things that seem obvious but aren't to many of the newcomers, such as don't leave your poop laying around, if you have to go and you can't find a public bathroom poop in an empty grocery bag and throw it away.

I have a problem with all the pan handlers on every street corner, considering all the Now Hiring signs literally all over town! Instead of giving hand outs to the homeless, help make them employable!

I have been picking up trash (including needles & liquor bottles) on the trail from Washington to the park for the last 3.5 years. Why don't park workers pick up the trash? Nothing has been done about the problem and it keeps getting worse. Your parks and rec guide says no camping or fires in parks and along trails; that is a joke.

I have lived in Loveland 50 yrs. and have seen this town go from a wonderful place to raise a family to a community like a California town. My 3 children graduated from Loveland High going on to get College degrees, today they wouldn't get the education they got in the 70's. I've seen this town grow into another Denver with it 's high rise buildings, taking down buildings downtown so it looks like "Wall Street". Why do you think new is better? With the encouragement of all the growth comes crime, drugs, homelessness, traffic problems all of which you are not prepared to handle. Why not listen to older citizens on ways to improve things, not the new comers who only want to tare down and rebuild in the likes of where they came from, like California.

I have lived in Loveland for almost 20 years along the river corridor. Up until the past few years, I have always felt safe and comfortable using the trails and allowing my kids to use them independently as the have gotten older. I no longer feel safe and comfortable from myself or my family because of the homeless population along the river. I understand why initially through COVID the un-homed people were allowed to stay, but it seems to have gone way passed this. I have witnessed drug use and transactions happening in my neighborhood between some of these people, have experienced horrible smells from them burning trash, and worry about my family, home and property with all of this happening so close to us. (And yes, proper authorities were notified in all of these instances). But, it doesn't help us to feel any safer.

I have volunteered for good charities in the community that provide help to the homeless and those down on their luck. I believe the city should support these charities as they can.

I live along the Big Thompson River and I don't feel safe on my own property because of the homeless population living on the river edge. Theft in the area has increased and they routinely trespass on my property and leave copious amounts of garbage in the trees, which encourages the local black bear population to scrounge for garbage at houses. I encourage the City to address this growing issue so residents can safely use the river walk and Loveland remains a beautiful and safe place to live.

I love the downtown area but the homeless people and panhandlers can make you feel unsafe at times.

I understand that with growth comes crime, but we can't be a 'good place to raise a family' when used needles litter parks and families are harassed by homeless people at the library and you don't feel safe walking/running/biking on our trails because of the encampment. Most of my answers are not related to the amenities themselves, because I think the city has done well with providing access to a lot of things neighboring communities have. I'm bitter that my tax dollars are going to things to improve our community but I don't feel safe enjoying those things. I'm a native, born at McKee and haven't changed zip codes once. I'm sad to see this city decline so severely, but if the transient issue isn't addressed soon, my family will be moving to a safer city.

I was in support of the Supportive Housing project that is planned for the empty lot next to the police department until the recent change to accept drug users. I have a lot of concerns about inviting drug users, especially people addicted to fentanyl and meth, to live in our neighborhood. I do hope that the services at the supportive housing facility along with the influence of the police next door will keep violent and/or dangerous behavior from spilling into our neighborhood. A close friend of mine was in San Francisco last month and a man threw a brick baseball-pitch style into the back of her head. The problems in San Fran are a result of laws (and/or politicians) that disempower police, empower criminals and drug users and endanger everyone in or visiting that community. I sincerely hope that Loveland can avoid going down that path but I worry about that when I find out that drug users will be invited to live in our neighborhood.

I wish the trail system on the south side of town near the river was safer for walkers.

I worry about the way we treat (or don't treat) our homeless and mentally ill.

I would like to see the City address homelessness in a way other than offering free services. I work in Longmont and see how the homeless have overrun the community and City Council.

If we continue to just provide for the homeless community and not try to resolve the reasons for homelessness, we are only creating a place where more and more people will come. If we give a man a fish, his expectation is we will just give it to him every time there's a need, never for him to learn to be self sufficient or to give back. There are plenty of opportunities for people to be a part of community and invest time and energy to make this community a nice place to live. There's a reasonable expectation that everyone does their part with whatever they can.

It is NOT the city's responsibility to help the homeless by storing belongings and giving them places to live. It IS the city's responsibility to enforce camping bans.

It was a huge mistake for the city of Loveland to take over the homeless needs that had been provided by HNS. This will only exacerbate the homelessness problem. HNS works to bring people up and out of homelessness. The city will just keep them oppressed.

Keep homeless out of city and county facilities if they are loitering.

Keep open spaces, Parks, and neighborhoods free of homeless encampments, drug dealing, violence, and harassment of citizens.

Love the arts but with the homeless situation and need for better commercial development planning and public transportation maybe less money should go towards art and sculptures and more to quality of life improvements for the city. Maybe we can afford both but it seems like the priority is art and not the living conditions for citizens. I'd love to retire here but not settled on that yet.

Loveland has a homeless & vagrancy problem. Lack of a shelter & affordable housing is making it worse.

Loveland has changed, the amount of homelessness and crime is increasing. No easy answers but something that would prompt me to leave if it isn't addressed. I know most homeless don't want help so it is hard but they should have consequences for breaking the law. In general the liberal practices around homeless people are failing. I am very moderate but this issue makes me think we need stricter policies and laws.

Loveland is heading in the wrong direction. You can not raise a family here because it has become to expensive and no money is actually put into the school system. Loveland is turning into a mini Denver you are either rich or homeless.

Loveland is known around the country as the place to go if you are homeless. I do not want more homeless people here. They are moving here from all parts of the country because the city caters to them. I am very unhappy about the housing going in across from the police department and I will no longer feel safe walking around the neighborhood. I work very hard and I pay a lot towards taxes and I want my money to benefit my family, not to benefit a homeless person who refuses to work and is addicted to drugs and does nothing to change their life. There has been a homeless person sleeping in a tent on the Marianna butte golf course. I do not feel safe in my seemingly safe neighborhood with homeless people around who will steal my property so they can buy alcohol and drugs. No thanks. If I wanted that I would go back to Greeley.

Loveland needs a homeless shelter. Loveland's homeless services are extremely poor compared to other cities.

Loveland needs to address the homeless issue, they are stalking, harassing and stealing from residents and turning public spaces into putrid refuges of waste and garbage.

Mental Health services/workers in downtown where the transient population loiter and are in crisis daily.

More attention needs to be paid to parks focused toward children in order to prevent "naked runners"; predators, etc. at these places. We stopped frequenting some places because they just aren't safe even during the day (Fairgrounds Park in particular).

More enforcement to rid the community of people who choose a lifestyle that takes advantage of the rest of the community. They are not homeless people in need of help. They are making a choice.

Most homelessness is by choice, a way of life, so to speak. I worked "in field" for the City for 30 years and observed one thing they all have in common: They completely trash any area they wind up in, whether it be downtown alleys, under bridges, or the natural area. You would think with nothing to do they could clean up after themselves. For services provided by the City they should be required to perform assistance in maintenance of parks, downtown areas, or other community services. Problem is most would refuse to do it. Area residents are generally a very "giving" group and they depend on this for their livelihood, so it's never going to magically go away.

Most of my feelings of being "unsafe" are due to the homeless people on streets, in parks (particularly fairgrounds park), and camping in fields. I wish we had more enforcement of no camping, and getting the naked and high homeless people out of the park where I like to go with my son. The homeless are overrunning this town and it makes me want to leave.

Most of the homeless have mental health problems. Create some sturdy tiny homes which have heat and cooling and security so they are safe too.

My greatest concern in Loveland is the homeless population and the impact it has on the environment and access to public space and services. We do not access some trails due to encampments and the threat of violence as well as unclean conditions including human waste and drug paraphernalia. While much of downtown Loveland is a place we frequent, driving through downtown can be dangerous with homeless individuals experiencing a crisis just walking out in front of moving vehicles. It is unsafe for all involved. Allowing the homeless population to continue to grow is not the answer nor is spending significant resources to house individuals that view homelessness as a right and a lifestyle. While there are some that need assistance getting on their feet, that is not the case for many. I would like to see city resources funneled to individuals genuinely working to improve their situation and not just looking for free handouts.

My opinion is that the more we "help" the homeless, the more they will come. many do not want help from government.

My top concerns are property and other crime, traffic issues (specifically the speeding on 29th by schools and along neighborhood streets), and finally control of homeless camps.

Need to address lack of mental health and addiction resources. Most of property crime and homelessness is tied to lack of these resources.

Need to find balance of homeless services as not to create a destination.

Newcomers are pricing out long term residents. I cannot enjoy walking the trails due to entitled bike riders and homeless people.

No camping. The homeless are out of control. Besides Longmont and Denver Loveland is right in the top three with so many. Time to do something as other cities don't have this problem like we do.

Not sure if the answer for homeless population, when I volunteered at our local shelter it seemed to be a choice for many, despite lots of resources available to them. I do worry excessive assistance will attract more to the area, burdening an already thinned budget.

Open mental health facilities and make vagrancy and panhandling a crime again. These things will end homelessness.

Our city is less safe and appealing now than it was a decade ago, primarily due to the transient population and the lack of work done to enforce the laws on these individuals

Our parks and downtown areas would feel safer to me if the homeless situation was under control. I no longer walk anywhere near the river, and I really dislike being in the downtown area especially at night.

Our parks, trails, and open spaces must be cleaned up and free of homeless encampments.

Our town will be disgusting if we don't fix the overgrowth of population and homelessness.

Overall Loveland is a great place to live. It has grown considerably in the 10 years since moving here and the growth is a concern with increased crime, homelessness etc.

Overall we think that Loveland is fantastic and we love living here. Biggest problem is homelessness, which is very complicated and not easy to solve. But Loveland needs to work on this in spite of the complexity.

Panhandling is present on corners.

Permanent housing should be developed; public shelter discouraged. Look at Houston model.

Persuade the homeless to go somewhere else, quit encouraging them to come here, killing business and making us fell unsafe with all the theft and other crimes they are doing to us. Not my tax dollars to fund their laziness.

I am a single mom of 2 kids that live downtown and they are making the area unsafe, leave garbage all over, camp and poop in residential building stairwells and use drugs wherever they want. I never see the police unless they're driving around. I would encourage "community policing" and maybe visit the idea of having them actually walk the streets downtown and engage the community members and businesses. The homeless are literally murdering each other in broad daylight and my children have to see this. It's beyond unacceptable! I am regularly harassed at the grocery store for money and food in the parking lot. I have lived in Loveland for 11 years and am looking forward to getting out simply to escape the homeless invasion.

Please enforce the no camping ban. I regularly ride my bike on the Loveland trail system and there are more and more tents and camp sites along the trail.

Please get the vagrants that are pan handling at intersections off the streets. They are trashing this town.

Please make economics the main topic of city development and do not spend money on genderism, diversity, inclusiveness, homelessness and similar "initiatives". Your role is to support working people and people with disabilities (without any priorities on sex, nationality, religion, political views, etc.) and not the fringe layers of the society who are trying to live on the back of the normal people.

Please provide more supportive services to people experiencing homelessness, racial equity and generally leading by example in a positive productive way, so that we all can be proud to live and work here. Thank you please stop treating citizens as second class folks to the homeless

The City should not be taking the lead in solving the homeless issue unless it clears the open spaces and now residential streets. Instead, Larimer County should spearhead the project and create services and facilities between Loveland and Fort Collins. The more services provided in the downtown area will only create more hostility and issues involving homelessness. Unfortunately, the City has chosen to allow non-taxpaying people to do whatever they want, wherever they want, while alienating the remaining 99.99% of the population.

The city's no camping ordinance is absolute trash and hurts people that are already down on their luck enough, they should be helping unhoused people rather than giving them fines or jail time.

The handling of the transient population and the "allowed" camping at Kings Crossing was terrible. What has been allowed at King's Crossing is ridiculous and the city should have acted on this well before it got to this level of chaos. The folks who pay for these open spaces and parks with their tax money, along with the businesses that are adjacent to these areas are implicitly being told that their rights don't matter as much as the homeless population. Because the city was scared about being sued, they decided to take a wait and see approach instead of being brave and being a leader and doing the right thing for the majority of their tax-paying citizens. The city is very reactive instead of proactive in many cases and this was one more of those situations.

The homeless are not Loveland's homeless-they are drug addicted transients who are here because Loveland has made it attractive for them. We are allowing a small group of people to take over Loveland's recreational areas as if it's their own. Totally unfair to all Loveland residents who now can't use those areas. It needs to be cracked down on immediately.

The homeless camp near me has a lot of drug use. Needles laying on the walking path and your city rep ignored them.

The homeless in Loveland is concerning. Providing free services does not solve the issue. Homeless lessen my desire to enjoy downtown.

The homeless issue has become almost unbearable for me, a local business owner and commercial property owner. It has driven me to lose all compassion for the homeless because of their mess, drugs, trash, trespassing, human waste, etc. The city MUST do more to eliminate the homeless issue in downtown Loveland. I have had two commercial tenants move out because of the issue and it is a daily battle.

The homeless issue has far too much budget when our streets and sidewalks are in disrepair and our open spaces are no longer "open.

The homeless need real care- they are humans that the system has failed and they've been tossed aside. Enforcing no camping laws does nothing to help these people.

The homeless problem in Loveland has gotten out of hand and makes Loveland tax paying residents feel unsafe! I take my kids to our public library and homeless people harass them. We go to a spray park and there are homeless people sleeping in the play area! It's horrible. They leave trash all over. Why are you not doing anything? There needs to be an aggressive law put in place. Make them leave!! No camping on trails allowed... this is how it used to be, I don't understand why it's ok all of a sudden in the past 3 years?? We don't need to accommodate transients, make them leave by giving them fines, close down their camps and have cops block it off so they get the point. They will move on if you make it uncomfortable for a few months. Entitled homeless people are ruining this community! My husband and I pay taxes and all our bills and we have full time jobs and we have to yelled at by homeless transients.

The homeless situation and the drugs need to be handled. It's out of control. I worry about walking alone, walking paths are unusable. Drug paraphernalia is all over the place, panhandling at every grocery store and at intersections, the bums go through our neighborhood leaving trash & stealing property, taking & dumping shopping carts. We find liquor bottles in our street. I worry for my elderly mom living at Mirasol, because of the proximity of the homeless people & the camps.

The homeless situation has gotten out of control. Those that want help will seek it but the majority of our homeless chose to be. Providing help for people who truly want it is one thing but enabling the lifestyle is wrong. Our trails and parks are unsafe for our children and anyone wanting to use them. Our tax dollars are paying for cleanup and maintenance of these community spaces and the homeless are destroying them over and over.

The homeless that are here are not in need. It is a lifestyle choice and it must be taken care of. I am speaking from experience in having employees people that choose to take advantage of the mess that has been created in Loveland. They need to be removed and not allowed around the general public. Visit Windsor, you will not see any of them there and it feels much safer.

The homelessness in our area is a huge problem and over the last two years has incredibly increased to where I no longer feel safe and open carry in my own home because I do not feel safe.

The homelessness issue will continue to get worse if we do not take a holistic approach to getting people on their feet.

The misplaced efforts to help the 'homeless' will merely attract more homeless to the city. The approach we are using to impact this problem ignores the reality that we cannot "fix" the homeless by offering free food and shelter to those who merely show up. I recently heard council members empathize with residents who expressed safety concerns about a "free housing" project in their neighborhood --- then they approved the project. Apparently the city council cares more about pretending to help the homeless than it cares about the safety of our residents.

The no-camping ordinance is a political maneuver to avoid the issues and resist creating a solution. I know it makes some people feel superior but there are more effective solutions. But it would take political courage.

The reason Loveland has a large homeless population is Loveland caters to them. Milliken, old Johnstown, Berthoud don't have homeless issues.

The services for homeless now are too generous. The homeless community need to have some ownership over their situation and some skin in the game for rectifying their situation. I feel what Loveland provides now is enabling this situation and attracting more homelessness to our city. There seems to be a separate set of rules for them. I'm tired of hearing the aggressiveness and threats the homeless community imposes on my family and downtown living friends. Families are being discouraged from visiting downtown because of the yelling, obscenities, and aggressive nature from many in the homeless population with clear evidence that they are in a mental crisis. Education, participation in paying for a currently free service, creating jobs in order to obtain services, providing mental health services would be better for creating self worth within the homeless community.

The unhoused population is a huge problem. The stop people from going into business, are constantly begging for money and get nasty when you do not give, the sexual harass you when you are just walking. The needles in the parks are horrible, and fairground park is just scary by the river!!!

There are differences between urban campers here for drugs and actual homeless families that are homeless not by choice. Help those and not the others

There are homeless encampments along the bike path which makes me nervous to you. I want the homeless to have a place to live, but some are actively using.

There is a white pickup truck in the parking lot of the UCHealth offices at 37th and acacia most nights. I had called it in and an officer contacted me stating he was allowed to be at the property by the owner. This should not be allowed after a complaint, since the owners or employees are not living in the area and are not around when he shows up. It makes the neighborhood unsafe especially with kids around. Camping should be banned in the city altogether. Most homeless are homeless because they want to be, not because of their situation. If they want to better themselves they will, otherwise get them out of the city.

There is real, economic homelessness, and then there is an epidemic of substance abuse and mental health, people that choose to hang out here for free and take advantage of everyone and everything around them. Help the working poor, the families, but please don't coddle the drunk, drug addicted freeloaders that are polluting this and so many other communities. Seriously, support those that are working and making a positive difference and keep us safe from the assclowns that are looking for a free ride. Let's not be like Boulder, Portland, Seattle and so many other communities that have opened up all their public spaces to be destroyed by these low lives.

Too many homeless in Loveland that need to be housed or moved on

We do not have a homeless problem we have drug addict and alcoholic problem , these people choose to live on our streets . The more programs and free services you are just enabling the problem . Providing free camping equipment and housing is not fixing the problem . Get the drugs off the streets! Also stop the people pretending they are homeless asking for money on the street corners . The road raging is horrible . Scary!!

We have seen a significant increase in homelessness across our community. Living downtown and having young kids, we no longer feel safe walking on the bike path to either Fairgrounds park or to Sunny Side Park due to the high amount of homeless. In years past, we have had many conversations and interactions with the homeless community and have actually enjoyed our conversations, however in the past year it seems that our interactions with the homeless community has gone from comfortable to uncomfortable/unsafe.

We know there is a homelessness problem in Loveland, but we just don't understand why their issues are our problem & all solutions are at the taxpayers expense. It's just not right!

We need a permanent overnight housing shelter for homeless people! This is an embarrassment to Loveland.

We need to assist the homeless rather than criminalize them.

We need to stop the panhandling at stores and street corners. most often they are not honest, just want the money.

When caring for those experiencing homelessness in Loveland--do not ENABLE them. They need help up, not hand outs. Creating a 24/7 low barrier shelter is going to attract even MORE people here and bigger problems for Loveland. I think the city has bitten off more than it can chew without putting in a structure for solutions. I'm not against the encampment ban, but the resources should've been built BEFORE creating the ban. You put the cart before the horse.

Why isn't the city building a homeless shelter instead of banning homeless camping?

You need to address homelessness. If camping is their only choice, then perhaps you need to find an area where they can do so safely.

## Infrastructure/Roads/Transportation

10, City bus or transit service: "Very confusing"

4th Street needs to be repaved.

Also, street repair should be focused on the areas that are the worse off. I see streets being resurfaced that shouldn't have been that high on the priority list, as other streets are in more need of repair.

Also, as someone who uses public transportation it make no sense for me to have to walk over a mile to get to the nearest bus stop. I am 70 yrs. old.

Appreciate the efforts towards connectivity for all residents

Better pedestrian infrastructure on 287 south of 1st street is needed

Bike paths are great, but not overly useful/safe if you still have to cross major streets on your bike or can't get where you need to go on them, or there is nowhere to lock your bike up once you've arrived at your destination.

Bus service is a joke. A plan for public transportation needs to be incorporated into all new development, which it isn't now. No wonder we have such a horrible traffic problem!

Clean up the sidewalks. I often see poop on them.

Create more crosswalk opportunities for safer access in the SW part of town, specifically on 14th St. between Wilson and CR21 (Loveland Classical creates terrible congestion during the school year!)

Dead-end sidewalks or no sidewalks shouldn't exist. 30-45 mins from west Loveland to hospital is unacceptable.

Design streets better especially Taft Avenue. Put in real bike lanes. You are going to expand Taft but it will only be for cars. It's a mess. Can you please be forward thinking when it comes to transportation planning! It is awful. I hate that Loveland is so car dependent.

Do more salting of the roads in winter and more plowing

Do your best and ensure you have some focus on correcting the disconnects across the Loveland commercial and residential landscape - i.e.; centarra vs downtown, far West vs Far North ... different needs and concerns and environs. Figure out what you want to be.

Downtown is great - but roads, maintenance (snow), and parking are horrendous. An 8 month resident - with downtown apartment.

Downtown is great. But Eisenhower is the gateway to thousands of people heading to RMNP. For the most part, Eisenhower is an eyesore. Something needs to be done to the empty abandoned buildings (old Ford dealership, and the old Albertsons that has been vacant for 17 years).

Downtown needs better parking for the disabled, specifically, but for everyone in general. Maybe a free weekend shuttle from an unused parking lot (like that eyesore at Boise and 34) to downtown can be implemented.

Fix our roads. What was the purpose of the traffic survey if you are not going to do anything about all the problems that were brought up? Clean the roads and all the litter along the roads.

Fix zoning. The whole town is getting more and more car centric and air quality has declined throughout my growing up in Loveland.

How about some senior communities in Loveland? Traffic scares me as a senior. Add turn signals so that turning left on red isn't a necessity. Review sidewalks on major paths to make it possible to walk to stores without fearing for your life. I used to ride a bike everywhere. Wouldn't dream of it now. Make the bike path safe to actually use again. It is scary now.

I would like to suggest that the city modify the pedestrian crosswalks to allow slow moving pedestrians the ability to cross intersections safely. Many of them don't allow enough time to get across before the light changes. One example is crossing Eisenhower at Wilson. I walk fast, about 4 miles per hour, and I can just make it across when the light changes.

I can't ride my bike in Centerra to downtown for shopping, or to shopping in Centerra. Too dangerous.

I feel street lighting is important at the round about along Taft heading towards 287 and the on ramp to 287 from Taft. It is especially problematic at night or in inclement weather. You can barely see them

I marked poor on utilities/infrastructure because the infrastructure in our area is extremely poor and substandard. The power lines in this area are very degraded and need replacing. I would rather see this basic, essential service replaced than see fancy embellishments on bridges, etc. Infrastructure before aesthetics.

I still believe some type of mass transit between Loveland and Denver is sorely needed to modernize the area.

I wish that the city would actively drive around and fix the broken curbs from their snow plow drivers in the Lakes of Centerra subdivision from over a year ago. They destroyed many curbs and never bothered to repair them. Deering Lake Drive and Echo Lake Drive is one example. Looks terrible for the last year and a half. Please fix all the broken curbs.

I worry there's not better alternatives for daily transportation (biking safety especially).

I would like to see more effort building bike safe streets and bike awareness culture (people drive in the bike lanes often, I don't feel safe biking around town)

I'm in a wheelchair and the sidewalks in Loveland are rough and not passable in many areas of town and dangerous in other areas. The walk lights don't always sound that you've pushed them or announce that the walk signal is on or the walk light is so dim you can't see it. The walk lights are too short to cross safely in many areas. I pay my taxes so my safety is important too. Also handicapped fishing piers would be greatly appreciated.

Increase access for non-motor vehicle mobility (bicycles, walking, scooter, etc.), especially in the downtown area and nearby areas. One way to do this is to create the downtown to be pedestrian-friendly. Olde Town Arvada, Fort Collins, and Iowa City, IA ped mall are great examples and the positives outweigh the negatives as there is plenty of parking away from the core downtown. 4th street can be closed permanently and non-restaurant businesses will thrive as foot traffic is increased which creates more visibility vs the current situation.

It seems that mass transit systems are lacking in Loveland. That may be a misconception on my part since I'm more familiar with the Fort Collins system. More information might be useful in the utility newsletter.

It would be nice to see some landscaping as you exit off 1-25 to Eisenhower Blvd. Ugly roadway coming into Loveland.

Less focus on auto; more focus on bike transportation.

Limited bike paths and walking paths that are connected to neighborhoods is problematic.

Loveland is a mixed bag right now. Cars dominate transportation and biking to actually get somewhere other than the rec trail is unsafe.

Loveland should be one of the most multi-modal transit friendly city in America, with its wealth of lakes, waterways, parks/natural areas and variety/spread of commercial districts throughout residential areas. Instead, this city is dangerous and exhausting to transit in anything other than a car. A number of people I know personally will not themselves, and certainly not their children, cross 34 by bike or foot. Hostile traffic areas like US-34, US-287, their interchange, and US-287 through the full downtown corridor, need to be redesigned with the quality of life for residents in mind, with multi-modal access for all. Data shows those types of inclusive transit efforts will increase economic activity and quality of life.

Loveland Streets need to fixed, all of them.

Low markings on roads, etc. is because it seems to take an extremely long time for repairs to be made. 1st Ave is a prime example. Mile by mile, it took the Romans less time to build Hadrian's Wall than it's taken modent technology to repair this stretch of road.

Make improving roads a priority since we are already behind the curve.

My biggest issue with the City is you keep promoting car dependent development. Why aren't you building in better bike lanes especially along Taft Avenue, it is a mess.

My husband cannot walk far and uses a walker. We used to enjoy walking/dining downtown but the sidewalks are so uneven it is near impossible for him to walk in town. Parking in the parking building and walking to anything on 4th st is impossible for him.

Need a crosswalk painted on street at Lincoln and 3rd. Parking is east of Foundry. Cars need to stop for pedestrians, but they don't because there's no painted white crosswalk. Foundry is heavily attended area. Make it safer.

Need better bus system that travels to a wider area.

No more roundabouts!

Not just a problem in Loveland, but generally in the region, it is the priority of automobile transportation. I live within walking distance of a major grocery store, but due to traffic and zero buffer zone between road and sidewalk, I don't feel safe walking on the sidewalk. Walking/biking should not be viewed only as a recreational activity in this city, but as primary (and exclusive for some) modes of transportation. With our climate crisis, we need to create an environment that promotes biking/walking over automobiles for shorter distance travel (i.e. within the city)

Please continue to re=pave the many poor urban streets in the city.

Please don't start charging for parking downtown! We LOVE downtown and having to pay for parking would likely mean we don't go as often.

Please focus on infrastructure.

Prioritize the widening of Highway 402 - this is a major road and becoming absolutely dangerous to drive on

Provide better public transportation opportunities along Taft and Wilson to Fort Collins. Not everyone uses 287 or bikes to work, and these one lane roads are becoming quite congested. Public transportation could provide us with more options that driving our own vehicles.

Public transportation is a joke in Loveland. That's your whole issue. Close off 4th street to cars. Loveland needs a walkable urban space or it's going to be dead. Legalize mixed use urban development everywhere. Get a tram everywhere... Street cars, light rail etc. To go along with that protected bike lanes and paths to bike and walk the entire city without encountering a car that get you to everywhere. Your recreational path does not count because it doesn't take you anywhere useful. Set up your infrastructure so that it's attractive to bike and walk not drive

Public transportation is extremely lacking. Cars are a necessity to get around town because everything is so spread out. It leads to issues with parking, affordability of gas prices, people driving under the influence, trouble commuting to work or school and so much more.

Question 9, Used bus, rail, subway...: "Very confusing – need every 1/2 hr plz"

Remove all street parking on Lincoln and Cleveland from 2nd street to 5th street. We have a beautiful, free garage. Traffic routinely travels at 20 mph in the 30 & 35 mph zone due to narrow lanes and bad sight lines from this hazardous parking, creating angry drivers.

Roads near target are pretty bad and have only been patched.

Snow removal policy needs review/modification

Street layout and design needs work.

Take care of very poor roads condition.

The City does a great job of keeping the snow removed at the Foundry.

The city leaders have done almost nothing to improve the road infrastructure in the 39 years I have lived here even though the number of residents has more than doubled. It is time to stop building until you can improve traffic flow. I have traveled to many different states and nowhere that has a similar population as Loveland has the same ridiculous traffic that we have.

The city needs to address transportation and land use issues comprehensively, not just continue with growth on the perimeter of the city.

The downtown area would be a much more pleasing if the streets and sidewalks were kept clean. Seems that it's not important since after living here for over 6 years it has not improved at all

The roundabout at first and 21 is horrible especially for cyclists.

The streets are a mess.

Too much road construction- it's just fine as it is!

We need a bike path going to Berthoud.

What's up with all the crazy intersections and roadways?

When will you do something about bike infrastructure?

Why is the city so SLOW with road repair. 1st Street is RIDICULOUS!!!!!! Seriously, WTF is happening?

Your lack of public transportation to those that would use it most is quite a downside of being a resident. I know many people that would use it more often if hours were extended and access to east of I-25 was more often with busy routes. People I know that would use the bus, cannot because it's not available when they get off work after 7pm. And doesn't run in Sundays. The lack of safe bike routes and lack of transportation, is a big problem. Even the city partnering with e bike and e scooters like Fort Collins does, or shuttle services would be ideal. And seeing more transportation offered in newer buildings areas.

I have ideas on how to solve the problem of downtown parking, but would the council even listen much less consider the idea.

If you're going to do road maintenance, and have signs and cones everywhere, pick up after yourselves.

# **Parks/Recreation/City Facilities**

Chilson is providing good service to our community.

he recreation trails and open spaces are lovely

I love the library and use it often. I think it is time for a second branch and/or book return boxes throughout the community.

I would like the city to recognize the Men's associations at both The Olde Course and Mariana Butte. They contribute to the economic welfare to the city golf courses and have a known loyalty to the courses. There are many other courses in the area which we could choose.

I would like the Parks & Rec department to adhere to their guiding documents and listen to the citizen of Loveland. The Dept eliminated our neighborhood tennis courts without notifying us and then ignored our petition to stop it. It was very disrespectful to our neighborhood.

I would like to see the public library receive more support. It seems to be forgotten or ignored by some on the city council.

It is great to see Loveland growing. My personal concerns lie in maintaining natural open spaces, rec areas (bike trails, walking paths, etc.), and providing enough resources (groceries!!) for residents. And I'm not talking... another Walmart, or another Target.

More open spaces within residential areas

Need a pool by Mahaffey to take pressure off Winona.

Need additional recreation center west side of city

On a selfish note, I believe the parks department does not recognize the shift from some traditional outdoor activities like basketball and tennis to current community interests like pickleball. The number of unused tennis courts is astounding considering how many community members wait around for an open pickleball court. Convert more courts!

Our public library needs to expand hours to include evenings. Working people don't have equal access to their services, including book groups.

Overall Loveland is a great place to live!! We especially LOVE the library and think the public library does a great job with engaging kids with their story times and reading programs and crafts. Thank you!

Parks need to be updated and water parks need to be maintained better.

Please add more pickleball courts.

Please continue your support for open spaces and parks, especially the foothills area, and opening skyline natural area. Please support and negotiate for the Front Range Rail, which will help transportation and the economy.

Provide more opportunities for river access; obtain and provide more open space opportunities around Boedecker

public library - excellent

I'd like theaters for plays/musicals.

Museum services - excellent

the bike trail loop around town is excellent except for the unpaved section off Wilson- please pave that.

The parks are not as clean as they used to be. The restrooms are not maintained well.

Unrelated, but important, please find a way to attract more farmers to the farmers market. It's turned into a craft fair. Thank you for asking for feedback.

Yes the one thing I don't get is why we don't have an indoor park. With winter months and days the drop below Odegrees and 100degree days in summer an indoor park seems essential to the community.

#### **Police**

A complete investigation and cleaning of the Police Department is needed to re-establish trust.

Address police response time!

Also our police department needs new people at the top and get back to the great police deportment we once had. community policing and cops teaching in schools( LRE) and coaching our kids to have a better interactions with our youth.

Also, I am sick and tired as a taxpayer paying out lawsuits for the police department because they have a culture issue. I don't care what the independent study said, there is a culture issue. Fix the damn department.

As a person who comes from a family of police officers, I have been discouraged and dismayed by the multiple abuse of power issues. I do not feel safe in the presence of local law enforcement, nor do I believe other Lovelanders are. The whole department needs a massive, top down overhaul. Our daughter, age 9, is neurodiverse and we have needed to teach her to avoid police interactions. She's just a little girl who communicates differently. This is not unfounded fear, as her previous "friendly" community outreach citizen/police officer interactions were less than ideal. One K9 officer literally laughed in her face and she cried all the way home. She knew that the police officer was making fun of her in front of 40 other people, including me. If we have an emergency, we have decided not to call Loveland Police. If my 9 year old autistic daughter isn't safe from the people who are sworn to keep her safe, it's hard to feel super excited about my city.

At times you feel ashamed to say you live in Loveland, between the bad police and homeless issues people are calling Loveland a dump

Better training and enforcement of standards in PD needed!

Bring a good police chief in who isn't afraid to make changes.

City Council and staff inaction in dealing with a lawless and abusive police department is emblematic of a lawless City Hall and City Council. Loveland is not a fit place to live until it is run by officials that respect our Charter, state statutes, citizen rights, and the environment. The City has subsidized runaway development that does not pay its own way; it seems to want to use up ever inch of land and water resources to the last drop.

City Council sets the tone for Loveland which is polarized. these 9 people would rather argue amongst themselves rather than take care of City issues and matters. They don't stay on task despite having a structured agenda. It appears the mayor preplans citizen input at the meetings and is anti-police and growth

Clean up the police department it is horrendous concerning some of the treatment done people have received. The coverups need to end.

crimes committed not by the police are low in number and generally non-violent

Does the city have enough reliable, educated police officers? or is that budget being cut by the city?

Don't even get me started on our abusive police department.

Everyone knows what Loveland PD is capable of and they need to focus their attention on cleaning up the streets, not targeting minor traffic violations.

Fix inept police department.

Fix our government and police violence.

Fix our Police Department. We are the laughingstock of all the surrounding communities. Most of our officers are great people who want to do the right thing. Get them the training they need so we stop beating up old ladies and shooting unarmed suspects.

Freeze LPD's budget for a few years to fund other services that are preventative of crime and supportive instead of punitive, such as the successes of CAHOOTS and STAR non-police low-level intervention programs in Oregon and Denver, with plenty of data proven their efficiency in both quality of outcomes and taxpayer cost.

Have police spend more time preventing crime than hiding in the bushes to catch drivers

Here are a few interesting stories from just the last two years. \$3M in taxpayer money was paid to Karen Garner due to her violent and mishandled arrest by Loveland PD in June of 2020. A lawsuit was recently filed against Loveland PD for excessive force against a 14-year-old girl placed in handcuffs, also in June of 2020. While in cuffs she was forced to the ground, and she hit her head on cement steps. Her dog then got loose, and video footage shows Loveland PD carrying the dog by the collar around its neck. Her father then got upset with how things were being handled and was subsequently tased and arrested as well. In early 2021, a man was arrested by Loveland PD and charged with a DUI despite not having any alcohol or other substances in his blood test. The now pending lawsuit claims that this is a common practice by Loveland PD and has at least 12 other examples of citizens being wrongfully arrested and charged with DUIs despite not having alcohol or other substances in their system. Another lawsuit was filed in August of 2021 against Loveland PD for shoot and killing a family's 14month-old puppy while officers were on their property. Officers refused to let the family take their dog to a veterinarian until their supervisor arrive and the dog died in the family's driveway. Also in August of 2021, Loveland PD shot a teen, Alex Domina, that was having a mental crisis in his own backyard. His grandmother called Loveland PD to de-escalate the situation. Alex died two weeks later in the hospital as a result of his injuries. No officers were charged. Again, this is just in the last two years. I hope you would agree that serious changes need to be made in the town of Loveland.

How many more times are you going to allow the police to brutally harass people before significant change is made?

I also think we have an extremely over zealous Police force. However there are some fantastic Policemen as well.

I also worry about our police department. I am upper middle class, white skinned, and even I don't trust them to be fair, honest and not apply too much force when things escalate. They also make a game of getting air on the road with a small hill by my house. It's dangerous and disruptive when done repeatedly at night.

I am concerned about the current perception of police attitudes and practices toward more ethnically and sexually diverse peoples and those with mental health issues in our county and city. IF police are compassionate and willing to treat the public in a respectful and compassionate manner I need to see that they are through their daily behavior. If they are not open, honest, respectful and compassionate, I also want to know this so that I can be aware. I would rather not find out about incidents and behaviors on the evening news! Respect is a baseline essential cultural requirement for me; one that will drive whom I support and where I wish to live, now and in the future.

I am very uncomfortable with our police department both from a personal perspective and the negative publicity it has received nationally.

I don't like the Loveland Police's attitude toward citizens. It's also a national problem.

I feel unsafe with the police dept.

I have absolutely zero trust in protection by our police or local government. I'm actually more so AFRAID of them, so much so, that's I've considered leaving Loveland for the first time in my 14 years here.

I have no confidence in the police.

I just kept coming back to poor police and poor city leadership as I was answering these questions. The community of Loveland is wonderful. The city as an organization has a lot of work to do.

I moved here in 5/2020. Clean up the Police Force quicker, progress has been made but it's too slow and the lawsuits cost money!

I worked at a police department years ago and find the Loveland PD to be based on a culture of violence... in every video we see the police start the escalation with a 'do as I say' demanding attitude.. chip on the shoulder ego.. this will always lead to an escalation and put our citizens and good officers in danger. CM Adams, CA Garcia, Councilmembers Overcast, Fogle, Olson and others have done nothing to stem that behavior from officers in our city... they are complicit in the heinous acts we have seen against vulnerable citizens. I'm a senior with disabilities who feels unsafe because of our police and our council members.

I would like to see more Police present in the Foundry.

I'm actually scared to utilize our police department. Please do something.

I'm afraid of Loveland police.

Karen Garner revealed MAJOR problems in the police force which showed there is NO accountability. The police can NOT be trusted to act with compassion, honesty, and professionalism. WHERE IS THE ACCOUNTABILITY to prevent this happening over and over again?

Last item; I know the police department must feel it is under siege, but they need to improve their policing performance. I have personally witnessed, and friends and neighbors have reported to me, that when responding to 'minor' calls they do not contact the person who called and they merely drive by and shine lights before leaving. This apparently apathetic, ineffective behavior is not going to improve their image. The police can't control what the press says about them, but they can win friends by handling even minor calls in a manner that indicates they care.

Loveland has a black eye from our policing issues over the past 2 years. I am in full support of our PD and the folks who serve and protect. That being said, what happened under the leadership of Chief Ticer, from the Karen Garner situation to the current situation in which Loveland PD, or it's associates, are being sued for at least one wrongful DUI charge sure does make you wonder what is going on and makes it harder and harder to support folks like that. I do feel that the police chief should have been held more accountable as "the buck stops with him".

Loveland has been getting bad friends of kin who live out of state and around the world for the several large profile police interactions. (guy thrown on ground outside Charlie Ls, lady with broken shoulder from. Walmart, aggressive arrest of young girl behind Safeway on 1lWilson and Eisenhower) It does make it clear that Loveland PD has an aggression issue and it needs to be corrected.

Loveland PD needs to follow Longmont PD's direction of mental health before punishment.

Loveland police department needs to be defunded and disbanded. Can we outsource to a professional department, like Fort Collins?

Loveland police department would do a great service to the community if they collectively pulled their bottom lips over their own heads and swallowed.

My extended family refuses to visit me out of fear of the police department.

my primary concerns with the city of Loveland are twith the police force and their complete inability to actually pursue a policing model that would allow them to know their community beyond power trips and needless assaults of our vulnerable citizens.

My wife and I bought a house in Northwest Loveland in early 2019. Within a week of moving in, my wife was ticketed for speeding just a short distance from our new neighborhood. My wife is a very safe driver-- she is in her early forties, and that was the first time she'd ever been pulled over. Ever. The police officer gave her a "It's a good thing you're cooperating, because I could make this a 20 mph over charge real easy" speech that left her shaken. There is zero chance she was going that fast. Shortly thereafter, we opened our first utility bill, and the cover article on the newsletter featured an interview with the Loveland Police chief, where he bragged about the number of "adult traffic citations" his officers were bringing in each month. Six months later, my parents were visiting from out of state, and we drove them up from the airport. I will never forget driving west on 34 from the interstate, with everyone on the road doing 5 miles under the speed limit, and it seemed there was a police cruiser at each and every intersection with someone pulled over.

Need to clean out police of all bad apples. Too many lawsuits

One of my largest concerns is the conduct of the Loveland Police Department and the apparent unwillingness of city council & the city manager to address the problem.

Our police department continues to be embarrassing and disgraceful on a national scale. Clear the rot.

Our police department is an embarrassment to the community.

Our police department is housed with overpaid, uneducated thugs.

Our police force is too abusive and racist. I got a DUI with about 8 cops standing around me when I was being calm and compliant and was not under the influence. I'm staying in Loveland to make a change the other direction.

Please fire cheif Ticer & hold LPD accountable - you cant have a cultural change with the same people in charge.

## Traffic/Congestion/Enforcement

- 1. Get the inoperable vehicles of the streets 2. Enforce the speed limits on city streets 3. Install red light cameras
- 1) There seems to be no enforcement of speed limits in Loveland, and far, far too many drivers ignore them. I walk daily for at least half and hour and often more, and I am incensed at the speeds vehicles are driven on N Taft Ave and on W 43rd St. It's dangerous for pedestrians, cyclists, and other vehicles. Speeding creates so much noise for those living along N Taft Ave that it is a quality-of-life issue.

All public road street lights should get changed to led, looks trashy having some non led and some led.

Also, the amount of people speeding around the city. It is crazy. I think the Police need to be out on the street/s running radar. Especially around Lake Loveland on 34. The speed limit is 35 and people are doing 45,50, 55. Start ticketing people and I bet the city has more revenue and people will get the word out that the police are ticketing speeders and the amount of speeders goes down. Just things I have seen over the years.

And, the traffic violations are out of control. More speed traps, monitoring devices, and police visibility needs to be used in combating poor drivers.

Better traffic control, I.e. people on cell phones while driving, slow drivers and trucks in the left lane, road and driving enforcement

Cars speeding through residential areas has increased drastically over that last few years. It is very common to see cars going 15 to 20 mph over the speed limit. This worsening issue needs to be addressed by the city for the safety of our residents.

Disappointed with enforcement of speed/noise ordinances sidewalk availability

Do something about this traffic, it's horrific. I see multiple people run red lights daily (it's time to put in Red Light Cameras at certain intersections like Taft/34), certain side street traffic lights don't blink at 10pm like they do in Longmont-why have people sit at red lights at midnight when no one is coming? Stop dumping ALL the traffic (new developments) onto highway 34- the road can't take it! There are very little back ways to get anywhere in this town- better planning needs to be applied when new developments are built. I go to Foco before I go to Centerra/that area because traffic is a nightmare.

Enforce the ordinances and laws we have especially parking

Fire the traffic dept and get people that can program the stop lights properly

Fix the traffic on 34 and 402 or build a bypass around them.

Homeowners request additional stop signs in their neighborhoods but the city disputes this by claiming cars are only going 5-10 miles over the speed limit. 5 to 10 is bad enough when cars fly over the hills. Crossing the street is at the pedestrian's own risk.

Hopefully more ppl are also commenting on the following: a horribly designed and very dangerous roundabout was put in within the last few years at South County Road 21 and West 1st. It needs to be re-done badly!! So many people drive right over it because it is so low, and there is nothing in the center of the roundabout such a shrubbery and trees, which there should be. The road surrounding the roundabout is in very poor shape, and in my opinion the intersection is now more dangerous with the roundabout than it was before.

I lost two parked cars to hit and run drivers in two years.

Loveland could make a mint if the police would enforce speeders on N. Boyd Lake Avenue. Speeding and racing are very common from 34 to 392.

Loveland has become a terrible place to live. There is no law enforcement for traffic and is way to expensive to live here. I have lived here do over 50 years and beyond sad of what Loveland has become.

Need to replace traffic flow personnel. Light flow in Loveland is the worst of any city I've ever experienced.

people always speed down 7th on their way to the Cleveland-Lincoln intersection- please set up speed monitoring or signs or something- someone is bound to get hurt as many people tend to cross 7th on Jefferson to head into old town and they have dogs/kids with them- and large vehicles often speed down the road.
