Garage Rental Policy at Rockcrest

#### Quarterly Financial Statements

Sharlet Lee presented the HACOL financial statements. Sharlet also reported that Tracie Thompson will begin working with the new auditors in September for June 30<sup>th</sup> year-end.

#### <u>Mirasol Phase II</u>

Sam Betters reported that Mirasol Phase II planning is moving along and we will contact the development committee when the next Charrette is scheduled.

## Orchard Place

Sam Betters reported that some of the porches are complete and they look really nice. Irrigation and landscaping will begin the week of August 2<sup>nd</sup>. We are going to use \$150,000 of disposition funds to build a clubhouse that will be located to the west of the

new playground. The clubhouse project will be completed by the end of the calendar year.

# **City Council Liaison Report**

Joan Shaffer reported that the City Manager search is going well and she anticipates they will disclose the finalist list by August 2<sup>nd</sup>. City Council voted to put the debate of allowing medical marijuana dispensaries on the November 2, 2010 ballot and let the citizens of Loveland vote on whether dispensaries should be allowed in Loveland. Council is also working with Artspace, an organization who is looking for a site to develop for affordable housing for artists in the downtown area.

Sam Betters said that the strategic planning kickoff session will most likely be September 16<sup>th</sup> or 17<sup>th</sup> and Tracy will notify everyone when the date is confirmed.
