A. Special Event Permit – Art Works Gallery: Sweetheart Festival 2023, 2/10 and 2/11

Art Works Gallery will be participating in the 2023 Loveland Sweetheart Festival as a venue featuring contemporary art, live music, drinks, and food from a local food truck. Proceeds will benefit the gallery from February 10th to February 11th.

B. Special Event Permit – Loveland Museum Nights on the Town and Museum Reception Events, 2023

Loveland Museum will be hosting "Night on the Town" events and Museum Receptions on February 10th, March 16th, April 14th, June 9th, October 13th, and December 8th, 2023 with events hosted from 6pm to 8pm. Proceeds will benefit Loveland Museum.

E. Renewal Application – Pinocchio's Loveland LLC, dba Pinocchio's Incredible Italian

An application for renewal of the Hotel and Restaurant license issued to Pinocchio's Loveland LLC, dba Pinocchio's Incredible Italian was filed on January 14, 2022. The licensee attended the December 15th, 2022 Liquor Licensing Authority Meeting and received the following conditions for renewal:

- 1. The establishment will open for inspection all records of bookkeeping
- 2. The establishment must be in full compliance with all fire department and city inspections
- 3. The establishment must pay their delinquent sales tax and maintain a \$0 balance with the sales tax division of the City of Loveland.

It was determined upon inspection by Loveland Police Department personnel that condition 1. was not adequately met.
