### UPDATE: LOVELAND POLICE ARREST FINAL TWO SUSPECTS IN HOMICIDE

**LOVELAND**— The Loveland Police Department has made two additional arrests in the homicide that occurred on **Friday, January 20, 2023**, in the area of **2500 E. 1<sup>st</sup> St.**, leaving Nasier Graham, age 18, dead and a 16-year-old Loveland resident seriously injured.

Detectives have taken two additional juvenile males into custody for their involvement in this case. Loveland Police believe there is no longer a threat to the community based on details surrounding this incident.

**Suspect 1, Male 15, Greeley, Colorado.** Taken into custody on **Tuesday, January 31, 2023**, was formally charged on 13 counts.

**Suspect 2, Male 15, Greeley, Colorado.** Taken into custody on **Thursday, February 2, 2023**, was formally charged on 15 counts.

**Suspect 3, Male 15, Greeley, Colorado.** Taken into custody Sunday, **February 5, 2023**, on an arrest warrant with charges pending as determined by the District Attorney's Office.

Loveland Police want to thank the public for their efforts in providing information and tips that have come in this past week. Since Friday, January 20<sup>th</sup>, over **90 tips** were received. It is our continued partnership with the community that helps us keep Loveland a safe community to live in.

Loveland Police also want to thank our law enforcement partners for the collaborative efforts in making these arrests, specifically, the Greeley Police Department, Larimer County Sheriff's Office, Fort Collins Police Services, Federal Bureau of Investigation, Larimer County District Attorney's Office, and the Larimer County Coroner's Office.
