

## WATER HEATER SUBMITTAL ITEMS

The following can be provided on a separate word/PDF document(s)

### **Residential and Commercial Water Heater Requirements per IPC 106.5.1**

1. Specification sheets / installation on new water heater and whether it is being utilized as a heating source (IPC 1002.2.)
2. Provide the name plate from the old water heater that includes the BTU's and gallon capacity.
3. Provide BTU requirements for the existing and new unit(s)
4. For Commercial water heaters: If the BTU requirement is larger than the existing or the flue size, type of flue, or gas pipe changes, a stamped drawing from a Registered Design Professional will be required.
5. For Residential water heaters (single family, duplex, townhouse): If BTU requirements on the new unit(s) is larger than the existing, a drawing showing the gas pipe sizing of the residence will be required, or a one-line gas pipe drawing showing a new gas line form the meter to the unit(s).

**Prior to submittal of this application, please:**

1. Verify your contractor holds a valid contractor's license with the City of Loveland
2. All highlighted areas must be filled out. If not applicable, please put N/A
3. Application must be printed and signed by contractor or authorized signer listed on contractor license
4. Submit the requirements from the front page
5. Please note that the Power Division may require an Electric Service Worksheet (ESW) with your submittal - [lovgov.org/res](http://lovgov.org/res)
