- A. Special Event Permit Application – City of Loveland Parks and Recreation – Farmer’s Market – June 18<sup>th</sup>, July 23<sup>rd</sup>, August 13<sup>th</sup>, and September 24<sup>th</sup>, 2023.**

permanently expand and/or move the store's existing alcohol beverage product placement areas to accommodate the sale of wine beginning on March 1st, 2023.

**F. Transfer of Ownership – Dubois Family, LLC, dba The Grill at The Olde Course to JnG Enterprises LLC, dba Big Fork**

An application was filed on February 6th, 2023, for a transfer of an **Optional Premises License** from Dubois Family, LLC, dba The Grill at The Olde Course to JnG Enterprises LLC, dba Big Fork, for the Optional Premises Liquor License located at 2115 W 29<sup>th</sup> Street. A temporary transfer permit was issued on February 17<sup>th</sup>, 2023.

**G. Renewal Application – Pinocchio's Loveland LLC, dba Pinocchio's Incredible Italian**

An application for renewal of the Hotel and Restaurant license issued to Pinocchio's Loveland LLC, dba Pinocchio's Incredible Italian was filed on January 14, 2022. The licensee attended the December 15<sup>th</sup>, 2022 Liquor Licensing Authority Meeting, and was required to meet a list of three conditions for her renewal to be granted. The licensee has satisfied all but one requirement set forth by the Authority after attending the January 17<sup>th</sup>, 2023 Liquor Licensing Authority Meeting:

1. The establishment will open for inspection all records of bookkeeping.
