ORDINANCE NO. 6590

**AN ORDINANCE REPEALING AND REENACTING CHAPTER 15.48 OF THE
LOVELAND MUNICIPAL CODE AND ADOPTING BY REFERENCE THE
INTERNATIONAL ENERGY CONSERVATION CODE, 2021 EDITION**

WHEREAS, pursuant to Section 4-12 of the Charter of the City of Loveland, the City Council is authorized to adopt, by ordinance, any code by reference in accordance with the procedures established by state law; and

WHEREAS, the Construction Advisory Board has recommended that City Council adopt the 2021 Edition of the International Energy Conservation Code (the “2021 IECC”), and amendments thereto; and

WHEREAS, the City Council has conducted a public hearing pursuant to C.R.S. §31-16-203 concerning the adoption of the 2021 IECC by reference and finds and determines that it is necessary to the health, safety and general welfare of the public that the City regulate conditions hazardous to life and property by the adoption of the 2021 IECC, and certain amendments and modifications thereto.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVELAND, COLORADO:

Section 1. Chapter 15.48 of the City of Loveland Municipal Code is hereby repealed in its entirety and reenacted to read as follows:

15.48.010 – International Energy Conservation Code, 2021 Edition – Adopted.

The International Energy Conservation Code, 2021 Edition (the “2021 IECC”), issued and published by the International Code Council, 4051 West Flossmoor Road, Country Club Hills, IL 60478-5795, is hereby adopted by reference as the energy conservation code of the City of Loveland as if fully set forth herein, with the modifications, if any, set forth in Section 15.48.020 below. This code is a complete code to safeguard public health, safety and welfare by regulating and governing energy efficient building envelopes and installation of energy efficient mechanical, light, and power systems and providing for issuance of permits and collection of fees therefore. At least one (1) copy of the 2021 IECC, which has been certified by the Mayor and City Clerk, shall be on file in the office of the City Clerk and may be inspected during regular business hours.

15.48.020 – Modifications to International Energy Conservation Code, 2021 Edition.

The International Energy Conservation Code, 2021 Edition, adopted in this chapter, is modified as follows:

- A. Section C101.1 and R101.1 – Title - is amended to read as follows:

These regulations shall be known as the International Energy Conservation Code of the City of Loveland, hereinafter referred to as “this code”.

- B. Sections C103.1 and R103.1 – Construction documents - are amended to read as follows:

Construction documents and other supporting data shall be submitted electronically with each application for a permit. The construction documents shall be prepared by a registered design professional where required by the statutes of the jurisdiction in which the project is to be constructed. Where special conditions exist, the code official is authorized to require necessary construction documents to be prepared by a registered design professional.

- C. Sections C104 and R104 – Fees – are deleted in their entirety.

- D. Sections C109 and R109 – Stop work orders – are deleted in their entirety.

- E. Sections C110 and R110 – Means of appeals – are deleted in their entirety.

- F. Section R401.2.1 – Prescriptive Compliance Option – is amended to read as follows:

The Prescriptive Compliance Option. Requires compliance with Sections R401 through R404.

For new single-family dwellings, two (2) family dwellings, townhomes, and R-2, R-3, and R-4 occupancies three (3) stories or less, the Prescriptive Compliance Option shall not be a compliance option.

- G. Section R401.2.2 – Total Building Performance Option – is amended to read as follows:

The Total Building Performance Option requires compliance with Section R405.

For new single-family dwellings, two (2) family dwellings, townhomes, and R-2, R-3, and R-4 occupancies three (3) stories or less, the Simulated Performance Alternative (Performance) Option shall be a performance option.

- H. Section R401.2.3 – Energy Rating Index Option – is amended to read as follows:

The Energy Rating Index (ERI) Option requires compliance with Section R406.

For new single-family dwellings, two (2) family dwellings, townhomes, and R-2, R-3, and R-4 occupancies three (3) stories or less, the Energy Rating Index (ERI) Option shall be an option.

- I. The following section is hereby amended to read as follows:

15.48.030 – Violations and penalties.

It shall be unlawful for any person, firm or corporation to erect, construct, enlarge, alter, repair, move, improve, remove, convert or demolish, equip, use, occupy or maintain any building or structure in the City of Loveland or cause the same to be done contrary to or in violation of any of the provisions of this code, as adopted and modified by the City of Loveland. Any person, firm or corporation violating any of the provisions of this code, as adopted and modified by the City of Loveland, shall be deemed guilty of a misdemeanor and subject to penalties as set forth in Section 1.12.010 of the City of Loveland Municipal Code.

Section 2. That if any section, subsection, or portion of this ordinance is, for any reason, held to be unconstitutional or invalid for any reason, such decision shall not affect that validity of the remaining portions of this ordinance. City Council hereby declares that it would have passed this ordinance, and each section, subsection, and portion hereof, regardless of whether any one or more sections, subsections, or portions may be declared unconstitutional or invalid.


Section 3. That nothing in this ordinance shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, liability incurred, or cause of action acquired or existing under any ordinance hereby repealed, nor shall any legal right or remedy of any character be impaired by this ordinance.

Section 4. That the City Clerk shall cause to be published twice in a newspaper of general circulation within the City, once at least fifteen (15) days preceding the public hearing, and once at least eight (8) days preceding the public hearing, the following notice:


Public notice is hereby given that at 6:00 p.m. on _____ in the City Council Chambers, City Hall, 500 East Third Street, Loveland, Colorado, the Loveland City Council will consider on second reading an Ordinance Repealing and Reenacting Chapter 15.48 and Adopting by Reference the International Energy Conservation Code, 2021 Edition. A public hearing shall be held prior to said consideration. Copies of the above-referenced International Energy Conservation Code, 2021 Edition and any codes adopted by reference within the code are on file with the Loveland City Clerk and are open to public inspection.

Section 5. That as provided in City Charter Section 4-9(a)(7), this Ordinance shall be published by title only by the City Clerk after adoption on second reading unless the Ordinance has been amended since first reading in which case the Ordinance shall be published in full or the amendments shall be published in full. This Ordinance shall be in full force and effect June 1, 2023, consistent with City Charter Section 4-8(b).


