2. PUBLIC HEARING

A. Special Event Permit Application – Meals on Wheels – Meals on 4th St.

Meals on 4th is the Premier fundraising event for Meals on Wheels of Loveland and Berthoud; this event is a celebration and fundraiser that raises awareness for the organization – this year’s event will be held on Wednesday, June 14th, on 4th Street between Cleveland and Railroad, from 5:30pm to 9:00pm and feature local breweries and wineries in support of the event as well as meals from local restaurants.

B. Special Event Permit Application – Loveland High Plains Arts Council – Sculpture in the Park 2023

Sculpture in the Park, the annual fundraiser presented by the Loveland High Plains Arts Council, raises money to place sculptures in Benson Sculpture Garden. The event will take place at Benson Sculpture Garden on August 11th from 3 pm to 8pm, and August 12th and 13th from 9:30am to 5:00pm, and will feature meals catered by Fresh Plate Catering and feature beer, wine, and margaritas donated from High Country Beverage and Coyote Gold.

C. Special Event Permit Application – Sweetheart City Racing – Health 4 Heroes Guardian Games 2023

Sweetheart City Racing will present the Health 4 Heroes Guardian Games Fitness Competition, raising funds for Health 4 Heroes to benefit Military Personnel and First Responders. Beer donations from New Belgium Brewing and High Country Beverage will be sold to benefit Health 4 Heroes in combination with athlete entry fees on June 17th in Loveland Sports Park, from 8am to 2pm – food trucks and light snacks will be available throughout the event.

D. New License Application – Bar Lyssa Inc. dba Bar Lyssa

An application was filed for a new **Hotel & Restaurant License** by Bar Lyssa Inc., d/b/a Bar Lyssa, at 120 E 4th Street. in Loveland, 80537. The neighborhood boundaries were designated as: (**NORTH – E 16th St.; SOUTH – 14th St. SW; EAST – N Boise Ave.; and WEST –N. Duffield Ave.**) The premise was posted with a sign advertising the Public Hearing and a notice was published in the Reporter Herald as the law requires.

A temporary transfer permit was issued on May 2nd, 2023.
