Two Suspects Arrested for Home Invasion

On May 16, 2023, at 12:38 am, Loveland Police Dispatch center received a 911 call reporting a burglary in progress in the 1400 block of Avondale Court, Loveland, Colorado, 80538. The 911 call taker related to responding officers several people in the background could be heard screaming and one of the suspects was armed with a handgun. Officers arrived on scene and determined the two male suspects had fled the scene prior to their arrival. Officers contacted several witnesses/victims who reported the two male suspects had forcibly entered the residence and started assaulting some of the occupants. As the suspects fled in a vehicle one victim heard a gun shot from the fleeing vehicle. Loveland Police Detectives and crime scene personnel responded to the scene. With the assistance of the Loveland Police Street Crimes Unit and the Fort Collins Police Services Criminal Impact Unit, Detectives were able to have both suspects in custody by 6:00 pm on May 16, 2023. The suspects were identified as Davon Nathaniel Randolph, dob: January 5, 2003 and Joseph William Kelly, dob: May 11, 1961.

Davon Randolph was charged with the following offenses: 1st Degree Burglary - 18-4-202 (1), a class 3 Felony; 3rd Degree Assault (3 counts) - 18-3-204 (1)(a), a class 1 Misdemeanor; Domestic Violence - 18-6-801, sentence enhancer; and Criminal Mischief - 18-4-501 (1)(4)(b) a class 2 Misdemeanor.

Joseph Kelly was charged with the following offenses: 1st Degree Burglary – 18-4-202 (1), a class 3 Felony; Possession of Weapons by a Previous Offender – 18-12-108, a class 5 Felony; Felony Menacing (4 counts) - 18-3-206 (1)(a), a class 5 Felony and 3rd Degree Assault (2 counts) – 18-3-204 (1)(a), a class 1 Misdemeanor.

“I appreciate all of the personnel and agencies involved who assisted us in taking these violent offenders off our streets within 18 hours of receiving the original report.”, stated Loveland Police Chief Tim Doran.

On May 17, 2023, both Joseph Kelley and Davon Randolph appeared before Larimer County Magistrate Schwartz. Davon Randolph was released on a \$8,500 co-personal recognizance bond and Joseph Kelley was released on a \$10,000 co-personal recognizance bond.

The charges are merely an accusation, and the defendant is presumed innocent until, and unless, proven guilty.
