PROPOSED AMENDMENT TO THE CHARTER OF THE CITY OF LOVELAND TO BE SUBMITTED TO THE CITY'S ELECTORS AT THE NOVEMBER 7, 2023, ELECTION

Amend Article 12 of the Loveland City Charter by the addition of a new Section, which is to read as follows:

“Section 12-3 — Tax on Food Prohibited.

Council shall make no law, nor continue any law, which imposes any tax or fee on the retail sale of any human food for home consumption.”

This amendment shall become effective on January 1, 2024.
