2. PUBLIC HEARING

- A. Transfer of Ownership – Elevation Liquors LLC to High Elevation Liquors DownLow LLC, dba High Elevation Liquors**

An application was filed on April 5th, 2023 for the transfer of the Retail Liquor Store License from Elevation Liquors LLC, dba Elevation Liquors to High Elevation Liquors DownLow LLC, dba High Elevation Liquors LLC, for the license located at 1904 W Eisenhower Blvd in Loveland. A temporary transfer permit was issued on May 2nd, 2023.

- B. Special Event Permit Application – Thompson Valley Art League – Art in the Park**

Art in the Park is a fundraising event for the Thompson Valley Art League; this event is a celebration of art and fundraiser that raises awareness for the organization – this year’s event will be held at North Lake Park, located at 2750 N. Taft Ave, on August 12th, 2023, from 10am to 5pm, and August 13th, 2023, from 10am to 4pm, and will feature local breweries and wineries in support of the event as well as food trucks.

- C. Special Event Permit Application – St. John the Evangelist Catholic Parish – Festival/Carnival Parish Appreciation**

The Carnival/Festival is a parish appreciation event held annually presented by Saint John the Evangelist Catholic Parish to raise funds for the Church and its community. The Festival/Carnival event will take place at the Parish’s Soccer Field/lawn on June 24th, 2023, from 12pm to 9pm, and will feature meals catered by the parishioners and soft drinks, along with beer, wine, and margaritas, also donated by the parishioners.

- D. Special Event Permit Application – Loveland Sertoma Club, Inc. – 2023 Loveland Loves Barbeque**

The Loveland Sertoma Club presents the 2023 Loveland Loves BBQ, a two-day event to promote community bringing people together through live music, food, and drinks to raise money for several local non-profits, including the Boys & Girls Club, House of

Neighborly Services, and many more. Loveland Loves BBQ will take place at Fairgrounds Park, located at 700 S. Railroad Ave, on July 7th, 2023, from 1pm to 11pm, and on July 8th, 2023 from 11am to 11pm.

E. New License Application – #1 Axehole LLC, dba #1 Axehole

An application was filed on April 20th, 2023, for a new **Beer and Wine License** by #1 Axehole LLC., d/b/a #1 Axehole LLC, located at 137 E 4th Street in Loveland.
