2. PUBLIC HEARING

A. Modification Application – Circle K #2740645

The licensee seeks to permanently expand and/or move the store’s existing alcohol beverage product placement areas to accommodate additional beverage displays.

D. New License – Sage Beginnings LLC. dba Sage

An application was filed on August 4th, 2023 for a new **Tavern License** by Sage Beginnings LLC, d/b/a Sage, at 428 N Cleveland Avenue. in Loveland. The neighborhood boundaries were designated as: **(NORTH – W 16th St.; SOUTH – 12th St.; EAST – N Boise Ave.; and WEST – Duffield Ave.)**. The premise was posted with a sign advertising the Public Hearing and a notice was published in the Reporter Herald as the law requires.
