A. Tobacco License – Lit Investments LLC dba Lit Tobacco

An application for a new tobacco license was filed on August 9th, 2023, by Lit Investments LLC, dba Lit Super Smoke Shop, located at 410 E. Eisenhower Blvd., in Loveland, CO. The applicant seeks to continue the licensing process which had been started in the previous years.

B. Transfer License – Fork Yeah LLC., dba Fork Yeah

An application was filed on September 20th, 2023 for the transfer of the Hotel & Restaurant License from What the Fyock Enterprises, LLC, dba The Ball Joint to Fork Yeah LLC, dba Fork Yeah, for the license located at 434 N Garfield Ave. in Loveland. A temporary transfer permit was issued on October 20, 2023 at the request of the applicants.

C. New License – The Awakened School Retreat Center LLC., dba Casa Sagrada

An application was filed on August 31st, 2023, for a new **Lodging & Entertainment License** by The Awakened School Retreat Center, LLC., d/b/a Casa Sagrada, located at 404 E. 3rd Street in Loveland. The neighborhood boundaries were designated as: **(NORTH – 16th St.; SOUTH – 12th St.; EAST – N Boise Ave.; and WEST – Duffield Ave.)**. The premise was posted with a sign advertising the Public Hearing and a notice was published in the Reporter Herald as the law requires.
